Chandrayaan-3 was launched on 14th July-2023 with Grand Success. 'Mission' is a matter of pride for the entire nation. We congratulate the ISRO team who made it happen. Shri Neeraj Mittal, IAS, (TN 92) has assumed the charge of Secretary, Department of Telecom New Delhi on 6.9.2023. We heartly welcome him.

Interaction Program with ALL India Central Govt. Pensioners Association Hq, Pune and Defence Accounts Pensioners Association Pune was held at O/O PCDA, Pune on 21st July-2023 under the presidentship of Hon'ble Secretary Shri V. Srinivas IAS, Min. Of Personnel, Public Grievances & Pension. General Secretary shared the main Activities of our Association and highlighted the issues faced by the Central Government Pensioners. Considering our achivements, Shri H. F. Chaudhari General Secretary was nominated on the committee for assessment, evaluation of new guidelines for Pensioners Welfare Associations.

In the Latest Judgement On 4th August-2023 Hon'ble Rajasthan High Court, In a case wherein the petitioners had invoked extraordinary jurisdiction of the Court under Article 226 of the Constitution to seek direction to the respondents to grant them notional increment for the services rendered by them and consequently refix their pensionary benefits, Hon'ble Justice Anoop Kumar Dhand held that the petitioners would be entitled to get notional payment on July 1, notwithstanding their superannuation on June 30, and further directed the respondents to consider the case afresh and grant notional increment to the petitioners. DOPT vide latest communication dt 5.9.2023 informed that the issue is under examination in consultation with Deptt. of Expenditure.

You may be aware about our correspondence made to the Secretary, Department of Post for provision for Off Cycle payments for DA Arrears to the pensioners, as available for Working employees. We are happy to inform that Department of Posts has issued the order that Off Cycle payments can be made now. Postal pensioners will receive DA arrears at par with working employees.

We met Shri Ankur Kumar, DAP Nagpur on 17th Agust, 2023 and discussed Status of long pending cases on account of DOP OM dated 23/5/2018, OM dated 04/11/2013 and Counting of pre 1986 Induction training period and also some individual cases. The report is printed in this bulletin.

DLC Camp and Pensioners Sanwad was conducted by CCA Maharashra & Goa at Pune on 28th August-2023 at 11 am to 2.30pm under the chairmanship of Mrs Vibha Mishra CCA. We demanded to release the retirement

benefits of BSNL retirees ST Category, in accordance with the guidelines of DOP&PW order dated 30.11.2021. The special meeting was conducted on 29.09.2023 under the Chairmanship of Ms Anuradha Joshi Durgapal, CGCA, New Delhi. She heard the views of all stakeholders and concluded the meeting saying Administration is keen to solve the issue.

In view of the unwarranted and unjustified delay in submission of Revised proposal of pension revision in respect of of BSNL/MTNL absorbed retired employees, Joint Forum conducted Agitation programme. Black Day - 06/07/2023, Dharana at CCA Office on 31/07/2023 Dharana at Jantar Mantar, on 24/08/2023 and Demonstrations at Sanchar Bhawan on 25.8.2023. Hon'ble PBCAT, New Delhi vide judgement dated 20.9.2023 ordered to revise the pension of BSNL/MTNL pensioners in accordance with relevant rules and entitlements to various sets of employees of the central government.

OM. No:1(2)/2023-P&PW(H), Dated 9August 2023 From Government of India, Ministry of Personnel, PG & Pensions Department to Pension & Pensioners' Welfare, New Delhi.

Subject : Comprehensive Guidelines for the Nation - wide Digital Life Certificate Campaign 2.0. November 1-30, 2023

The undersigned is directed to say that submission of Life certificate is an importment activity to be carried out by pensioners every year in the month of November (with special provision for pensioners aged 80 years and above to submit their life certificates in the month of october) to ensure continuity of their pension.

- 2. To enhance 'Ease of Living' of Central Government pensioners, this department engaged with UIDAI & MeitY to develop a face-Authentication technology system based on UIDAI Aadhaar database whereby it is posiible to submit life certificate from any android based smart phone. This is in addition to giving Life Certificate using a bio-mertic device on the Jeevan Pramaan App, Videp-KYC, LC through the Gramin Dak Sevaks by using the APP of India Post payments Bank and Door-step service by the consortium of Public sector Banks.
- 3. With a view to spread awareness amongst all the Central Government pensioners as wll as the pension disbursing authorities for use of DLC through face authentication technology, DoPPW launched a nation-wide campaign in 37 cities in collaboration with SBI, PNB, Pensioners' Associations, UIDAI & MeitY in the month of November 2022. This campaign resulted into use of DLC by approx. 35 Lakh out of 69.8 Lakh Central GovernmentPensioners across India.

- 4. DoPPW shall now be conducting a nation wide DLC campaign 2.0 in 100 cities of India, where there is a significant persence of central Government Pensioners, from 1st to 30th November, 2023. The objective of this campaign is to promote increased use of Face Authentication Technology and DLC modes with a target of 50 lakh central Government Pensioners across India. The SOP regarding the technique of issuing DLC through face Authentication is attached for reference.
- 5. In order to conduct this campaign, DoPPW shall obtain the support of the following stake-holders:
- Pension Disbursing Banks
- Pensioners' Associations
- Ministry of Defence, Postal & Railways (for their own pensioners)
- PIB & DD (for media support)
- UIDAI & MeitY (for technical support)
- 6. Nation wide DLC campaign 2.0 Features:
- There Shall be a common All India banner of the Nationwide DLC Campaign to be shared separately by DOPPW.
- DoPPW shall nominate its Nodal officers for each State; these Nodal officers shall tie up with the campaign Nodal officers of the different stake-holders, as given above for the respective States/UTs.
- The 100 cities have been identified and multiple locations within each city will be identified in consultation with the stakeholders.
- Camps will be organized at the identified multiple locations in each city, shorlisted for the campaign by the banks/establishements.
- Each Bank shll nominate its nodal officers for each state/UT who shall coordinate with the Bank's nodal
 officer for each city for the campaign. DoPPW shall coordinate with the state Nodal officers only.
- M/o defence, Railway, Posts & Telecom shall appoint their own Nodal Officers.
- UIDAI and MeitY shall also nominate Nodal officers for technical support for each state/UT.
- PIB & DD shall nominate its Nodal officers for publicity in each State/UT.
- Form September, 2023, onwards wide publicity is to be carried out through social media, print media, banks and registered pensioners' associations.
- The Banks/Establishments associating for the campaign in a particular state shall hold camps on designated days of November. In addition camps will also be held on other days by all Banks branches for the pensioners reaching banks.
- MeitY shall be roped in for utilizing its software to give real-time inputs on the progress of the campaign.
- A socail media group of all the Nodal officers shall be created by DOPPW for real time sharing of information during the Campaign.
- 7. A separate DLC portal with URL https://ipension.nic.in/dlcportal/ has been created wherein details of Nodal officers at state and city level shall be registered. All inputs related to the campaign such as URLs of tweets and PIB notes/ press releases are to be entered in this portal. The user manual for the DLC protal is attached for reference.
- 8. Pre Campaign preparation phase (August 1 30, 2023)
- Nomination of nodal officers by DoPPW, all Banks, Defence (SPARSH), UIDAI, MeitY, PIB and DD.
- State-wise meetings of all the stake-holders for the identified 100 cities with DoPPW officials.
- Training of Nodal officers, Bankers & Training of trainers by DoPPW/UIDAI/ MeitY on DLC through Face authentication and DLC Portal.
- 9. Campaign Period activities (1st November 30th November, 2023)
- Launch of Nationwide DLC campaign 2.0 on 1st November, 2023 under the auspice of Hon'ble Dr. Jitendra singh, MoS.

Government Orders

- DLC camps in 100 cities as per schedule from Nov 1.10.2023 when the maximum rush is expected; thereafter the Banks/Establishments shall keep the facility open.
- Visit of DoPPW nominated offcials to different locations to monitor & inspect the drive.
- Daily updation of data dentrally by MeitY of the progress of the DLC campaign in a pre-determined format
 to be intimated separately.
- Release of PIB note and tweets for each location in every city by respective nodal officers. This shall be monitored by the DoPPW official in charge of that particular state/UT.
- Mid-campaign press conference by DOPPW on 15th November 2023.
- Sharing of PIB notes, tweets links, DD coverage on campaign by the Nodal officers on the portal / social media group.
- End of campaign Press conference by DOPPW on 30th November.
- Release of Nation wide DLC campaign booklet by DOPPW.

10. Role of different stake - holders w.r.t. the Nationwide DLC 100 city campaign :

Role of Department of pension & pensioners' welfare

- Issue letters to all stake holders containing details o the campaign.
- Nomination of Nodal officers for each state/Ut.
- Co-ordination meetings with all stake-holders in different states/UTs including with the Registered Pensioners' Association.
- Creation & monitoring of the Nationwide DLC campaign 2.0 Portal for upload of details of Nodal Officers.
- Creation of a social media group comprising all the nodal officers for posting of pictures of different site locations and number of tweets.
- Provide a MIS format to MeitY for real-time updates with regard to the Campaign.
- Training of different stake-holders along with MeitY & UIDAI officials in face Authentication and DLC methods.
- Conduct an awarenes drive at the appropriate time through newspapers, television, FM radio, Social media, SMS messages, films regarding the DLC campaign.

Role of Pension Disbursing Banks

- A nodal officer, not below the rank of Chief General Manager/General Manager, to be nominated for the Nation wide DLC campaign.
- State/ UT wise sub-nodal officers, not below the rank of AGM, to be nominated for each State/ UT where bank has been identifide as lead bank.
- Shortlist multiple branches in the concerned cities for holding the campaign.
- Conduct an awareness drive of the Nationwide DLC campaign using a uniform common Banner at their locations and publicize the event through social media, SMS to pensioners and other means such as posters at Digiguts, ATMs and prominent branches.
- Dedicated staff at all branches (even though not part of DLC campaign selected cities/locations) should be equipped with an Android phone to use this technology when pensioners visit the branch for submission of DLC certificate.
- Printout of successful submission of DLC screenshot may be provided to pensioners.
- Effort may be made to encourage pensioners to download face authentication apps in their mobile so that they learn technology themselves.
- Coordinate with the designated DoPPW, UIDAI, MeitY, PIB & DD officials for the event as wll as the registered pensioners' Associations in their jurisdiction.

- Conduct a daily exercise to ensure that all DLCs submitted have been processed and confirmation SMS sent to the Pensioner.
- Inspect their software prior to the campaign for auto consumption of the DLC reaching their servers through UIDAI.
- Inspect their software for enabling LC through Video KYC method.
- Women and sick Pensioners should be given highest priority.
- Prepare an exception check-list of the pensioners in the select cities who have not given LC by November 15, 2023 and send reminder SMS.
- Prepare for providing doorstep LC facility to those pensioners who are unable to visit centers due to age/ infirmity.
- No Pensioner wanting to give a physical LC should be turned back.
- Instructions to be given to their International Banking Divisions to give a similar treatment to pensioners settled abroad and visiting their centers for giving LC.
- PIB note, Tweets and media coverage should be given to each event and DOPPW twitter handle to be tagged. Short videos of 30 seconds may be taken of pensioners above age of 90 years generating their DLC.
- Prepare a media plan of the campaign and send pictures to DoPPW on the mail ID doppw-dlc@gov.in.
- Role of Pensioners' welfare Associations
- PWAs to nominate officials to make home/hospital visits for pensioners who are unable to move to campaign locations.
- Conduct a rigorous awareness drive of the campaign among all their members as well as apprise their RWAs (Resident Welfare Associations) regarding the campaign and the Face Authentication methodology for giving LC.
- Coordinate with the local Bank/Defence (SPARSH)/PIB officials for conducting a seamless DLC Nationwide campaign.
- Report to the concerned DoPPW official of the State about any local issues being faced by the Pensioners in giving LC.
- Prepare a media plan of the campaign and send pictures to DoPPW on the mail ID doppw-dlc@gov.in
- Role of Ministry of Defence (SPARSH)
- A Nodal officer may be nominated, not below the rank of Dir/DS/Dy.CGDA for coordination at central level. Sub-Nodal officers to be nominated for each state/ UT/Command, not below the rank of Dy.CDA, where the camp is being held for SPARSh pensioners and details of the nodal officers to be uploaded on the portal.
- Wide publicity should be given to this campaign by spreading awareness through banners, social media, SMS and sainik welfare Boards.

OM No:X-06/9/2023-SPN-II-DOP, Dated: 6 August 2023 From Government of India, Ministry of Communications, Department of Posts, New Delhi, addressed to Chief Post Master Generals.

Subject: Regarding Coverage under central civil services (Pension) Rules, in place of National Pension System, of those central Government employees who were recruited against the post/ vacancies advertised/notified for recruitment, on or before 22.12.2003.

In pursuance of Department of pension and pensioner welfare/s (DoP & PW) Om no 57/05/2021-P& PW (B) dated 3.3.2023, various postal circles have forwarded option exercised by the officials recruited through combined graduate level examination, 2004 conducted by staff selection commission for taking necessary action at directorate level as the cadre of IP/ASP being managed centrally by the Directorate.

P. P. Bulletin 7 Oct. - Dec. 2023

- 2. Advertisement for the preliminary examination of combined graduate level examination, 2004 conducted by staff selection commission was published in employment news dated 18.10.2003. Hence, all the IP cadre officials recruited through SSC CGLE, 2004 shall be eligible for coverage under CCS (Pension) Rules, 1972 (now 2021) as advertisement for the said examination was published prior to the date of notification for national pension system i.e. 22.12.2023.
- 3. Further, para 7 of ibid OM dated 3.3.2023 provides that the matter of coverage under the CCS (Pension Rules, 1972 (now 2021) based on the option exercised by the government servant, shall be submitted befor appointing authority of the posts.
- 4. The cadres of Inspector Posts (IP) and assistant superintendent of posts (ASP) are now managed centrally by the directorate. Although, it has been decided that member (P) would be appointing authority for ASP cadre, relevant notification is yet to be issued.
 - 5. Accordingly, following has been decided:
- a. Option exercised by the officials working in Directorate against sanctioned posts, but excluding those working in directorate on attachment basis, shall be processed at the directorate level; and
- b. Options exercised by the officials working in postal circles shall be processed by the postal circles and final decision will be taken with the approval of CPMG.

Circular

This is regarding submission of application for family pension/second stage family pension by spouse/co-authorized family member for commencement of family pension/second stage family pendion on death of a pensioner or family pensioner. In order to avoid various issues faced by the family pensioners the following instructions are to be followed regarding submission of application forms and relaed documents.

I. Submission of application by spouse or a permanently disabled child or children or dependent partents or disabled siblings, who names have been included in the pension payment order.

In the case of death of a pensioner, if the deceased pensioner is survived by a window or widower who is eligible for the grant of family pension or a permanently disabled child or children or dependent parents or disabled siblings, whose names have been included in the pension payment order as family pensioner may submit claim in Form 12 (As per CCS (Pesion), Rules, 20021) along with the following documents to CCA office.

List of Documents to be submitted with form 12

1. Two speciment signatures of claimant (to be furnished in a separate sheet)

(Two slips each bearing the left hand thumb and finger impressions may be furnished by a person who is not literate to sign his name. If claimant is unable to give left hand thumb and finger impressions on account of physical disability, he/she may give thumb and finger impressions of the right hand. Where a government servant has lost both the hands, he/she may give tow impressions.)

- 2. Two copies of passport size photographs of the claimant.
- 3. Undertaking for refunding any excess payment made by the pension disbursing Bank.
- 4. Speciment signature of left hand thumb and finger impressions of guardian, in the case of the guardian who is not literate enough to sign his or her name.
- 5. Two self attested copies of passport size photograph of the guardian/nominee
- 6. Descriptive roll of the guardian/nominee, wherever applicable, showing the particulars of height and identification marks, self-attested.

- 7. Copy of PPO of pensioner/previous family pensioner (To be provided, if available)
- 8. Proof of permanent address of the guardian.
- 9. Copy of death certifiacate of the deceased pensioner/previous family pensioner
- II) Submission of application for family pension eligible family members as per Rule 50 after the death of pensioner of family pensioner (second stage family pension)

Where the pension payment order does not include name of any member of the family for payment of family pension or where the head of office is of the opinion that in accordance with the provisons of rule 50, on death of a pensioner of family pensioner, the family pension in respect of a deceased pensioner or deceased family pensioner has become payable to a member of the family other than that whose name has been included in the pension payment order, head of the office may obtain claim in form 10 (As per CCS (Pension) Rules, 2021), and forward to CCA officers along with format - 13 (As per CCS(Pension) Rules, 2021)

The application for second stage family pension may be submitted by the eligible family members in form 10 (As per CCS (Pendsion) Rule, 2021) to the head of the office (office where the employee retired) along with the following enclosures.

- Two speciment signatures (to be furnished in a separate sheet). If the claimant cannot sign his/her name then he/she is required to put the impression of his/her left/ringt thumb etc. on the document in liey of sepcimen signature.
- 2. Proof of identity.
- 3. Proof of relationship with the deceased/ missing government servant/pensioner.
- 4. Two copies of self attested passport size photographs of the claimant.
- 5. Details of family in form 4 (As per CCS (pension) Rule, 2021.
- 6. Undertaking for fefunding any excess payment made by the pension disbursing bank in format 9.
- Certificates of age showing the dates of birth of the children. The certificates should be from the municipal
 authorities or from the local panchayat or from the head of a recognized school or central state board of
 education.
- 8. Two specimen signatures of guardian (to be furnished in a separate sheet if the claimant is minor or suffering from mental disability.)
- 9. If the guardian cannot sign his/her name then he/she is required to put the impression of his/her left/ right thumb etc. on the document in lieu of speciment signature.
- 10. A copy of photo ID proof of the guardian along with proof of perment address.
- 11. Two self attested copies of passport size photograph of the gurdian/nominee.
- 12. Copy of pension payment ofder of previous pensioner/family pensioner.
- 13. Copy of death certificate of government servant/ pensioner/previous family pensioner, if applicable.
- 14. Copy of document regarding ineligibility of previous family pensioner, if applicable.
- 15. Copy of report lodged with police in respect of missing government servant or pensioner of previous family pensioner. (In case of missing pensioner/family pensioer only.)
- 16. Copy of the report from the police that the government servant could not be traced so far despite all efforts made (in case of missing pensioner/family pensioner only.)
- 17. Indemnity bond in format 8 (In case of missing pensioner/family pensioner only.)
- 18. Last income tax return failing which certificate from SDM failing which any other document regarding income in support of the claim for family pension (Not applicable in the case of spouse.)
- 19. Copy of the first page of the pass book showing name and account number in which the family pension is to be credited. (Name of the claimant in the form and in the bank accounts should be the same.)
- 20. If the claimant is a widowed/ divorced daughter or a disabled child / sibiling, document in support of the eligibility of the claimant (i.e. death certificate of husband in the case of widowed daughter / divorce decree in the case of divorced daughter/ disability certificate in the case of a disabled child.)
- 21. Form 8, if a family member is proposed to be co-authorised for family pension.

22. Verification report from the head of the office.

On receipt of form 10 and documents from the claimant, head of the office may verify the eligibility of the claimant and if eligible the same may be forward to CCA officers along with format - 13 for authorization of family pension.

- a) & b): Dearness Allowance (DA) and Dearness Relief (DR) is paid to central Government employees and pensioners to compensate them for erosion in the real value of their pay and pension on account of inflation. These rates were increased to 42% of the pay and pension in January 2023. The rates of DA/DR are revised periodically at every six months on the basis of All India consumer Price index for industrial workers (AICPI-IW).
 - c) & d) No such proposal is under consideration of the government.

- 3. The contents of Para 2 above shall be added to the definition of the term 'Family' for CGHS benefits.

With reference to the above subject the undersigned is directed to convey the approval of the competent authority to issue guidelines for the approval of anti cancer medicines to CGHS beneficiaries as per the details given below.

With reference to the above subject the undersigned is directed to convey the approval of commitment authority to issue revised guidelines for the approval of anti-cancer medicines to CGHS beneficiaries as per the details given below.

- I. In respect of non, imported of line anti-cancer medicines advised by specialist of government hospital, empanelled hospital, approval shall be granted as per the details given as under.
- a. If the cost of medicine is less than 1,00,000/- for one chemotherapy cycle. It shall be approved by the Addl. director, CGHS without the requirement of examination by STC. For a maximum 3 cycle meanwhile STC examination may be carried out.
- b. If the cost of medicine in between Rs. 1,00,000/- to Rs. 1,50,000/- for one chemotherapy cycle. It shall be approved by the Director, CGHS without the requirement of examination by STC. For a maximum 3 cycle meanwhile an STC examination may be carried out.
- c. In case of medicine is more than Rs. 1,50,000/- for one chemotherapy cycle. The cases shall be placed before the STC of experts for justification, before seeking the approval of the competent authority.
- d. Once a particular drug for chemotherapy for an individual beneficiary has been approved on the recommendation of STC. No for the STC approval shall be needed for further continuation of treatment provided the same treatment is continued.
 - II. In respect of imported anti-cancer medicine, the existing guideline would continue as follow.

The medicine which has been advised by government, specialist/ specialist of empanelled hospital shall be placed before the STC of experts and if the medicine is justified approval of competent authority and concurrence of IFD shall be solicited. After the approval of the competent authority, an indent for such medicines shall be placed with the embassy, high commission of the concerned authority for procurement.

The undersigned is directed to refer to this Office Memorandum No. 4-12(12)/2018-PATPart (1) dated 01.07.2019 on above subject vide which the revised mapping of IDA and CDA pay scales was issued for deciding the rate of monthly CGHS contribution and entitlement of wards in private hospitals empanelled under CGHS in respect of retired BSNL/MTNL employees who receive pension from Central Civil Estimates and avail CGHS facilities.

- 2. The entitlement of wards in Private Hospitals empanelled under CGHS has been revised w.e.f. 28.10.2022 by Ministry of Health & Family Welfare vide its O.M. No. S.11011/11/2016-CGHS(P)/EHS dated 28.10.2022. This has necessitated corresponding modification in Annexure-B of the said O.M. dated 01.07.2019.
- 3. Accordingly, Annexures to the said O.M. dated 01.07.2019 stands modified w.e.f. 28.10.2022, as enclosed.
- 4. This O.M. and mapping is applicable only for the Combined Service Optees who retired from BSNL/MTNL with IDA pay scale.
- 5. This O.M. and mapping is not applicable for pro-rata pensioners who retired from DoT under CDA pay scale. Also, as per guidelines issued from Directorate of CGHS, MoH&FW, ward entitlement is based on the last basic pay and CGHS subscription is based on the pay scale as mentioned in the Pension Payment Order (PPO) of a particular retiree. Accordingly, ward entitlement and CGHS subscription in case of prorata pensioners of BSNL/MTNL will continue to be decided based on last pay drawn in DoT before absorption, as mentioned in their respective PPO while retiring from DoT, Govt. of India as already conveyed vide this office O.M. No. 4-12(12)/2018-PAT dated 08.09.2021.
 - Hence, no mapping of IDA/CDA scale is required in case of pro-rata pensioners.

Sub: Request for comments on taxability of one-time CGHS payment/ contribution paid to BSNL absorbed pensioners by BSNL

The undersigned is directed to forward herewith the letter no. SNPWA/CHQ/Deputy Commissioner/1/23 dated 26.06.2023 received from Sanchar Nigam Pensioners' Welfare Association i.e. BSNL Retired Pensioner Association, addressed to your kind office with a copy to this office on the above cited subject.

- i). Brief of the Issue i.e. reimbursement of one-time CGHS payment made to BSNL absorbed pensioner by BSNL:- In BSNL, absorbed pensioner of BSNL who are in receipt of Central Civil Pension are eligible to choose either Central Government Health Scheme (CGHS) or BSNLMRS post-retirement as per their convenience. Those retired employees opting for the Central Government Health Scheme (CGHS) are required to fill the prescribed form, deposit the onetime payment of Rs.1,20,000/- and then claim reimbursement of the onetime from BSNL by submitting the index card and proof of surrendering the BSNL MRS. In respect of those retired employees who opt for CGHS Scheme, BSNL will be redeemed from the expense towards medical claims of the pensioner and his family. Presently, BSNL is treating such reimbursement of one-time CGHS payment to BSNL absorbed pensioner as a perquisite under section 17(2) of the Income-tax Act, 1961 ('the Act') and is deducting TDS from the reimbursed amount.
- ii). BSNL Unions/Associations have objected the tax position adopted by BSNL as per their letter attached (Annexure attached):-

BSNL Unions/Association has cited reasons in their letter (copy enclosed) for non-deduction of TDS on refund of Central Government Health Scheme subscription fees to retired BSNL employees. Some of the reasons cited for non-deduction are as follows:-

a) Proviso to Section 17 states that, provided that nothing in this clause shall apply to :-

Any portion of the premium paid by an employer in relation to an employee to effect or to keep in force an insurance on the health of such employee under ay scheme approved by the Central Government or the insurance Regulatory and Development Authority established under sub-section(1) of Section 3 of the Insurance Regulatory and Development Authority Act, 1999 for the purpose of clause (ib) of sub-section (1) of Section 36.

Any sum paid by the employer in respect of any premium paid by the employer to effect or to keep in force an insurance on his health or the health of any member of his family wider any scheme approved by the Central Government or the Insurance Regulatory and Development Authority established under sub-section (1) of Section 3 of the Insurance Regulatory and Development Authority Act, 1999 (41 of 1999), for the purpose of Section 80D.

b) Furthermore, Section 80D, referred to in Section 17(2)(viii)(iv) of the Income Tax Act, 1961 explicitly states as follows:-

Deduction in respect of health insurance premia

(2) Where the assessee is an individual, the sum referred to in sub-section (1) shall be the aggregate of the following, namely:-

The whole of the amount paid to effect or to keep in force an insurance on the health of the assessee or his family or any contribution made to the Central Government Health Scheme or such other scheme as may be notified by the Central Government such other scheme as may be notified by the Central Government in this behalf or any payment made on account of preventive health check-up of the assessee or his family as does not exceed in the aggregate twenty-five thousand rupees, and

Moreover, Section 80D(4A) allows proportionate deduction (appropriate fraction) in case of lump sum payment.

c) In comparable circumstances, the Hon'ble High Court of Delhi in Yushio Kubo and Ors. Vs. Commissioner of Income Tax [2013:DHC: 3744-DB], held as follows:

P. P. Bulletin 17 Oct. - Dec. 2023

"37. In CIT vs. Lala Shri Dhar (1972) 84 NR 192 (Del) this court was concerned with contributions made by the employers under policies of personal accident taken out by them for protecting themselves against the liability for payment of compensation to their employees. It was held by the Court that the decision to take the policy was of the company, which paid the premium, that the assessee himself did not want to take out the insurance. If the company bad stopped paying the premium, the assessee would not have continued the same from year-to-year and therefore, the contribution paid by the company to keep the policy alive could not be considered as a perguisite in the hands of the employee."

- iii). In view of the above, it is requested to kindly arrange to clarify the following:-
- a) Is the CGHS subscription fee refunded by BSNL to its retired employees to be treated as a taxable income?
 - b) Is BSNL liable to deduct TDS on refund of the onetime CGHS subscription fees to its retired employee? Thanking you, Yours faithfully,

MAMMOTH AND STUPENDOUS DHARNA AT JANTAR MANTAR ON 24TH AUGUST, 2023 BY THE JOINT FORUM OF BSNL MTNL PENSIONERS ASSOCIATIONS.

The third phase of the agitational programme, against the apathy of the government and bureaucracy in the most burning issue of pension revision was the 5 days Dharna from 21 - 25 August 2023. But the Delhi Police gave permission for only one day on 24th August, 2023, that also from 10am to 1pm. only.

The pensioners that came from all parts of the country exhibited their anger and anguish against the unjustifiable stalemate on the issue of pension revision after completing almost all the formalities. They raised slogans against the continuing injustice on their legitimate demand and affirmed the determination and commitment to fight it out until achieved.

Veteran leader and Advisor of AIBDPA, Com. V A N Namboodiri presided. Com. K G Jayaraj, General Secretary, AIBDPA and Convener, Joint Forum welcomed all and explained the demand. Com. Shiva Gopal Mishra, General Secretary, AIRF, Secretary, N JCM (Staff Side) and President, NCCPA inaugurated the Dharna. He came down heavily on the anti worker, anti pensioner policies of the government and assured all the support in achieving the genuine demand of pension revision of BSNL and MTNL absorbed retirees. Coms. Thomas John & D D Mistry, BDPA(I), G L Jogi, GS, SNPWA, H F Chaudhari, GS, AICGPA HQ Pune, V K Thomar, Secretary General NCO and Chairman, Joint Forum of MTNL Associations and Unions, R K Mudgal, General Secretary, MREWA spoke criticising the negative stand of the government.

POWERFUL DEMONSTRATION HELD AT SANCHAR BHAWAN on 25 th August 2023.

In view of the denial of permission to continue the Dharna on 25th August, 2023, Joint Forum has planned to hold Protest Demonstration before Sanchar Bhawan at 11.30am. Plenty of Police were deployed to prevent the demonstration and some of our comrades, who reached earlier, were removed in the police vehicle to Jantar Mantar. The leaders reached at the spot at 11.30am had a tough time to deal with the police. But they started shouting slogans and all the comrades joined together and staged a powerful demonstration resisting the police to remove them to the police vehicle. Then the police informed that Joint Forum can continue the Dharna at Jantar Mantar. Thereafter hundreds of pensioners moved to Jantar Mantar in a procession.

Coms. V A N Namboodiri, K G Jayaraj, G L Jogi, H F Chaudhari, M K Mudgal, D D Mistri and M R Das addressed hundreds of Comrades who came from almost all parts of the country with great commitment and determination to fight for the genuine cause. All the speakers delivered spirited and encouraging speeches and declared that Joint Forum will continue the fight until pension revision is achieved.

Thereafter the police took the leaders in a vehicle to Sanchar Bhawan and the Joint Secretary received the memorandum from the leaders.

Judgment on Pension Revision of BSNL/MTNL Pensioners

CENTRAL ADMINISTRATIVE TRIBUNAL, PRINCIPAL BENCH, NEW DELHI, O.A. No. 1272/2020, M.A. No. 1581/2020, M.A. No. 76/2020, M.A. No. 1582/2020 With

Important Paras

- 6. Learned counsel clarifies that the terms and conditions which were to remain in operation in the case of the applicants included pensionary benefits; he draws attention to the documents annexed to the O.A. to substantiate this claim. He further informs that pursuant to the recommendations of the various Central Pay Commissions (CPCs) necessary benefits as recommended by the CPCs and accepted by the Government have been extended in favour of the applicants except for revision of pensionary benefits pursuant to Pay Commission recommendations. Aggrieved by the same, they seek the following relief(s) by way of the present O.A.:-
- (a) Pass an Order directing the Department of Telecommunications to revise the pension/family pension/minimum pension w.e.f. 01.01.2017 for the BSNL combined service Pensioners, who were absorbed from DOT/DTS/DTO we.f. 01.10.2000 and retired prior to 01.01.2017 by applying the fitment formula on IDA pension as on 01.01.2017;
- (b) Pass an Order directing the Department of Telecommunications to revise the pension/family pension/minimum pension w.e.f. 01.01.2017 for the BSNL combined service Pensioners, who were absorbed from DOT/DTS/DTO w.e.f. 01.10.2000 analogous to the revision of pension/family pension/minimum pension for the Central Government Pensioners based on the recommendations of the 7th Central Pay Commission;
- (c) Pass an Order directing the Department of Telecommunications to revise the pension for BSNL combined service pensioners parallel to the revision of pension of the Central government servants without linking with Pay revision in BSNL:
- (d) Pass such other further order (s) as this Hon'ble Tribunal may deem fit and proper in the facts and circumstances of the present case and in the interest of justice."
- 21. We have gone through the voluminous pleadings on record and also heard the detailed arguments put forth by the learned counsel on more than a couple of occasions.
- 22. The facts of the case are not disputed, nor is questioned any documents relied upon by the respective parties. There is no ambiguity that at the time of their placement and absorption in BSNL and MTNL, it was categorically stated that the erstwhile employees of the Department of Telecommunication shall continue to be governed by their existing terms and conditions of the service which means that they shall continue to be treated as government servants for all intents and purposes. It is also not in dispute that from time to time, the recommendations of the Central Pay Commission, as accepted and notified by the government, were made applicable in their case too. There is no ambiguity with respect to the general terms and conditions governing absorption, as circulated and quoted in para 5 of this order, stating categorically that provisions of Rule 37 (A) of the CCS (Pension) Rules, shall guide payment of pension to these employees.
- 23. Section 37 (A) of the CCS (Pension) Rules has to be read in totality and sub para 21 of the same further clarifies that pensionary benefits of these employees, including family pension shall be paid by the government.

In fact, several communications and memoranda, extracts of which have been quoted in this judgment, lead only to one inference that a very well-considered conscious decision was taken and expressly stated that the terms and conditions of the service of employees of Department of Telecommunications shall remain protected even on their absorption in BSNL/MTNL and further, it has been emphasized that these terms and conditions are inclusive of pension and family pension.

24. The relevant rules as quoted above have further clarified that since BSNL and MTNL are corporate entities, the liability of pension and family pension shall be borne by the government. We do appreciate the

arguments put forth by the learned counsel for the respondents, especially the fact that once the applicants have ceased to be government employees, they should not and cannot expect the benefits available to government employees in perpetuity. Further, we also appreciate that there may have been specific facts and circumstances at the relevant time of their absorption when the decision to protect their terms and conditions was taken. However, no document has been shown to us which would substantiate these arguments that protection was to be available for a specific period only.

- 25. Learned counsels have submitted that the applicants have now ceased to be governed by the CCS (Pension) Rules and in case they are allowed to agitate their claim at this juncture, it would open up the Pandora box and thus, strike at the very roots of the governance of corporate entities.
- 26. We are not inclined to consider the extended arguments on behalf of the respondents even though we acknowledge some merit in these. The decision qua these employees, as further reflected under innumerable communications, is unambiguous and has been, so far, implemented also. We reiterate that even on their absorption in the corporate undertaking, the terms and conditions of services governing them were to remain the same as they existed when they are employees of the Department of Telecommunications. Further, these terms and conditions include pension and family pension and this has been expressly stated in the rules and several subsequent communications which have been elaborately quoted in some of the preceding paragraphs of this order.
- 27. We have no hesitation in concluding that the present application deserves positive consideration. The government had given a promise and stated it in black and white. How could it now retract from the promise, that too not by any law or rules but by simply a refusal to honour it?
- 28. In view of the elaborate discussion above, the OA stands allowed. The competent authority amongst the respondents is directed to forthwith revise the pension and family pension wherever applicable, strictly in accordance with the relevant rules and the entitlement governing pension to various sets of employees of the Central Government, maintaining strict parity. It is clarified that the benefits of revision of pension and family pension as notified by the Central Government on the recommendations of the Pay Commission, shall stand extended in favour of the applicants, analogous to the revision of such pension in case of Central Government pensioners.
- 29. The directions contained herein shall be complied with within a period of ten weeks from the date of receipt of a certified copy of this order.
- 30. The OA stand allowed against the background of the aforesaid directions. Pending MA(s), if any, stands disposed of accordingly. There shall be no orders as to costs.

DLC Camp and Pensioners Sawand was conducted by CCA Maharashra & Goa at Conference Hall, O/O PGM, Sanchar Bhawan, Satara Road, Pune on 28th August-2023 at 11 am to 2.30pm under the chairmanship of Mrs Vibha Mishra CCA. Shri Shashank Bhardwaj Jt. CCA, Shri Prasanth O. S., Accounts Officer (Pension) were present.

SarvaShri H. F. Chaudhari General Secretary, K. S. Kulkarni AGS, Ramesh Pillai, Org. Scretary, D. L. Sadavarte Secretary, Pune Branch and Shri Vinayak Date represented our Association in the meeting.

We raised the following issues.

1. Burning issue of Withholding the Retirement benefits to BSNL retirees ST Category. We strongly demanded that In accordance with the guidelines of DOP&PW order dated 30.11.2021 and DOT directives vide order dated 22nd Matrch, 2022 to take necessary action as per DOP&PW letter dated 30.11.2021, the retirement benefits may be released in respect of all 216 cases pending. CCA clarified that out of 212 cases pending report is received in respect of 33 cases only. In respect of 33 cases VC is clear as on date, 76 cases with Status 'Withheld'. It is serious that no provisional pension is paid to 8 tretirees.

We stated that the status at the time of retirement should only be considered as the disciplinary action is initiated for no submission of validity certificate only, CCA mentioned that the charge sheet is issued for disobedience.

The meeting is concluded that Joint Forum will submit the memorandum justifying the release of retirement benefits with reference to today's meeting, which will be considered by CCA, Maharashtra & Goa.

- 2. We raised the issue of abnormal delay in issuing Pensioners Identity Cards. BSNL/DOT pensioners applied for Identity Card from June, 2022 onwards but they did not receive the same as yet. It was informed by Jt. CCA that the tender is approved and Identity cards will be issued from September, 2023.
 - 3. Issues faced by migrated Pensioners.

We brought into notice some of the complaints received from the pensioners migrated to SAMPANN. It is necessary to check the following discrepancies

- i)Date of Restoration of Commuted pension: Restoration is not done automatically. Secondly after restoration of commuted pension, the arrears has not been paid. Case of Shri R. B. Jadhav
 - ii) the details of Joint Account in Banks/Post Office
- iii)DA is calculated on the original Pension only ignoring additional quantum of pension on attaining the age of 80/85/90/95 years.

Joint CCA mentioned that these points are well taken and requested to address the specific cases to check the provisions in SAMPANN and find solutions.

- iv) Good number of pensioners are complaining that they did not receive the Message. This may be due to their Mobile No. is not available in record migrated. **Account Officer replied that Form is introduced for updation of Mobile and Email id.**
- 4. Processing of Family pension cases. Before the migration the Family pensioner(Claimant) used to submit the Simple Application along with death Certificate and Family pension was paid in the next month. Now On Migration to SAMPANN there is delay in sanction of Family pension.

Accounts Officer mentioned that the instructions regarding Submission of Application for Family pension/ Second stage Family pension are posted on the webside. Application forms may be submitted accordingly.

1. Details shown in SMS on Credit of Monthly pension.

The details shown in the current SMS do not give the details are not placed in order resulting confusion. We here by suggest the order of details for easy understanding...

Life Certificate:.

Before migration to SAMPANN the pensioners used to submit Manual/Digital Life Certificate in the Bank-Branch/Post Office, where from they were distributed monthly pension. They were also aware that they are required to submit Life Certificate in the month of November every year.

On migration to SAMPANN, the pensioners are required to submit Life Certificte to the Office of CCA Office available at State Headquarter/Zonal Office. No doubt they can submit the Digital Life Certicate from Home/nearest Cyber Café or arrangement made by the Pensioners Association.

Majority of the pensioners are belonging to Group C, D Category and Family pensioners spread over in rural area also. They are not conversant to English and handy with Android Mobile.

Moreover DOT has staggered the due date for submission of life Certificates depending on first payment received from DOT .

In view of the above, Pensioners/Family pensioners are facing difficulties to submit the Digital Life Certificate on due date resulting stoppage of pension.

It is suggested that Outreach Program may be arranged at District level explaining the facilities available in SAMPANN and Submission of Digital Life Certificate. A broucher explaining the procedure may also be distributed. We will be with you in this program.

Hope the Outreach Programme will be useful in clearing the doubts and making the SAMPANN successful. With Regards,

Subject: Acceptance of Applications for CGHS from BSNL pensioners at Nashik

We wish to bring into your notice the complaint from BSNL pensioners at nashik that the applications for CGHS attached with the Pension slip, uploaded by CCA, Maharashtra, are not accepted as proof of non drawal of Medical allowance and asking them to produce separate certificate from CCA, Maharashtra & Goa which is located at Mumbai.

The BSNL pensioners are entitled to receive the medical reimbursement under BSNLMRS ie. with voucher or wothout voucher medical allowance. If they opt for CGHS, they have to surrender BSNLMRS card to BSNL office, who issues the surrender certificate. On surrender of BSNLMRS card they don't get indoor (IPD) as well as outdoor (OPD) medical bills or medical allowance. As per procedure they are submitting the surrender certificate issued by BSNL office along with the application for CGHS.

Secondly department of telecom has implemented compressive pension management system (SAMPANN) for telecom pensioners (ie. DOT as well as BSNL.) On implementation of SAMPANN, the monthly pension is processed by CCA Maharashtra & Goa, Mumbai and credited to pension account maintained in Bank/post office. Due to this change in the processing of Monthly pension processed by CCA are transferred to through NEFT to Bank/post office, As such Bank/post office do not have the details of pension, medical allowance etc. Therfore BSNL/post office are not issuing the certificate showing the details of pension, medical allowance etc. which is required to be attached with application for CGHS.

CCA Maharashtra & Goa on the disbursement of monthly pension, commuted pension, medical allowance etc. in the SAMPANN -pension slip. Pensioner can download the pension slip form SAMPANN and produce whenever required. CGHS authority can verify from the pension slip, whether the pensioner is getting medical allowance or not.

Sir, In view of the above, we hereby request you to cinsider and direct the CGHS staff at Nashik to accept the application for CGHS attached with pension slip as a proof in place of certificate from Bank/post office.

A reply in line is solicited.

लाईफ सर्टिफिकेट देताना पेन्शनधारकांना येणाऱ्या कोणत्याही स्थानिक समस्यांबद्दल राज्यातील संबंधित नोडल अधिकाऱ्याला कळिवणे. मोहिमेच्या प्रसिद्धीसाठी आराखडा तयार करणे आणि मोहिमेअंतर्गत झालेल्या कॅम्पची तसेच घरी किंवा हॉस्पिटलला भेट देऊन काढलेल्या लाईफ सर्टिफिकेट ची क्षणचित्रे doppw@dlcgov.in या ईमेलवर पाठविणे.

मायग्रेशन ऑफ टेलिकॉम पेन्शनर्स अकाउंटस टू सी.सी.ए.

आपणा सर्वांना आतापर्यंत माहिती झाले असेल, की आता आपली दरमहाची पेन्शन, बँक काढत नसून ती सी.सी.ए. मुंबई काढत आहे. अशाप्रकारे अकाउंटस मायग्रेट करण्याचे काम टप्प्याटप्प्याने पूर्ण होत आले आहे. बाकी काम लवकरच पूर्ण होईल. या मायग्रेशनच्या प्रक्रियेमध्ये बहुतेक पेन्शनरांचे काम सुरळीतपणे पार पडले आहे. पण काहींच्या बाबतीत अडचणी आहेत व मार्गदर्शनासाठी कोणाकडे जावे, हेच त्यांना कळत नाही. याबाबतीत आपल्या जनरल सेक्रेटरीने अहोरात्र मेहनत करुन अशा अवघड केसेस मार्गी लावल्या आहेत.

आपल्या पेन्शनबाबतच्या सूचना, सीसीए, त्यांचेकडे नोंदवलेल्या मोबाईल नंबरवर देत असते. या सूचना मराठीत असाव्यात यासाठी आम्ही सीसीएकडे विनंती केली आहे. तरी सर्व टेलिकॉम पेन्शनरांना विनंती की, त्यांचे जवळचा मोबाईल स्मार्ट मोबाईल असावा. त्यावर आलेला संदेश समजून घ्यावा व त्यानुसार वर्तन करावे. सर्वात महत्त्वाची गोष्ट म्हणजे, सीसीए ने दिलेल्या त्यांच्या संदेशानुसार लाइफ सर्टिफिकेट, हयातीचा दाखला देणे आवश्यक आहे. तसा न दिला गेल्यास नंतर पळापळ होते. आता लाईफ सर्टिफिकेट डिजिटल स्वरुपात द्यावे लागते. त्याबद्दल प्रोसिजर, एखाद्या जाणकार माणसाला सहज समजेल अशा स्वरुपात या बुलेटिनमध्ये छापले आहे. कोणतीही नवीन योजना अंगिकारताना, सुरुवातीचे काही दिवस अडचणींना तोंड द्यावे लागते, पण एकदा सर्व सेट झाले की काम सुकर होते.

मायग्रेशन झाल्यावर पेन्शनरांची दर महिन्याची बिले, बँकेच्या ऐवजी यापुढे सीसीए (कंट्रोलर ऑफ कम्युनिकेशन अकाउंटस्) तयार करणार. तथापि त्याची पेन्शन मात्र पूर्वीप्रमाणे त्यांनी निवड केलेल्या बँकेतून/पोस्ट ऑफिसच्या खात्याने जमा होणार आहे. गेले वर्षभर किंवा त्यापेक्षा अधिक कालावधीपासून, या विषयाची चर्चा, सर्व शाखांमधून, सर्व पेन्शनर्स करीत आहे. बुलेटिनमध्ये सुद्धा त्याविषयक खूप लिखाण छापून येते.

ही मायग्रेशनची व्यवस्था फक्त डिफेन्स डिपार्टमधील तसेच टेलिफोन (बीएसएनएल धरुन) खात्यातील पेन्शनरासाठी लागू करण्यात आली आहे.

पोस्टस्, रेल्वे त्याचप्रमाणे केंद्र सरकारची इतर खाती (उदा. इन्कम टॅक्स, सेंट्रल एक्साइज, हवामान खाते) यामधून निवृत्त झालेल्या इतर पेन्शनरांना ही पद्धत लागू नाही. तरी अशा खात्यातून निवृत्त झालेल्या पेन्शनरांनी, त्याबाबत काळजी करु नये.

एसएमएसद्वारे १५ आकडी पीपीओ क्रमांक व संपन्न प्रणालीचा वापर करण्यासाठी युजर आय डी क्रिएट करण्यास सूचिवले जाते. यापुढे सीसीए कार्यालयाशी संपर्क करतांना ह्याच पीपीओ क्रमांकाचा उल्लेख करणे गरजेचे आहे. म्हणून मायग्रेशन झाल्याचा महिना व १५ आकडी पीपीओ क्रमांक ची नोंद करून करून ठेवावी.

अशाप्रकारचा एसएमएस काही कारणामुळे आला नसेल व मायग्रेशन झाले असेल तर.. आपला १५ आकडी पीपीओ क्रमांक dotpension.gov.in या वेबसाईट साईट वर शोधता येतो.

त्यासाठी वरील वेबसाईट वर जाऊन 'Know Your PPO No' वर क्लिक करावे.
