Dear Brothers & Sisters,

The issue of revision of pension of Pre-2016 pensioners was discussed in the SCOVA meeting also, it was decided to complete the work of revision of pension/family pension by 31st May, 2018 by all departments except Defence and by 30th June, 2018 by Defence. DAP Nagpur finally agreed that there was a delay in dispatch of the revised PPOs. As per the discussion with DAP Nagpur on 26.06.2018, 32600 PPOs have been finalized and 10 Officials are engaged for dispatch of PPOs. As per feedback from secretaries, good number of pensioners received revised PPOs in May & June, 2018. In reply to our letters sent to DAP Nagpur on 19th March, 12th April & 24th April, 2018 for abnormal delay in revision of pension of Postal Pensioners, we have received a communication from DAP Nagpur for settlement of all 55 cases which were referred by us. In Karnataka Circle 13000 cases have been finalized out of total 15600 cases due for revision.

Postal Directorate vide Memo No. 2-1/2007-PCC dated 23.05.2018 issued the orders to grant notional monetory benefit to the Postmen/Mail Guards w.e.f 01.01.1996 to 10.10.1997 in the revised pay scale of Rs. 3050-4590/-. The Postmen/Mail Guards who were on duty from 01.01.1996 to 10.10.1997 will get the pay fixation benefit and consequential increase in the quantum of pension.

As per the guidelines received from Department of Pension & Pensioners Welfare, Vide letter dated 11th may, 2018, We observed the Swachh Bharat Pakhwada during May 16- 31, 2018. We sensitized members at Pune at AGM on 16th May, and Branch Secretaries through post on Whatsapp. I am thankful to the Secretaries/members from Pune, Kolhapur, Dombivli, Akola, Beed and Wardha for active participation in Swachhata Abhiyan at the Post offices, Public garden, Schools Campus etc.

As informed earlier (Bulletin-April, 2018), CCA has started the collection of information from all DOT/BSNL pensioners for the purpose of CCA taking over the function of Pension Disbursing Authority ie. crediting the pension Account maintained in Post office / Bank directly. Branch Secretary are already requested to call meeting of DOT/BSNL pensioners to fill the required application (printed in this Bulletin) and submit to concerned CCA office (Mumbai, Nagpur or Aurangabad) under intimation to HQ.

Regional CCA Office at the Aurangabad has started working from 18.05.2018 to deal with the cases of DOT/BSNL pensioners from Marathawada Region, Jalgaon and Dhule SSAs.

BSNL Corporate Office, vide its No. BSNL/Admn.I/15-22/14 dated 25.04.2018, has finally issued Orders for release of last two quarterly installments of Medical allowance payable to the optees (retired employees) for the year 2017-18. In reply to our letter addressed to CGM Maharashtra circle dated 07.05.2018, CGM Maharashtra Circle informed that they have released the payment of Medical allowance for 3 quarters and payment of 4th quarter is pending.

BSNL Corporate office vide F. No. BSNL/38-1/SR/2016 dated 28.06.2018 Constituted a Joint Wage Revision Committee comprising of Ten members, Five members from Official side and Five members from Staff side to recommend wage structure for Non-executive employees w.e.f 01.01.2017

BSNL vide letter dated 22.05.2018, set up Grievance Redressel Cell for the Retired employees under Staff Relation(SR) Cell of Corporate Office for settlement of the grievances Contact No. 011-23766063, link for filling on line grievance in prescribed format is also provided at the front page of BSNL intranet site.

CWC of our Association will be held on 7th October 2018 at Pune. Looking forward for very useful deliberations in the meeting

At the end, I appeal once again to adopt modern methods of communication such as SMS, Emails, WhatsApp etc. to communicate and highlight the issue of pensioners, and activities of our Association.

■ Minutes of the 30th Meeting of Standing Committee of Voluntary Agencies (SCOVA) held on 23.03.2018. under the chairmanship of Hon'ble MOS (PP) at Vigyan Bhawan Annexe, New Delhi

The 30th meeting of Standing Committee of Voluntary Agencies (SCOVA) was held under the chairmanship of Hon'ble MOS (PP) on 23.03.2018. List of participants is enclosed.

- 2. Joint Secretary (P) welcomed the representatives of Pensioners Associations and the participating officers from various Ministries /Departments.
- 3. He mentioned that some issues of the last SCOVA meeting have been resolved. Two review meetings were held with Ministry of Health & Family Welfare on 05.06.2017 and with Ministry of Health & Family Welfare, CPAO, Ministry of Defence. Department of Telecom and Department of Financial Services on 09.01.2018 to resolve issues pending in SCOVA.
- 4. Thereafter, the Action Taken Report on the decisions of the 29th SCOVA meeting and Fresh Agenda Items of the 30th SCOVA meeting were taken up for discussion.
- 5. Discussion on the Action Taken Report of 29th SCOVA meeting
 - ii) Health Insurance Scheme for pensioners including those residing in Non CGHS area.

Ministry of Health and Family Welfare informed that final EFC Memo regarding finalization of Health Insurance Scheme was submitted more than a year ago and that the matter was pending with Department of Expenditure. Director (E.V.), Department of Expenditure said that the proposal is not pending with his Division and it may be pending with some other Division in the Department of Ependiture. Ministry of Health and Family Welfare was advised to follow up the matter with Department of Expenditure for taking a final decision in regard to EFC Memo.

(Action: Ministry of Health & Family Welfare and Department of Expenditure)

iv) Extension of CGHS facilities to P&T pensioners.

Ministry of Health and Family Welfare informed that CGHS facility has been extended to all pensioners of P&T Department vide Ministry of Health and Family Welfare OM Dated 19.07.2017. In view of this, the item was closed.

vi) Anomaly in flxation of pension of DoT employees who were absorbed in BSNL between 01.10.2000 and 30.07.2001

DoT informed that Hon'ble CAT in its order dated 16.12.2016 has allowed the petition filed by some absorbee BSNL pensioners who retired during 01.10.2000 and 30.07.2001. DOT has filed a writ petition in Delhi High Court against order of Hon'ble CAT. Hon'ble High Court has granted stay on implementation of Hon'ble CAT's order. The case will come up for hearing in High Court in October, 2018

DoT has separately moved a proposal to Department of Expenditure on a formulation suggested by DoPPW. Department of Expenditure has sought financial implications on the proposal. DoT is compiling information and would submit the same to Department of Expenditure.

(Action: Department of Telecom and Department of Expenditure)

vii) Extension of benefit of upgraded Grade Pay to pre-2006 retirees of S-12 grade (Issue of grant of grade pay of Rs. 4600/- instead of Rs. 4200/-

It was informed that CAT, Bangalore Bench and High Court of Karnataka have in some cases allowed the grant of grade pay of rs. 4600/- to pre-2006 pensioners who retired from the pay scale of Rs. 6500-10500/- In order to avoid the contempt action. DoT has implemented the orders of Hon'ble Cat/ High Court in respect of the petitioners only. Director (PP), Department of Pension & PW informed that a proposal for extending the benefit of grade pay of Rs. 4600/- for revision of pension of all pre-2006 pensioners who retired from the pre-revised pay scale of Rs. 6500-10500/- was carlier referred to Department of Expenditure. However, the proposal was not agreed to by Department of Expenditure. The matter has again been referred to Department of Expenditure for reconsideration on 22.02.2018. Department of Expenditure was requested to expedite their decision in the matter.

(Action: DoPPW and Department of Expenditure)

x) Delay in commencement of family pension to spouse on death of pensioners.

It was mentioned that instructions issued by DoPPW/CPAO provide that family pension to widow should commence within one month of the receipt of death certificate in respect of deceased pensioner. However, widows and other family members of the deceased pensioner continue to face a lot of difficulties in getting the family pension started.

CPAO informed that they have obtained information regarding time taken in commencement of family pension from all banks. The report prepared by CPAO confirms that there has been considerable delays by the banks in commencement of family pension on death of pensioner. The family pension commenced within stipulated period of one month was only in only 38% in cases. In around 47% cases, the time taken for commencement of family pension was more than 6 months. CPAO informed that they have again issued instructions to all the banks on 30.01.2018 and had also taken a meeting with these banks on 31.03.2018 to impress upon them the need for ensuring that the family pension commences within the stipulated on month period. Department of Pension and PW has also taken up the matter with Department of Financial Services on 07.02.2018 forwarding a copy of the report received from CPAO and requesting them to advise all Banks to adhere to the timeline.

DFS was requested to take up the matter with the banks at highest level to make sure that the families of the deceased pensioners get the family pension in time and an acknowledgment is invariably given by the Bank to the family member on receipt of the death certificae of the deceased pensioner and application for commencement of family pension. CPAO was advised that the representatives from DFS may also be invited in meetings held by CPAO with the banks.

(Action: CPAO, Department of Financial Services, CGDA and DoPPW)

xi) Timely (i) Restoration of commuted pension and (ii) Commencement of Additional Pension on attaining the age of 80 years by the Banks.

Director (PP), DOPPW informed that as per the reports received from CPAO, in more than 83% cases during 01.10.2016 and 30.09.2017, commuted pension was restored after a period of 12 months from the date it was due. The report of CPAO also reveals that in 87% cases, the additional pension to old pensioners was started more than 12 months after the date when it was due. Secretary (P&PW), observed that situation is really grim and it cannot be allowed to continue. JS (Pension), DoPPW emphasized the need for making suitable modifications in the softward for automatic restoration of commuted value of pension and commencement of additional pension / family pension. Department of Financial Services (DFS) was advised to instruct banks in this regard.

CPAO informed that the instructions have been issued to CPPCs of the banks from time to time to ensure restoration of commuted pension and commencement / enhancement of additional pension. The matter was also discussed by the CPAO with the banks in the meeting held on 31.03.2018 and the banks were directed to make necessary provisions in the software for timely restoration of commutation and commencement of additional pension. CPAO also requested that all CPPCs should have their e-mail id and contact number. Software should also have date of birth of family pensioners.

CPAO informed that CGA is in the process of developing a common software for banks which will take care of problems relating to delay in restoration of commuted pension and commencement of additional pension.

(Action: CPAO, Department of Financial Services and DoPPW)

xii) Item wise details of payment made to be shown in the pass books of pensioners.

DFS representative informed that instructions to the banks have been issued in January, 2018 in this regard. DoPPW mentioned that only SBI is implementing these instructions to some extent and other banks are not providing the details to pensioners. DFS was requested to issue fresh instructions to all the Banks in this regard.CPAO representative informed that the details regarding pension paid during last 24 months can be accessed from their website. Joint Secretary (P) said that Ministry of Railways should also explore the feasibility of similar provisions in their softward ARPAN.

(Action: CPAO, Department of Financial Services, DoPpW and Ministry of Railways)

Xiii) Additional Pension for recipients of disability pension of age of 80 years and above.

Department of Ex-servicement Welfare informed that orders in this regard have been issued y Department of Ex-servicemen Welfare vide their letter dated 05.09.2017. The item was accordingly closed.

xvi) Empanelment of Hospitals / Health Centre with CGHS in Ambernath / Dombivil.

Ministry of Health and Family Welfare informed that they prescribe terms and conditions and rates for empanelment of private hospitals under CGHS. A private hospital in Ambarnath could be empanelled under CGHS only if such an Hospital applies and accepts the terms and conditions and rates of CGHS. There was some issue regarding CGHS rates for treatment in empanelled private hospitals. Ministry of Health & Family Welfare informed that they have initiated the process for revision of rates based on a new formula which is likely to attact more private hospitals for empanelment under CGHS (Action: Ministry of Health and Family Welfare)

6. Discussion on Fresh Agenda Items of 30th SCOVA meeting

(30.1) Revision of PPOs of pre-2016 pensioners / family pensioners as per 7th CPC orders.

CPAO informed that out of 9.06 lakh cases, 5, 98,400 have been received from PAOs of different Ministries / Departments. Out of which, 5,13,160 caes have been revised as per 7th CPC. CPAO also informed that revision at their end has been fast, however, the cases are not coming from the DDO level because of non-availability of records. The pensioners associations stated that although PPOs have been revised in many cases, pensioners are not getting the copy of the Revised Authority. Also, as well as payments have not been started by the banks due to non-receipt of PPOs by them in many cases.

Department of Posts informed that out of 2,58,205 cases, they have issued revised authorities in respect of 2,17,644 cases.

Department of Telecom informed that out of 95,659 cases, 90,572 cases have been revised as per 7th CPC. Ministry of Railways informed that out of 13,87,542 cases, 8,43,391 cases have been revised

Out of 5,58,761 cases of Defence Civilian pensioners/family pensioners, revised authority has been issued in respect of 1,52,417 cases. Ministry of Defence intimated that they are monitoring the revision of cases of pensioners at highest level i.e. by Secretary (Defence); and CGDA is also monitoring these case fortnightly. Concordance tables for service pensioners have been prepared and will be submitted to Ministry of Defence for approval. Pensioners also reised point of following different guidelines by PCDA (P), Allahabad than the guidelines issued by CPAo. It was advised to CGDA to issue centralized guidelines so that the same guidelines are followed in their all units.

It was decided the work revision of PPOs should be completed by all Ministries / Departments (except Ministry of Defence) by 31.05.2018. Ministry of Defence / CGDA will complete the work in respect of civilian pensioners by 30.06.2018.

(Action: CPAO, Ministry of Railways, Ministry of Defence, Deptt. of Telecom and Deptt. of Posts)

(30.2) Payment of arrears accruing in respect of deceased pensioners / family pensioners to the nominee / legal heir.

It was mentioned that payment of life time arrears in such cases is covered by para 23.2 and 23.3 of the Scheme Booklet of CPAO. As per this para payment is made by the bank to the nominee by a bank pay order after making suitable note on both halves of the PPO. CPAO was advised to direct all banks to take action accordingly in these cases. In the context of revision of pension/family pension of those pensioners / family pensioners who have died on or after 01.01.2016, it was clarified that revised authority needs to be issued in respect of all such pensioners / family pensioners. It was decided that suitable instructions in this regard will be issued by DoPPW.

(Action: CPAO and DoPPW)

(30.4) Empanelment of private referral hospitals in each of the districts of the States in the country.

Ministry of Health and Family Welfare id that empanelment of private hospitals is done only in those cities where CGHS facility exists. Due to referral issue, empanelment of private hospitals was not possible in non-CGHS areas. The proposal for opening of CGHS wellness centre in some more cities is under consideration

with Department of Expenditure. Empanelment of private hospitals in these cities will also be considered. Ministry of Health and Family Welfare also informed that the pensioners in non-CGHS areas can also avail CGHS facility and thus avail the benefit of treatment in private empanelled hospitals in CGHS areas.

In view of the above, the item was closed.

(30.5) Revision of CGHS package rates suitable for attracting more private hospitals for empanelment.

Ministry of Health & Family Welfare informed that the process for revision of CGHS package rates for medical facilities in private empanelled hospitals has already been initiated and a new formula has been proposed in this regard for finalization of rates. This is likely to attract more private hospitals for empanelment under CGHS.

(Action: Ministry of Health and Family Welfare)

(30.9) Holding of regular Pension Adalat by all major Ministries / Departments.

DoPPW informed that they had issued instructions to all Ministires / Departments to held Pension Adalats. Ministry of Defence informed that they are regularly conducting such adalats. Ministry of Railways, DoT, Department of Posts also informed that they have been regularly conducting such Pension Adalats. Representatives of Pensioners associations also confirmed holding of Pension Adalats by the respective Departments on regular basis. Therefore, the item was closed.

- 9) Hon'ble MOS (PP) referred to some recent initiation of the government for the benefit of pensioners. For instance, minimum pension has been increased to Rs. 9000/- ceiling of gratuity has been increased to rs. 20 lakh, FMA has been increased to rs. 1000/- per month. Constant Attendance Allowance has been increased from Rs. 4500/- to Rs. 6750/- w.e.f. 01.07.2017. Some benefits relating to income-tax e.g. Standard Deduction, tax-rebate etc. on interest made available in the Finance Bill, 2018.
- 10) Hon'ble MOS (PP) referred to a news item published in some newspapers regarding difficulties in disbursement of pension in the absence of Aadhaar linkage with the Bank Account. Hon'ble MOS (PP) clarified that Aadhaar has not been made mandatory for getting pension for Government employees. Aadhaar is an aditional facility to enable use of technology for submission of life certificate without the need for visiting banks. The meeting ended with the vote of thanks to the chair.

- 2) All India Postal Employees Union filed SLP No. 6394/2007 before Hon'ble Supreme Court, which was converted in to Civil Appeal No. 2010/2009, demanding grant of upgraded pay scale of Rs. 3050-4590/ from 01.01.1996 instead of 10.10.1997, after dismissal of OA No. 283/2003 filed before Hon'ble CAT, PB New Delhi and WP(C) No. 8972-74/2007 filed before Hon'ble Delhi High Court. The Hon'ble Supreme Court disposed of the SLP directing the respondents to give notional monetary benefit to the members of the appellant w.e.f. 01-01-1996 till 10-10-1997. Further directed that the members of the Union will not be entitled for any arrears of wages / salaries for the interregnum period, i.e. from 01-01-1996 to 10-10-1997
- 3) The issue has been considered in the Directorate in consultation with D/o of Expenditure, Ministry of Finance. The D/o of Expenditure, Ministry of Finance agreed to implement the orders of Hon'ble Supreme Court vide U. O. No. 6 (2) / E.III (B)/ 2016 dated 10.04.2018. Therefore, the competent authority is pleased to grant notional monetary benefit to the Postmen / Mail Guards w.e.f. 01.01.1996 to 10.10.1997 in the revised pay scale of Rs. 3050-4590/-. However, they will not be entitled for arrears of wages / salaries for the interregnum period, i.e. from 01.01.1996 to 10-10-1997.

Subject: Recovery of excess payment made to pensioners.

It has been brought to the notice of this office that some Bank branches are refusing to disburse the family pension to the family pensioners until and unless the whole overpaid amount is credited back to the bank. This issue was also highlighted in the Standing Committee of Voluntary Agencies (SCOVA) meeting Chaired by Hon'ble Minister of State of the Ministry of Personnel, Public Grievances & Pensions.

In this context, RBI in consultation with the Office of the CGA, Ministry of Finance, Deptt. of Expenditure has issued instructions for recovery of excess payment made to pensioners vide their Circular No. RBI/2015-16/340 DGBA GAD No.2960/45.01.001/2015-16 dated - 17.03.2016 which is reproduced below.

- a) As soon as the excess / wrong payment made to a pensioner comes to the notice of the paying branch, the branch should adjust the same against the amount standing to the credit of the pensioner's account to the extent possible including lumpsum arrears payment.
- b) If the entire amount of over payment cannot be adjusted from the account, the pensioner may be asked to pay forth with the balance amount of over payment.
- c) In case the pensioner expresses his inability to pay the amount, the same may be adjusted from the future pension payments to be made to the pensioners. For recovering the over-payment made to pensioner from his future pension payment in installments 1/3rd of net (pension plus relief) payable each month may be recovered unless the pensioner concerned gives consent in writing to pay a higher installment amount.
- d) If the over payment cannot be recovered from the pensioner due to his death or discontinuance of pension then action has to be taken as per the letter of undertaking given by the pensioner under the scheme.
- e) The pensioner may also be advised about the details of over payment / wrong payment and mode of its recovery.

The above uniform procedure may be strictly adhered to while effecting recovery of excess / wrong pension payments made to pensioners and necessary instructions may be issued to the bank branches to ensure that no branch may refuse the pension / family pension to the pensioners on the pretext of excess payment / recoveries.

Guidelines to Process the Requests for Settlement of the Medical Claims

1) New Timelines for settlement of the Medical Claims

The new timelines prescribed for settlement of normal medical claims are 30 days from the date of submission to the payment by Pay & Accounts Office. Every effort must be made to avoid delay at any stage. Proper calculation sheet must be prepared in the file, so that the same could be shared with the beneficiaries, if there are requests for reasons for the deductions.

2) Full reimbursement case / Cases for relaxation of Rules

As per the new guidelines they fall into two categories

- a) Full reimbursement Non-HPC (Non High Power Committee) cases
- b) Full reimbursement HPC (High Power Committee) cases

a) Full reimbursement - Non-HPC cases

The following cases fall under this category;

- Treatment was obtained in a private unrecognized hospital under emergency and the patient was admitted by others when the beneficiary was unconscious or severely incapacitated and was hospitalized for a prolonged period.
- ii) Treatment was obtained in a private unrecognized hospital under emergency and was admitted for prolonged period for treatment of Head Injury, Coma, Septicemia, Multi-organ failure, etc.
- iii) Treatment was obtained in a private unrecognized hospital under emergency for treatment of advanced malignancy.
- iv) Treatment was taken under emergency in higher type of accommodation as rooms as per his/her entitlement are not available during that period.
- v) Treatment was taken in higher type of accommodation under specific conditions for isolation of patients to avoid contacting infections.
- vi) Treatment was obtained in a private unrecognized hospital under emergency when there is a strike in Govt. hospitals.
- vii) Treatment was obtained in a private unrecognized hospital under emergency while on official tour to non-CGHS covered area.

Although the new OM has not mentioned about STC recommendation, it is advisable to have expert Committee meetings under the Chairperson of Addl. DGHS (as in the case of earlier STC meetings) in respect of item Nos. i) ii), iii) and v) before arriving at a decision. The conditions mentioned at Nos. iv), vi) and vii) are administrative in nature and do not require meetings of expert committees and may be recommended by Addl. Director, if conditions are satisfied.

IN Delhi the expert committee meetings shall be organized by respective CMO (R&H) and by Ad (R&H) in case of claims of serving employees of Delhi. Such meetings in respect of other cities shall be organized by Sr. CMO in the office of Adl. DG (HQ).

The requests for full reimbursement as examined by Additional Director (HQ)/ Addl. DDG (HQ), in consultation with expert committee meetings, wherever deemed necessary and recommended for full reimbursement shall be submitted to Director, CGHS and concurrence of IFD may be obtained after approval of AS & DG, CGHS before the seeking the approval of Secretary for reimbursement in excess of CGHS rates.

If the above criteria are not satisfied (including the regrets by expert committees) the requests may be regretted by AddI. Director of concerned City, with a covering letter explaning the reasons and referring to the concerned OM.

In case there is a representation to consider as a special case then only it may be placed before the High Power Committee.

Addl. Directors shall prepare a self-contained note giving details of case and submit the files with relevant documents to Director, CGHS though AD (HQ) Addl. DDG (HQ)

If the proposal is approved by AG & DG, CGHS, concurrence of IFD and approval of Secretary, Health & Family Welfare are solicited for reimbursement in excess of approved rates.

b) Full reimbursement - HPC cases

The Composition of High Power Committee, shall be as under:

- 1) Special Director General ... Chairperson
- 2) Directorate General, CGHS or his Nominee... Member
- 3) Additional Director, CGHS (HQ) Addl. DDG (HQ) CGHS ... Member
- 4) Addl. Director, CGHS (R & H) ... Member Secretary
- 5) One Government Specialist (of concerned Speciality) ... Member

The High Powered Committee shall consider the representations of only those CGHS beneficiaries having a valid CGHS Card.

The High Powered Committee shall consider representations received from CGHS beneficiaries holding valid CGHS cards only at the time of treatment, in respect of the following conditions

- 1) Approval for air-fare with or without attendant on the advice of treating doctor for treatment in another city even though he is not eligible for air travel / treatment facilities are available in city of residence.
- 2) Representations from CGHS beneficiaries seeking full reimbursements under special Circumstances.
- 3) Relaxation of Rules.

High Powered Committee shall meet once in a month and action on the decisions taken shall be completed within seven days of meeting, with the concurrence of the IFD wherever, it is deemed necessary. AddI Directors shall submit the files with relevant documents to the AD (HQ) / AddI. DDG (HQ) for placing the representations before High Power Committee.

AD (R & H) shall be Member Secretary, who shall with the help of Sr. CMO of the Office of Addl. DDG (HQ) shall issue meeting notices including notices to concerned Govt. Specialists and organize meting for the Meetings of High Power Committee.

The requests received upto the 15th of the month shall be placed before the Committee. If the High Power Committee recommends full reimbursement / relaxation of rules, Concurrence of IFD and approval of Secretary (H & FW) shall be obtained within 7 days.

3) In addition there are expert committees to consider several cases

Expert Committee meetings for other purposes shall continue to be held as in the past in the following cases. Expert Committee meetings for Consideration of Liver Transplant cases, Bariatric Surgery,

Bone-marrow / Stem Cell Transplant, Justification of treatment / Implants in selected cases shall continue as before. Standing Committee meetings for Cochlear implant shall continue as before. Expert Committee meetings for approval of Drugs, etc., shall continue.



As per the CGMT, MH Circle instructions and in conformity with the existing guidelines on austerity measures, there is urgent need to outline a strategy for effecting a reduction of a minimum 20% under working expenses (Annexure attached) for the Financial year 2018-19. All Heads of SSAS' are requested to strictly adhere to the monthly expenditure limits given in the enclosed annexure, crossing the monthly limit under any components, approval of the CGMT shall be sought & note approval copy submitted to CSC for realising payments for the excess expenditure incurred. IFAs shall effectively monitor the component wise expenditure on monthly basis for payments and initiate necessary action well in advance.

1) Medical Expense-Indoor & Outdoor

It is suggested that all generic medicines to be purchased from authorized generic Medical Stores / Online medical shops or chemist which are providing medicines on discounted rates / 50% deduction. AO (Claims) should ensure that all the avenues have been explored before the bill has been passed. Otherwise he may pass the claims by making 20% reduction.

- 3) To identify the grievance prone areas i.e. grievances of similar nature occurring more frequently.
- 4) To determine the cause of grievances of similar nature occurring more frequently and address the root cause by taking suitable corrective and preventive actions.
- 5) If the grievance can not be resolved at the level of circle, it may be referred to this cell.

Sub: Denial of Promotion under MACP (Modified Assured Career Progression Scheme) due to the orders of the Directorate New Delhi.

Reference: No. 2-19/2015-PCC from Assistant Director General (GDS/PCC) dt.12.02.2018

Respected Sir,

- 1. As per the provisions in the Directorate OM No. A-7(MACP) 2009 PCC -Dated 18.09.2009 the promotions earned in the posts carrying same grade pay in the promotional hierarchy as per the rules shall be counted for the purpose of MACP promotions. As such the promotions earned by the officials on passing the competitive examinations were counted towards the promotions under MACP (10/20/30 years). The officials were thus denied of the newly introduced promotion under MACP after 10/20/30 years of service.
- 2. Aggrieved by these orders one shri D. Shivkumar retired SPM Chenn ai had filed a petition in the Hon'ble CAT Madras under No. 1088/2011. His claim for promotion under MACP ignoring the promotions by competitive examinations was upheld by the CAT Madras by its order dated 14.03.2013. Accordingly shri D. Shivkumar got his promotion as approved by CPMG Chennai. In this connection the department filed a revision petition in the Hon'ble Supreme Court of India. This revision petition was dismissed and the orders pronounced by the Hon'ble tribunal Madras were upheld vide SLP No. 1848/2016 Dtd. 16.08.2016.
- 3. The directorate had conveyed vide letter No. 2-19/2015-PCC Dtd. 01.03.2017 that the directorate has decided to implement the orders of the Hon'ble CAT Madras in the case of shri D. Shivkumar.

The Directorate while conveying further order in this case vide his No. 2-19/2016-PCC Dtd. 12.02.2018 took a negative approach by Quoting the advice of DOPT that "The Supreme Court while dismissing the review petition has not given any direction on the revisiting the policy in the context of the instant case of Shri D. Shivkumar. Therefore the Judgement may be implemented in "Personm" and may not be treated as a precedent in other cases.

- 4. The Hon'ble Supreme Court while dismissing the review Petition has not given any direction on the revisiting the policy in the context of the instant case. Therefore the DoPT has advised to treat the judgement as 'in personm' and implement it without treating it as a precedent in other cases. Solicitor General of India in his advice has pointed out that the Department has lost the case due to the fact that they have not produced a copy of Recruitment Rules before the Hon'ble Tribunal and High Court. The D/ o Legal Affairs Ministry of Law and Justice has advised that the Hon'ble Apex Court had kept the question of Law open. There are lot of of serving employees/ pensioners who are aggrieved by the stand taken by the Department of Posts which denied the benefit of MACP. All these employees/ pensioners are very sincere and are not so rich to afford the expensive procedure to approach the Tribunal or theHigh court individually.
- 5. Department of Post may also not like that these employees/Pensioners to approach the Tribunal or the High Court individually. In view of the above you are hereby requested to consider to revisit the policy of MACP and consider to sanction of promotion under MACP afresh ignoring the promotion if any earned on passing the competitive examination.

This act of the D/o Posts will give relief to thousands of officials who are denied the promotions under MACP scheme.

- 1. 6th Central Pay Commission also made recommendation with regard to Modified Assurance Promotions(MACP) to the employees. The recommendations of 6th CPC related with Pay and allowances were implemented by the Government with effect from 01.01.2006.
- 2. Whereas MACP Scheme is approved by Govt. of India replacing ACP existed on the recommendation of Sixth CPC and the benefit of up gradation under MACP is given from 01.09.2008 in stead of 01.01.2006. This immediately removed a section of employees who retired in between 1.1.2006 and 31.08.2008.
- 3. Under such circumstances, Supreme court after hearing the prayer of Balbir Sing Turn & Another, (Civil Appeal No 3744 OF 2016) has given the judgment to give the benefit from 01.01.2006. The judgment is very important in the context of the demand that remains unheard by GOVT.
- 4. There is section of serving employees/ pensioners who are aggrieved by the stand taken by the Government, which are denied the benefit of MACP. All these employees/pensioners are very sincere and are not so rich to afford the expensive procedure to approach the Tribunal or the High court individually.
- In view of the above you are hereby requested to address the DOPT to consider up gradation under MACP from 01.01.2006 instead of 01.09.2008.
