Let us pay humble tribute to Chief of Defence Staff General Bipin Rawat, his wife and 12 other soldiers who are dead in a tragic helicopter accident on 10-12-2021. Defence Staff General and Soldiers died serving our Nation. We salute all of them.

It was necessary to hold the AGM of our Association to elect the Office bearers on CWC as the tenure of earlier CWC members was about to over in November, 2021. 69th AGM was held on 21st October, 2021 at Phadake Hall, 1785 Sadashiv Peth, Pune 411030. The arrangements of Hall and food were appreciated by the Delegates. We brought out an Informative, Multicolour Calender-2022 in the year of celebration of 75th year of our Association and released at AGM held on 21-10-2021. The efforts put in for bringing out such informative Calendar was appreciated by Shri S. K. Deshpande and most of the Secretaries. We are thankful to Branch Secretaries, who participated in the arrangement of AGM at grand success and also contributed for Calendar-2022 through advertisements and also distribution.

Jamkhandi (Karnataka) Branch is merged with Vijaypur Branch on 30/10/2021 in the presence of Shri G. N. Kulkarni, Vice President. AGM Karad Branch, held on 10/11/2021 resolved that the Karad Branch be merged with Shahupuri, Satara branch.

Government has issued the order for granting the DA to central Govt. pensioners at the rate of 31% with effect from 01/07/2021. In respect of BSNL pensioners also, MOF, DPE has issued the order for granting IDA 173.6% from 01/07/2021 and 179.3% with effect from 01/10/2021.

On receipt of petition/suggestions from Service Unions/Pensioners Associations (including our Association), Parliamentary Standing Committee on Personnel, Public Grievances, Law& Justice headed by Shri Sushil Kumar Modi Rajya Sabha MP, submitted its report, presented in Rajya Sabha on 10/12/2021. In addition to recommendation to improve CGHS facilities, Committee has also recommended to consider the demand of Pensioners Associations for 5% /10%/15% additional quantum of pension on attaining 65/70/75 years respectively.

Union Minister Dr Jitendra Singh launches unique Face Recognition Technology (Face reading App) for pensioners, on 29th November, 2021. It recognizes the face and generate the Digital Life Certificate. It will bring Ease of Living for the elderly pensioners to submit the Digital Life Certificate from home.

We arranged DLC camps for Central Govt. pensioners at different parts of Pune City to facilitate the senior members to submit the Life certificate in the month of November.

SPARSH-System For Pension Administration (Raksha), a Compressive Pension Package(CPP) is introduced for Defence pensioners. CPP is envisaged to ensure Right payment to the Right pensioner at Right time through digital processing of 30 lakh plus pensioners.

There is good news for the BSNL absorbed employees, who retired between 1/10/2000 to 31/06/2001 that DOT issued the order dated 07.10.2021 removing the anomaly in the pension of absorbed employees retired within 10 months from 01/10/2000 as per the illustrations given in the Annexure - I and grant all consequential benefits. BSNL Corporate office also vide letter dated 5.11.2021 ordered for Calculation of Gratuity and cash payment in lieu of leave for the employees of CPSEs following IDA pattern retired on or after 01/10/2000 and up to 30/06/2021.

BSNL Corporate office vide order dated 10/11/2021 to reconstitute the Joint Committee to recommend the Wage structure for Non-executives in BSNL with effect from 01/01/2017.

Government Order

F.No. 1/7/2020 -P&PW (F), Dated: 30th September 2021, Government of India, Ministry of Personnel Public Grievances and Pensions, Department of Pension and Pensioners Welfare, New Delhi

Subject: Payment of amount of Ex-Gratia lump sum compensation to the families of Central Government servants who die in the performance of bona fide official duty- Provision for nominations regarding.

The undersigned is directed to say that the families of Central Civil Government servants, who die in harness in the performance of their bona fide official duties under various circumstances, are entitled to payment of ex-gratia lump sum compensation in accordance with this Department's OM No. 45/55/97- P&PW(C) dated 11th September, 1998. The amount of ex-gratia lump sum compensation has been revised from time to time. The existing rates of ex-gratia lump sum payment are specified in this Department's OM No. 38/37/2016-P&PW (A) dated 04.08.2016.

- 2. The existing instruction, however, do not specify the member of the family to whom such exgratia lump sum compensation is payable in the event of death of the Government servant in the performance of bona fide duty. Therefore, in terms of para 13 of the guiding principles mentioned in the Annexure to the OM No. 45/55/97-P&PW(C) dated 11th September 1998, payment of ex-Gratia lump sum compensation is presently being made to the member of the family who is eligible for extraordinary family pension under the CCS (Extraordinary Pension) Rules, 1939.
- 3. The matter has been examined in consultation with Ministry of Finance (Department of Expenditure). On death of a Government servant, payment of other lump sum amounts, such as death gratuity, GPF balance and CGEGIS amount, is made in accordance with the nominations made by the Government servant during service. Accordingly, it has been decided that, on death of a Government servant in the performance of bona fide duty also, payment of ex-gratia lump sum compensation may be made to a member or members of the family in whose favour a nomination is made by the Government servant during service. Family for this purpose shall have the same meaning as in the case of gratuity and it shall include the members of family as mentioned in sub-rule (6) of Rule 50 of the CCS (Pension) Rules, 1972.
- 4. The Common Nomination Form in Form 1 appended to the CCS (Pension) Rules, 1972 has been amended to include the nomination in respect of the ex-gratia lump sum payment and the same is enclosed. Accordingly, nomination in respect of ex-gratia lump sum payment shall also be made in this Common Nomination Form. The nomination for ex-gratia lump sum payment shall be subject to the provisions as applicable in the case of gratuity under Rule 53 of the CCS (Pension) Rules, 1972. Since the ex-gratia lump sum payment is payable to the family only, no nomination shall be made in favour of a person who is not a member of the family, even where the Government servant has no family. If no nomination has been made or the nomination made by the Government servant does not subsist, the exgratia lump sum compensation will be shared equally by all eligible family members, as in the case of Gratuity, in accordance with Rule 51 of the CCS (Pension) Rules.
- 5. These instructions shall be applicable in the case of death of a Government servant on or after the date of issue of this OM. Cases of payment of ex-gratia lump sum compensation on death of Government servants before the date of issue of this OM shall continue to be dealt with in accordance with the instructions applicable before the issue of this OM.
- 6. This OM is issued with the concurrence of Ministry of Finance, Department of Expenditure vide their ID Note No. 27(1)/E-V/2020, dated 22.07.2021.
- In its application to persons belonging to Indian Audit and Accounts Department, these orders are issued under Article 148(5) of the Constitution and after consultation with the Comptroller and Auditor General of India vide their U.O. No. 211-Staff -Hak (Rule)-A.R/09-2019 dated 13.09.2021.
- 8. The Administrative Divisions of all Ministries/Departments and attached/subordinate offices are requested to bring the contents of these instructions to the notice of all concerned for compliance.

- 9. Formal amendment to CCS (Pension) Rules, 1972 for amending Form 1 appended to those rules shall be notified separately.
- 10. Hindi version will follow.

IPPB has enabled this service across the network of post offices and also at the doorstep of the pensioners, through the Postmen/Gramin Dak Sevaks. This doorstep service from IPPB witt hetp more susceptible etderl.y citizens to avoid travetting and visit banks / offices to submit DLCS in the current COVID pandemic.
- 3. The assisted DLC services can be avaited by any pensioner inctuding Centrat, State and EPFO, based on Aadhaar enabted biometric authentication. The service would increase convenience for the pensioners and atso reduce the turnaround time of issuance of Jeevan Pramaan Certificate.
- 4. In view of the above, I would like to request you to spread the awareness amongst pensioners of your Ministry regarding the avaitability of assisted DLC services through India Post Payments Bank. **Shri Pawan Kumar Singh, Deputy Director General (Post Bank of India)** may be contacted on ddgpbi@indiapost. gov.in for any support. Subject: Grant of Dearness Relief to Central Government pensioners/family pensioners – Revised rate effective from 01.07.2021-reg

The undersigned is directed to refer to this Department's OM of even no. dated 22.07.2021 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government pensioners/family pensioners shall be enhanced from the existing rate of 28% to 31% of the basic pension/family pension (including additional pension/family pension) w.e.f 01.07.2021.

- These rates of DR will be applicable to the following categories:
 - i. Civilian Central Government Pensioners/Family Pensioners including Central Govt. absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D)Vol.II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years.
 - ii. The Armed Forces Pensioners/Family Pensioners, Civilian Pensioners/Family Pensioners paid out of the Defence Service Estimates.
 - iii. All India Service Pensioners/Family Pensioners.
 - iv. Railway Pensioners/family pensioners.
 - v. Pensioners who are in receipt of provisional pension.

- vi. The Burma Civilian pensioners/family pensioners and pensioners/families of displaced Government Pensioners from Burma/ Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008-P&PW(B) dated 11.09.2017.
- 3. The payment on account of Dearness Relief involving a fraction of a rupee shall be rounded to the next higher rupee.
- 4. Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in this Department's OM No. 45/73/97-P&PW (G) dated 2.7.1999 as amended from time to time. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.
- 5. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.
- 6. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 7. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of relief to pensioners etc. on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, II/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalized Banks.
- 8. In their application to the persons belonging to Indian Audit and Accounts Department, these orders are issued under Article 148(5) of the Constitution and after consultation with the Comptroller & Auditor General of India.
- 9. This issues in accordance with the Ministry of Finance, Department of Expenditure's OM No. 1/4/2020-E.II(B) dated 25.10.2021.

No. Z 15025/35/2019/DIR/CGHS/ CGHS(P) Dated 1/10/2021 From MOHFW, Deptt. of H&FW, New Delhi. Sub: Clarification regarding investigations at empanelled Diagnostic Centres in respect of CGHS beneficiaries aged 75 years and above.

With reference to the above mentioned subject the undersigned is directed to draw attention to the Office Memorandum of even number dated the 29th May 2019 vide which CGHS beneficiaries aged 75 years and above were permitted to consult Specialists at Hospitals empanelled under CGHS without referral from CGHS and to clarify that there is no provision to undergo investigations at CGHS empanelled Diagnostic Laboratories and Imaging Centres without advice for such investigations from Government Specialists/CGHS Medical Officer / Specialists of empanelled hospitals. In case of unlisted investigations, approval of Competent Authority is necessary before undergoing such investigations from empanelled Diagnostic Laboratories and Imaging Centres.

As per Rule 277 of Parlimentary procedures "the report of a Standing Committee shall have persuasive value and shall be treated as considered advice given by the Committee".

Department of Pension has to consult Department of Expenditure and it has to submit "Action taken report to the committee.

Parlimentary Standing Committee on Personnel, Public Grievances, Law & Justice headed by Shri Sushil Kumar Modi (Rajya Sabha MP) submitted its 110th report which was presented in the Rajya Sabha on 10/12/2021. It was laid on the table of Lok Sabha on the same day.

There are 30 MPs (10 from Rajya Sabha & 20 from Lok Sabha) in the committee. Three MPs (S/shri A.Raja, Manickam Tagore & P Wilson) are in the committee from Tamilnadu.

Regarding Medical Facilities

Para 3.19 -

The Committee notes that despite favourable decision of apex Court in a number of cases, all the expenditure incurred by a beneficiary of CGHS on his or her treatment in non-empanelled Private Hospitals should be reimbursed to the beneficiary, the Govt. has not yet issued any general instructions in this regard and the pensioners/beneficiaries have to approach the Court of law for justice by spending a lot of money and time. The Committeee believes that rules and procedures are just a means to achieve a larger goal i.e. welfare of pensioners and they should not become an end in themselves. Strict adherence and conformity to norms, rules and procedures might lead to a situation where strictly following these norms, rules and procedures instead of being means, become ends in themselves which create stumbling blocks in achieving mandated objectives/ends. The Committee is of the view there may be exigencies when the old age pensioners may directly approach non-empannelled hospitals for treatment without first approaching a Govt. Hospital. They should not be deprived of their rightful entitlements under any circumstances. The Committee recommends the Department to play a pro-active role and pursue the matter with the Ministry of Health and Family Welfare.

The Committee also recommends the Department to seek details of action taken by the Ministry of Health & Family Welfare on the judgements of the Apex Court in this regard and furnish them to the Committee in its Action Taken Replies.

Para 3.20 -

The Committee is in agreement with the views of Pensioners Associations that CGHS should not confine its operations to metro cities, state capitals and a few large urban centres only. The Govt. may explore opening of CGHS centres at district locations or designate already functional Govt. hospital in district headquarters as CGHS Centres to provide treatment to CGHS beneficiaries. The Govt. may also include settlement of medical facility related grievances of pensioners on the portal of CPENGRAMS as requested by pensioners and the DoP&PW should work in tandem with Health Ministry in this regard.

Para 3.21

The Committee takes note of the fact that Fixed Medical Allowance is granted to pensioners who reside outside the CGHS areas for meeting expenditure on day-to-day medical expenses (OPD) that do not require hospitalization. The Committee also takes note of the request of Pensioners Associations for enhancement of Fixed Medical Allowance from Rs.1000 to Rs.3000 per month as most pensioners are suffering from different diseases at old age and are unable to manage with meager pension as CGHS hospital is not available in every town. The Committee recommends DoP&PW to take up this issue of enhancement of FMA with the Finance Ministry as Rs.1000 is a very meager amount for an old age pensioner and apprise the views of the Finance Ministry to the Committee in its Action Taken Replies.

Para 3.22 -

The Committee takes note of the difficulties faced by pensioners in surrendering their Fixed Medical Allowance (FMA) and getting FMA Surrender Certificate to avail CGHS indoor & outdoor (OPD) facilities, and, accordingly, recommends DoP&PW and CGA that the procedural loopholes coming in this way should be plugged and ensure that all such pensioners should get FMA Surrender Certificates in a hassle free manner through online mode under intimation to the bank concerned and a timeline should be fixed in this regard.

Para 3.23 -

The Committee notes that the Central Govt. provides health care facilities for both, serving as well as, retired employees. However, the Committee observes that serving employees of Central Govt. are covered under the Central Service (Medical Attendance) Rules, 1944 (CSMA Rules), which provides facilities for availing medical facilities outside CGHS covered areas. However, these Rules are not applicable to pensioners, and instead pensioners residing outside CGHS covered area are entitled to FMA. The Committee is of the view that non-applicability of CSMA Rules to pensioners residing outside CGHS areas has placed them at disadvantaged position vis-à-vis serving employees. Accordingly, the Committee feels that either the provisions for medical facilities available to serving employees also needs to be extended to pensioners or instead of increasing FMA year after year, DoP&PW may moot a proposal for introducing cashless health insurance facilities for such pensioners in nearby Private Health Centre in lieu of FMA on voluntary basis.

Regarding Additional Pension

Para 3.28 -

The Committee is very much cognizant of the social churning taking place in our society over the years. The joint family system is breaking down giving way to nuclear families. The growth of nuclear families due to geographical and social mobility have further led to rise in individualism and individualistic thinking and the generation who want to live away from shackles of joint families and patronage of elderly parents or grandparents. According to one estimate, by 2050, the share of population over the age of 60 is likely to increase significantly in the country. In view of such changes at societal level, we need to have a robust pension system for elderly which can help them survive in this world without being a burden on anyone. The Committee is of the view that the Govt. should sympathetically consider the demand of Pensioners Associations for 5% additional quantum of pension on attaining the age of 65 years, 10% on 70 years, 15% on 75 years and 20% on 80 years to the pensioners. The Committee recommends DoP&PW to pursue vigorously with Finance Ministry and apprise the Committee of the outcome.

Subject: Implementation of the order dated 16.12.2016 of the Hon'ble CAT (PB), New Delhi in OA No.2173/2014 in the matter of All India BSNL Pensioners' Welfare Association & Ors. Vs. UOI & Ors.

It is intimated that All India BSNL Pensioners' Welfare Association (AIBSNLPWA) raised the issue of anomaly in pension of the absorbed BSNL employees, who retired within 10 months of the effective date of absorption i.e. 01.10.2000. Pension of these absorbed employees of BSNL was to be calculated on the basis of average emoluments of their last 10 months before retirement — some period of which (prior to 01.10.2000) fell under CDA and the remaining period fell under IDA. Pay Scales in CDA was less than that of in IDA Pay Scales. The Dearness Relief in such cases was to be allowed on IDA rates, which is less than DR rates under CDA. Thus, these absorbees got pension based on average emoluments which included an element of CDA whereas the DR on pension is allowed on the basis of IDA resulting in an anomalous situation where these pensioners got less pension.

- 2. It has been decided with the approval of the competent authority to implement the order dated 16.12.2016 of the Hon'ble CAT (PB), New Delhi in OA No.2173/2014 in the matter of AIBSNLPWA & Ors. Vs. UOI &Ors, on dismissal ofWP(C) No.10019/2017 of DOT by the Hon'ble Delhi High Court, vide judgment dated 24.01.2020, thereby removing anomaly in pension of the absorbed BSNL employees retired within the period of 10 months from 01.10.2000. Their pension is to be re-fixed from the date of their retirement by adopting the formula as contained in the DOP&PW's OM dated 18.10.1999 by giving them notional benefit of IDA pay for the period their pay was taken in CDA pay for the purpose of calculating average emoluments and, thereafter, grant all consequential benefits. Two illustrations (methodology adopted) are given in the Annexure-I of this letter for removing anomaly in pension of the ex-BSNL absorbed employees retired within the period of 10 months from 01.10.2000. Accordingly, revised pensionary benefits may be extended suo moto to all affected pensioners. However, in case of death of pensioner, payment may be made suo moto based on nomination as per Arrears of Pension(Nomination) Rules, 1983. In the absence of nomination, the arrears may be paid to legal heirs of the deceased pensioners who apply for the same.
- 3. All concerned offices/CCAs are requested to take further action in the matter for removing the anomaly in pension of the ex-BSNL absorbed employees retired within the period of 10 months from 01.10.2000 as per the illustrations given in the Annexure-I of this letter and, thereafter, grant all consequential benefits.

Subject: Petition praying for compressive medical facilities to Central Government Employees/Pensioners. Difficulties faced by Serving Employees/Pensioners.

Respected Sir,

We hereby appreciate the initiative of Rajya Sabha Committee for having taken up such important issue regarding health facilities of Central Government Employees/Pensioners. We would like to draw your kind attention to the following issues in respect of Central Government Health Scheme.

- 1. During last Seven years, the Cities having CGHS facilities have been remarkably expanded extending the boundary of the cities. CGHS facilities have been extended to BSNL/MTNL pensioners also. There is a huge demand from the Employees/ Pensioners residing in the new areas to open CGHS Wellness centres within their reach. For example:
- a. In Pune, Most of the pensioners reside in Karve Road-Kothrud-Karvenagar area. Senior pensioners aged 80 years and above have to travel 7 to 12 Kms to reach the earmarked Wellness Centre.
- b. Instead of opening new Wellness Centres, the existing Wellness Centre at Mahatma Gandhi Road, Camp, Pune, which was convenient, has been closed since July, 2021. The pensioners residing in Hadapsar, Kondhwa area have to travel 10 to 12 Kms to reach allotted Wellness Centre at Bajirao road, Pune.
- c. Due to the increase in the no of CGHS beneficiaries in the suburban of Mumbai, CGHS decided to open CGHS Wellness Centre at Kalyan but they could finalize the accommodation as yet.
- d. Most of Employees/Pensioners, CGHS beneficiaries reside in and around Panvel-Navi Mumbai Area, CGHS Wellness Centre is not available in the area. Department of Post and the Postal Service Union have also demanded the CGHS facilities in the area. It is understood that accommodation for Wellness Centre, may be made available in the space owned by Department of Posts.
- 2. In Maharashtra and Karnataka the progressive states, most of the pensioners prefer to reside in the District headquarter, which has the good hospitals. There is a demand from big towns, having good number of employees/pensioners for extension of CGHS facilities to these districts. The demand of extension of CGHS facilities to these districts is not met as they are short by some margin of existing criteria of minimum 6000 card holders for extension of CGHS to a new city. The following demands are pending on this account.
- The demand of extension of CGHS facilities at Sangli- Miraj(Maharashtra).
- b. The demand of extension of CGHS facilities at Dharwad-Hubbali(Karnataka). Belagavi may also be covered in that region.
- 3. Secondly Department of Health & Family welfare, New Delhi, vide Order dated 10th June, 2021, 64 posts have been created for 16 new Allopathic CGHS Wellness Centres. As per feedback received from our Branches at Aurangabad(Maharashtra), Coimbatore (Tamilnadu), CGHS wellness Centres are not started as yet. They are still searching for a suitable building for opening the wellness centre.
- 4. Many wellness centres face shortage of doctors and other paramedical staff. This issue should be addressed.
- 5. Plastic Card printing and CGHS Card printing system is required to be updated and improved a lot..

 There is vast delay in the issue of Plastic Card issues.
- 6. The revision of CGHS rates for empanelled private hospitals have been carried out in 2014, seven years ago and no revision of CGHS rates has been done in the recent times in spite of revision of rates by Private hospitals. Secondly, Most of the Empanelled hospitals say that the bills submitted by them to CGHS authorities are not passed in time. There is inordinate delay in passing of bills. Due to this, Pensioners are facing following difficulties.
- a. The empanelled private hospitals are refusing to admit the CGHS beneficiaries. Patients Most of them are Sr. pensioners, have to wait for admission in panic.

- b. On admission Hospitals are asking an excess amount (difference) from the patients. Some tests are done only on payment of difference of actual charges and charges approved by CGHS.
- c. Similar situation is in the case of Diagnostic Laboratory & Dental Clinic.
- d. Good hospitals who were empanelled are withdrawing themselves from the Central Government Health Scheme hospitals.
- 7. CGHS card holders above the age of 75 years are allowed to consult doctors in any empanelled hospital directly, the specialist doctor advice some tests to be done. Pensioners/beneficiaries are asked to get the memo signed by CGHS wellness centre, otherwise they have to pay for it.

Sir, We therefore, request you to consider these issues, while recommending the improvement in the existing CGHS facilities.

Feedback on these issues shall be appreciated.

- 7. General Secretary submitted the Following Resolutions which were discussed and adopted by the AGM.
- 1. Extension of Court Judgements to similarly placed Pensioners / Family Pensioners:-
- 69th AGM of AICGPA, Hq. Pune is constrained to note that Though there are various Court(s) judgements in favor of pensioners/family pensioners, the benefits accruing out of these judgments are not being extended suo-motto by GOI to similarly placed pensioners/family pensioners. As such AGM resolved that Courts decision in respect of the following judgement may be implemented as its not possible for pensioners to go to the court.
- a) MADRAS High Court's decision for Grant of increment form 1st July for the retirees who retired on 30th June may be extended to similarly placed pensioners.
- b) GAUHATI High Court's decision for Grant of 20% additional quantum of pension in the slab of 'From eighty years to less than eighty five years' from the first day of his 80th year instead of on completion of the 80 years of age may be extended to similarly placed pensioners/family pensioners.

- c) Complying with the Judgment of the Hon'ble Supreme Court of India, the Government has implemented the MACP with effect from 1.1.2006 in respect of Defense employees. The judgement may also be implemented respect of Civilian employees.
- 2. It is an undisputed fact that the Pensioners Associations assist the pensioners in general, and the family pensioners and the semi literates in particular, in resolving pension related problems through the institution of Pension Adalats. But regretfully, on most of the occasions, representatives of these Associations are not involved/allowed to attend these Adalats and assist the needy pensioners. As such,
 - AGM resolved that the Governments to permit the representatives of Pensioners Associations to assist the pensioners/family pensioners, who need their services, in the Pension Adalats.
- AGM resolved that In view of high inflation of health-care, Government may consider the long pending demand of the pensioners/family pensioners to increase the present Fixed Medical Allowance to Rs.3,000/ - pm linking it to Dearness Relief for automatic further increase.
- 4. DOT employees, who retired prior to 01.10.2000 and residing in NON-CGHS area are paid Medical Allowance regularly @ Rs. 1000/- p.m. along with monthly pension.
 - Whereas, DOT employees who are absorbed in and retired from BSNL from 01.10.2000 onwards are struggling to get the reimbursement of the medical expenses in later stage of their life. The Medical Bills for Outdoor/Indoor treatment submitted by them have not been paid since 2018-19. The Medical Allowance applicable for the retirees who opted for Without Voucher facility have not been paid since 2018-19 in some cases since 2017-18. In so many cases, BSNL units have deducted the TDS from the amounts of some Medical Bills passed by DDOs, but the amounts have not been paid to the pensioners so for. In accordance with DOT OM NO 40-13/2013-Pen(T) Dated 20.07.2016, The liability towards pensionary benefits including Family pension to the BSNL pensioners(except recruited after 01.10.2000) lies with the Government of India. This AGM resolved that the Government of India (DOT) may take the responsibility of payment of Fixed Medical Allowance @ Rs. 1000/- pm to such BSNL pensioners also.
- This AGM demands implementation of 3rd P.R.C. Recommendations for BSNL Working Employees at the earliest as admitted by Shri A.K. Sinha, DGM BSNL in conciliation meeting dated 07.12.2020 with Labour Commissioner, New Delhi, so that Pension Revision for BSNL Pensioners can also be implemented by the DoT.
- 6. In view of General Body shall meet once in every year, It will not be possible for Headquarter to reimburse the travelling expenses of the Branch Secretaries for attending the AGM. It is therefore proposed that Branch Secretaries may submit the claim of reimbursement of travelling expenses to attend the AGM to the branch.

AGM resolved that Branch Secretaries shall submit the claim of reimbursement of travelling expenses to attend the AGM to the branch for payment.
