Mahore, who have taken my call very positively and arranged the Special AGM, successfully electing the new body of the Branch unanimously. Let us wish all the best to the new executive bodies of both the branches for reinforcing the belief among the members.

The meeting with Shri S. K. Pande, Director of Accounts(Postal) held on 13th August, 2018 was successful in solving the ground level issues in revision of pension as per 7th CPC/non receipt of copies of revised PPO by pensioners/delay in forwarding the orders of DOT/BSNL pensioners issued by CCA etc. The detail report is printed in this Bulletin.

Finally, the Revision of pension as per 7th CPC, for retired employees of Kendriya Vidyalaya Sangathan, is ordered vide No. F.110230(Misc)2018/KVS(HQ)P&I/2256 Date:09/08/2018. Branch Secretaries are requested to inform the good news to the concerned members.

With the support of recent Supreme Court / High Court judgments, Pre-2006 retirees may be extended the benefit of upgraded scales AND the benefit of MACP would apply with effect from 01.01.2006 in stead of 01.09.2008. Matter is being pursued with DOP & PW. We are looking forward the issue of orders.

You are aware that CCA, Maharashtra Circle has started the collection of the information from all DOT/BSNL pensioners, required for the functioning as PDA(Pension Distributing Authority). All Branch Secretaries/ Org. Secretaries are again requested to contact the remaining DOT/BSNL pensioners and get filled specified form printed in July, 2018 Bulletin and forward the same to concerned CCA Office.

As per the guidelines of Department of Pensions and Pensioners Welfare, New Delhi, National Pension Adalats were held by almost all Departments. We hope the grievances of most of the pensioners were heard and settled to the satisfaction of pensioners. The details of National Pension Adalats held by CCA Mumbai as reported published in this bulletin.

The 3rd Meeting of Joint Wage Revision Committee was held on 27/08/2018 under the president ship of Shri H. C. Pant. Management side proposed the multiplication factor of 2.4 to arrive at the minimum of new scale. Staff side demanded the multiplication factor of 2.44. The management side agreed to examine. The next meeting will be held on 28/09/2018.

As per the guidelines received from DOP&PW, New Delhi "Swachhata Hi Seva" 2018 again from 15th September to 2nd October, 2018 is to be observed by sensitizing our members and general public reinforcing the belief that "Sanitation is everyone's business".

Due to heavy rainfall in Kerala state, many people have lost all their belonging including houses. They require our help in rehabilitation and providing infrastructure. It is requested to donate liberally for this cause.

At the end, I appeal once again to adopt modern methods of communication such as SMS, Emails, WhatsApp etc. to communicate and highlight the issue of pensioners, and activities of our Association.

Subject : Revision of pension in respect of pensioners of KVS retired prior to 01.01.2016 in respect of 7th CPC.

Sir/Madam,

It is to inform that the Ministry of HRD has granted approval for adoption of 7th CPC to the pensioners of the Kendriya Vidyalaya Sangathan vide letter No.F.3-45/2017-UT-2 dated 13.06.2018 in terms of following OMs of Govt. of India (copy enclosed):

1. OM No.38/37/08-P&PW(A) (i) dated 04.08.2016.
2. OM No.38/37/08-P&PW(A) dated 12.05.2017.
3. OM No.38/37/08-P&PW(A) dated 06.07.2017.

The following modus operandi has to be adopted by the Pension Disbursing Authority i.e. State Bank of India, Parliament Street, New Delhi for revision of pension:

1. In case of pensioners **retired prior to 01.01.2016**, the revised pension/family pension with effect from 01.01.2016 shall be determined by multiplying the pension/family pension, as had been fixed at the time of implementation of 6th Central Pay Commission (CPC) (pension drawn on 31.12.2015) by 2.57 in terms of OM NO.38/37/2016-P&PW(A)(ii) dated 04.08.2016. The amount of revised pension/family pension so arrived so arrived at shall be rounded off to next higher rupee. The revised pension/family pension will be the basic pension/family pension only without the element of additional pension available to the old pensioners/family pensioners on attaining the specified age.
2. The revised pension in accordance with 7th CPC will be applicable with effect from August 2018. The arrears of pension (w.e.f.01.01.2016) will not be paid to pensioners till further instructions from this office.
3. In case of pensioners retired between 01.01.2016 to 31.05.2018, the revised order according to 7th CPC for individual case will be issued by the Kendriya Vidyalaya Sangathan. In such cases also existing pension is to be revised with effect from August 2018 and the arrears of pension for 7th CPC will not be paid till further instructions from this office. It is relevant to mention that with effect from June 2018, The Kendriya Vidyalaya Sangathan is issuing the Pension Payment Orders as per recommendations of 7th CPC.
4. The Dearness rates for all the pensioners drawing pension according to 7th CPC will be paid as mentioned in this office letter of even number dated 05.07.2018 (copy attached).
5. The Govt. of India, Ministry of Personnel, PG & Pensions vide OM NO.4/34/2017-P&PW(D) dated 19.07.2017 has enhanced the amount of Fixed Medical allowance from Rs. 500/- to Rs.1000/- with effect from 01.07.2017. The fixed Medical Allowance (FMA) of Rs.1000/- is to be paid to all the pensioners with effect from August, 2018. The arrears of FMA i.e. from 01.07.2017 to 31.07.2018 will only be paid at the time of payment of arrears of pension in accordance with 7th CPC for which the necessary instructions will be issued by this office.

You are requested to circulate the same among all your CPCC/Pension Payee branches for necessary implementation.

Subject : Manner of disposal of PPO- death of the pensioner with no claimant authorized for family pension in the same PPO.

Attention is invited to this office OM No. CPAO/Tech/Bank Performance/2014-15/511-581 dated 23.09.2014 (copy enclosed) wherein all Heads of the CPPC and Heads of Government Business Department of the Banks were instructed to return both halves of PPO to CPAO where no nominee is authorized for pension on the same PPO so that the family pension could be authorized to other eligible members of the family of the pensioner.

It has been observed that the both halves of the PPOs are not being returned by the CPPCs of the banks which has resulted in a number of court cases for delay in the commencement of family pension to the family pensioner other than the spouse.

It is reiterated that both halves of the PPO may be returned to the CPAO in case there is no nominee authorized for family pension on the same PPO exist as stipulated at per Para 23.3 of the Scheme for payment of Pension to Central Government Civil Pensioners by Authorized Banks (Fourth Edition 3rd December, 2004)

As per Para 23.3 of the Scheme for Payment of Pension to Central Government Civil Pensioners by Authorized Banks (Fourth Edition, 3rd December, 2004) wherein it is clearly stated that "The paying branch will enter the date of death of the pensioner in the disburser's portion of the PPO as well as pensioner's portion and in the register in the form as in Annexure VIII (pg.33). The pensioner's half of PPO will then be returned to the nominee if family pension stands authorized through the same PPO; otherwise it will be returned to the Link Branch/CPPC along with the disburser's half, for onward transmission to the CPAO. The latter will update its record and transmit both halves of the PPO after keeping the necessary note in their records, to the PAO/AG who had issued the PPO for similar action and record."

All the Heads of the CPPC and Heads of Government Business Department of the Banks are requested to adhere to the above guidelines and return both halves of the PPO to the CPAO in order to avoid delay in finalization of family pension cases other than spouse.

Subject: Manner of disposal of PPO- death of the pensioner with no claimant authorized for family pension in the same PPO.

The Central Pension Accounting Office is a nodal agency for administering the Scheme for pension disbursement through public sector banks. It is in continuous process of streamlining and simplifying the pension delivery to the utmost satisfaction of Pensioner's/family pensioner's comfort and convenience. The disbursement of family pension to the "family pensioner other than spouse" like widowed/divorced daughter is one of those areas in which a lot of efforts have been put in to simply and make them effective and efficient.

But it has been observed that a number of court cases and legal cases received in CPAO are mainly related to delay in the commencement of family pension to the family pensioner other than a spouse and arisen due to negligence on the part of the banks in returning the disburser's' and the pensioners' half of the PPO to CPAO if there is no family pensioner stands to be authorized through the same PPO.

Government Orders

In this context, Para 23.3 of "Scheme for Payment of Pensions to Central Government Civil Pensioners through Authorized Banks" provides the manner of disposal of PPOs wherein no claimant exists after the death of pensioner/family pensioner with the stipulation that the disburser's portion as well as pensioner's portion of the PPO is to be returned to CPAO for updation of its record and onward transmission to the PAO/Ag who had issued the PPO for similar action and record.

The non-compliance of these instructions by the banks is resulting increase in receipt of number of court cases and legal cases in CPAO, non-updation of CPAO's and PAO's relevant record, delay in authorization of family pension to the eligible family members for whom a new PPO is to be issued, causing hardship to the claimants, points raised by the Pensioners' Welfare Associations from different platforms including SCOVA meetings.

The Para 6.3.1 of the CPPC Guidelines also stressed upon the strict adherence to the codal provisions of 'Scheme Booklet', CCS (Pension) Rules, Orders, Guidelines on Pension issued by Government of India / Reserve Bank of India from time to time.

Non-compliance of codal provisions by the banks is a very serious lapse on their part. Therefore, it is imperative to instruct the Heads of CPPC of all the banks/Heads of Govt. Business Divisions to take a stock of these cases and send a Review Report within seven days from the receipt of this Office Memorandum followed by returning of both the halves of all such PPOs wherein pensioner/spouse has died and no claimant for family pension has been authorized in the PPO. The matter may be taken on priority as it is under review at the higher level.

This issues with the approval of Chief Controller (Pensions).

Subject : Clarification / medication of the guidelines issued regarding simplification of referral system under CGHS vide OM Z15025/117/2017/DIR/CGHS dated 15/01/2018

With reference to the above mentioned subject the undersigned is directed to draw attention to the guidelines issued vide OM No Z 15025/117/2017/DIR/CGHS date 15/01/2018 under para no (i) and to state that the matter has been reviewed by Competent Authority and it is now decided to modify para (i) in supercession of the earlier guidelines of the above referred to OM as under.

- i) All CGHS beneficiaries (in all CGHS Cities) shall be permitted for seeking OPD consultation from Specialists at Private Hospitals empanelled under CGHS after being referred by any Medical Officer of CGHS Wellness Centre The referral may be mentioned on the computer generated Prescription slip after consultation at empanelled hospital, beneficiary shall report back to concerned Wellness Centre, where MO/CMO would endorse listed investigation / listed treatment procedure and issue medicines as per the guidelines mentioned in the OM dated 15.01.2018. For unlisted investigations/unlisted treatment procedures CMO Incharge shall submit the prescription to Competent Authority for consideration in case of pensioner beneficiaries. Serving employees shall seek permission for unlisted investigation/ unlisted treatment procedure from their department as per prevailing guidelines.

The other terms and conditions of OM NO. Z 15025/117/2017/DIR/CGHS Dated 15/01/2018 shall remain unchanged.

Subject: Grant of Dearness Relief to Central Government pensioners / family pensioners Revised rate effective from 01-07-2018

The undersigned is directed to refer to this Department's OM NO. 42/06/2018 P & PW (G) dated 22.03.2018 on the subject mentioned above and to state that the PResdient is pleased to decide that the Dearness Relief admissible to Central Government pensioners / family pensioners shall be enhanced from the existing rate of 7% to 9% w.e.f. 01.-07.2018.

- 2) These rates of DR will be applicable to (i) Civilian Central Government Pensioners / Family Pensioners including Central Govt. absorbee pensioners in PSU/Autonomous Bodies in respect of whom orders have been issued vide this Department/s OM No. 4/34/2002-P & PW (D) Vol. II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years
 - ii) The Armed Forces Pensioners. Civilian Pensioners paid out of the Defence Service Estimates.
 - iii) All India Service Pensioners.
 - iv) Railway Pensioners / family pensioners.
 - v) Pensioners who are in receipt of provisional pension.
 - vi) The Burma Civilian pensioners / family pensioners and pensioners / families of displaced Government Pensioners from Burma / Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008 – P & PW (B) dated 11.09.2017
- 3) The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 4) Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in this Department's OM No. F. No. 38/88/2008-P & PW (G) dated 9th July, 2009. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.
- 5) In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.
- 6) It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 7) The offices of Accountant General and authorized Pension Disbursing Banks are requested to arrange payment of relief to pensioners etc. on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, II/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL) / 81 dated the 21st May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- 8) IN their application to the pensioners / family pensioners belonging to Indian Audit and Accounts Department, these orders issue after consultation with the C & AG.
- 9) This issues in accordance with Ministry of Finance, Department of Expenditure's OM NO. 1/2/2018-E II (B) dated 7th September 2018.

Minutes of the Meeting of various Pensioners' Associations held with Additional Director CGHS, Pune

- 1) Compliance of the Directions of Honble Supreme Court :** A copy of the guidelines for settlement of medical claims received from Ministry of Health & Family Welfare, New Delhi vide OM No. Z 1502/51/2018/DIR/CGHS/ESH. Dated – 06/06/2018 is enclosed with this minutes of the meeting.
- 2) Denial of service by HCOs :** The members brought to the notice of Additional Director that Shashwat hospital and some other hospitals are charging extra amount of OPD Consultation. The Additional Director informed that such hospitals can be de-empanelled. However it is advised to avoid such hospitals.
The member requested to empanel more hospitals including Ruby Hall Clinic Wanowrie and the Cardiac unit of Ruby Hall Clinic functioning in the campus of YCM Hospital Pimpri.
- 3) Opening of New Wellness Centre at Khadakwasala :** Additional Dierecot informed that the Ministry has not approved the proposal to open a new Wellness Centre at Khadakwasala as it is outside the city limits. The members were requested to take up the matter with the Health Ministry as Khadakwasala is within the limits of PMRDA.
- 4) Appointment of Medical Specialist :** The members requested to appoint medical Specialist and also various other Specialists like Eye Specialist, ENT Specialist, Orthopaedic surgeon.
- 5) Opening of new Lab at Wellness Centre No. 1 :** The Additional Director informed that the Lab will be opened at W.C. NO. 1 once accommodation is ready for the said purpose. Provision of asbestos sheet at waiting space. The members requested to provided waiting shelter for protection from sun and rain. This has been agreed to (Action : C. M.O. incharges W.C. No. 1)
- 6) Late opening of new lab at W.C. No. 6 :** The members complained that the senior Lab Technician posted in W.C. No. 6 is reporting late for duty everyday causing difficulties to the office going employees. The members also requested to post one Lady Medical Officer in W.C. No. 6 The members also complained that most of the staff working in W.C. NO. 1 disappear for hours together. Additional Director assured that necessary remedial action will be taken. (Action : CMO 1/C).
- 7) Issue of 3 months medicines to beneficiaries :** The Additional Director informed the members about the new system of procurement of medicines and the resultant shortage of medicines. The Additional Director assured that medicines will be issued for 2 months to the beneficiaries for Chronic Disease once regular supply resume. However medicines are issued to the beneficiaries going abroad up to 6 months.
- 8) New referral system :** The Additional Director informed the details of new referral system as per the guidelines received from the Ministry. Copy of the O. M. is attached.
- 9) Functioning of Dental unit :** The Additional Director informed that the process of procurement of new Dental Chair will be under taken shortly and the Dental Unit will start functioning fully.
- 10) Functioning of X-Ray unit / sonography unit :** The Additional Director informed that new X-Ray machine has already been received and installation work is under process. Efforts will be made to procure a new USg unit during the current financial year.
- 11) Separate Queue for senior citizens :** The members requested for preference of OPD Consultation to the beneficiaries who are above 80 years of age by providing token number or Separate Queue. The Additional Director informed that the possibility providing preference to such beneficiaries will be looked into.
- 12) Local purchase of medicines :** The members complained that a number of substitute medicines are supplied by the local chemists. The Additional Director informed that all the CMO incharges have been requested not to accept any substitute medicines in future.
- 13) Issue of plastic cards :** The Additional Director informed that now-a-days there is no delay in getting plastic cards. Normally the cards are received within a period of 3 months. The members complained that certain cards which does not belong to W.C. NO. – 1 are kept in W.C. No. 1 instead of returning to office of the Additional Director. (Action : CMO I/c)
- 14) Over crowding in wellness centres :** The members requested to increase the working hours of C.G.H.S. Wellness Centres in order to avoid of over crowding. The Additional Director informed that as the network system gets disconnected at 2 pm, the working hours of the W.C. cannot be extended. However the C.M.O. incharges have been requested to open an additional dispensing counter to avoid Queue. (Action ; CMO I/c)

- 15) **Provision of inverter** : The Additional Director assured that inverter will be provided wherever it is not available.
- 16) **Extension of empanelment** : The Additional Director informed that this will be done as soon as the instructions are received from the Health Ministry.
- 17) **Hospital visit by C.G.H.S. medical officers** : The Additional Director informed that the medical officers of C.G.H.S. regularly visit C.G.H.S empanelled HCOs especially to verify the genuineness of prolonged stay. The meeting was concluded with a vote of thanks.

- 1. Status of the Revision of Pension/Family pension** in accordance with DOP&PW Order dated 12th May, 2017. DAP had already instructed to Shri Sanjay kumar to work on the issues cases forwarded by us along with the agenda of the meeting. They informed the settlement of following cases. Shri N. G. Bhawte, Gondia, PPO No. P-51547, Rajaram M More, P-44964, Shri M. M. Upakare PPO No. P-54056 , Sou. Rajani Shivram Sohani, Sangli, P-50115, Smt. Urmila R. Kirve, retired on 27.09.2001, PPO No. P-26883, Smt. J. R. Kulkarni, P-28263, Shri S. V. Bamane, P-62152, Shri P. R. Deshpande, P-47049. Shri Pralhad Rajaram Sawant, Miraj P-52746, Smt. Anjali B. Kulkarni, retired on 19.09.2014, PPO No. P-78056, Smt. Anjali S. Belhe, retired on 05.01.2015 PPO P-79090 , Shri C. G. Keskar, Postal pensioner retired on 31.05.2008 from Maharashtra Circle and receiving pension at Belgavi HO under Karnataka Circle. PPO No. P-12927/LPS/BG; TRF No. 4959

DAP informed that out of 35500(approx.) postal pensioners in Maharashtra and Goa Circle, DAP issued revised PPOs in respect of 32000 pensioners. Difference may be due to non receipt of ANNEXURE-I from offices of SSPs.

About non receipt of copies of pensioner's Copy of revised PPO, DAP mentioned that the copies will be sent as soon as, they receive the complaint/email showing the correct address by the pensioner for non receipt of copy of revised PPO.

We have submitted the further list of 33 Pensioners(handed over to us by Pune branch) who did not receive the revised PPOs.

2. Cases returned back on account of discrepancies.

It is confirmed by DAP that some HPOs are returning back the revised PPOs. Mostly these cases are related with revision of Pre-2006 pensioners in view of DOP&PW OM No. 38/37/08-P&PW(A) Dated 6th April 2016 on delinking pension from qualifying service of 33 years. DAP assured that separate orders will be issued for revision from 01.01.2006 in such cases.

3. Delay in endorsing/forwarding the revised PPOs of DOT/BSNL pensioners :

DAP called the concerned officer and instructed him to forward such cases within week's time.

4. Functioning DAP Nagpur as PDA

DAP informed that In respect of some HPOs the sanctions are received from them are checked and the payment of monthly pension is credited directly through GPO Nagpur. DAP is not authorized Pension distributing Authority as yet.

5. Holding of Pension Adalat by DAP.

3) OM No. BSNL / Admn./15-22/14 dated 25th April 2018.

Medical Allowance without voucher facility, in lieu of reimbursement of outdoor medical claims with voucher, for retired employees was revived vide this office OM of even no. dated 11th April 2017. While extending the facility it was decided that the decision will be reviewed after six months.

2. The issue was reviewed, there has been an increase in expenditure on this account. As a measure to control the expenditure and continue the facility it is decided to reduce quantum of allowance from 50% to 25% of the annual ceiling w.e.f. 01.04.2018, subject to a minimum allowance (without voucher) payable would be Rs. 12,000/- per annum payable in four equal quarterly instalments. Retired employees can continue to opt this facility or switch over to reimbursement of outdoor claims with voucher facility. The option can be exercised in the beginning of the financial year and cannot be changed during that financial year. Retired employees who have not sought any outdoor claim with vouchers during the financial year can exercise the option.

3. This issues with the approval of the Competent Authority.

■ Status of 3rd PRC

BSNL Corporate office vide F. No. BSNL/38-1/SR/2016 dated 28.06.2018 Constituted a Joint Wage Revision Committee comprising of Five members from Official side and Five Staff side members to recommend wage structure for Non-Executive employees w.e.f 01.01.2017.

The Staff Side of the Committee wrote a letter on 8th August, 2018 to the Chairman of the Committee and suggested

1. Mortification factor as 2.44
2. Minimum of the Revised Scale of Pay in respect of NE 1 as 19590.
3. Increment rate @ 3%

The 3rd Meeting of the Joint Committee on Wage Revision of the Non-Executives took place on 27-08-2018 under the chairmanship of Shri H. C. Pant. Management Side proposed

1. Minimum of the new pay scales may be arrived at, by multiplying the minimum of the existing pay scales by 2.4.
2. Accordingly, minimum of the revised NE 1 pay scale as RS.18,600.

However, the Staff Side did not accept this. They demanded that the multiplication factor should be 2.44. Accordingly, the minimum of the new NE-1 pay scale comes to Rs.18,934 and that it should be rounded off to Rs.19,000.

The Management Side agreed to examine these proposals of the Staff Side.

As regards the maximum of the new pay scales, proposed by Staff Side by providing 43 years of span, the Management Side stated that this would result in heavy expenditure on account of payment of Pension Contribution.

Committee met on 14-09-2018. The Pay Scales proposed by management have been accepted by the Staff Side. The next meeting will be held on 28-09-2018.

- b) Quarterly Informal meetings at regional and divisional level are not granted to our Branch secretaries by most of the PMGs/SSPs in accordance with your letter No. O&M/AICGPA/2013 dated 31.12.2013.
- c) There is abnormal delay in endorsing/forwarding the IDA order received from CCA, Mumbai resulting delay in payment by the HPOs. We have received the complaints from BSNL pensioners, that they have not received the revised IDA due from April and July, 2018. CCA Mumbai informed that they have issued the order for July, 2018 and the copy of the order was sent to your office by speed post on 17th July, 2018. Again on request from your office, the copy is sent through email on 22nd July 2018. It need to be checked what happened with the copies if received in CPMG's Office.

We had brought, into your notice, the issue of abnormal delay in payment of Medical Bills/Medical Allowance to Retired employees of BSNL vide our letter No. AICGPA/BSNL/Medical/59 Dated 06th December, 2017, further reminder Dated 05th May, 2018. Your office responded vide letter under reference, that the retired employees of the circle have been paid three installments of medical allowance. But this is not in line with the feedback we receive from the Branch Secretaries/retired employees spread over in Maharashtra Circle.

For Example:

1. Medical Bills for the outdoor medical expenses forwarded by Aurangabad SSA are not paid since October, 2017. This may be the position in all over.
2. Nashik SSA informed to our representatives that required data in respect of ret'd. employees (except 6 cases) have been completed. But most of the pensioners who opted did not receive the any installment.
3. Shri M. R. Kaulkar, ret'd JTO from Yevatmal intimated, that he is informed by SSA that his data was in error. The corrected data is sent in July, 2018 only. Shri A. M. Burkule also complained that he did not receive the payment as yet.
4. Organizing Secretary is informed by SSA Kolhapur that vendor creation is held up due to error in respect of 70 employees. Secondly near about 250 pensioners have not received any installment of medical allowance.
5. Branch Secretary, Nanded branch intimated that retired employees who opted have not received medical allowance as yet. The list is enclosed herewith.

Sir, We therefore request you to look into the SSA wise..... STATUS of

- i) retired employees who opted for medical allowance for the year 2017-18,
