GS Speaks:

It is learnt that the Government is seriously thinking of granting notional increment to those, who completed one year of service and retired one day before their increment was due. 29 Officers retired on 30th June, from Intelligence Bureau approached CAT, Principal Bench, New Delhi demanding notional increment wef 01st July. Hon'ble CAT on 28/04/2023 disposed OA 1554/2020 with direction to grant notional increment to the applicants with effect from 01/07/2021.

The Meeting with pensioners Associations was held under the chairmanship of Shri V. Srinivas, Secretary (Pension) on 24th May, 2023 for seeking feedback on family pension and Commutation of pension. In the reply of our query regarding demand of restoration of commuted portion of pension after 12 years instead of 15 years it is advised to wait for the recommendations of 8th CPC which is not yet decided.

DOP&PW conducted the meeting on Nation Wide Campain of DLC at 100 cities with Chief of Nationalized Banks and Identified Pensioners Association in Pune under the chairmanship of Shri Sanjiv Narain Mathur, Addl. Secretary on 1st June, 2023. In Maharashtra DLC Camps will be arranged at Aurangabad, Jalgaon, Kolhapur, Mumbai, Navi Mumbai, Nagpur, Nashik, Pune and Sangli in the month of November.

Preliminary Meeting(VC) with Mrs Shraddha V. Gokarn, ADPSR and Shri Ramchandran Sr.AO O/O CPMG, Maharashtra Circle was held on 13th June, 2023 at 11am to discuss the pending issues in respect of postal pensioners. The record of discussions is printed on page 25.

Department of Post issued the orders dated 19/04/2023 for migration of DOT/BSNL pensioners receiving pension from Post Offices. The migration would start from May-2023 and SMS regarding migration will be sent to the pensioner on his registered moble. Detailed procedure is explained in this Bulletin.

Finally CGHS has met the demand of Pensioners Associations/Empanelled private hospitals and revised the of empanelled private hospitals for consultation, rent and ICU charges with effect from 12/4/2023 and 36 Radiological/Imaging investigations with effect from 19/06/2023. The Rate revision of surgical procedures is also under consideration.

During the meeting on 17th May, 2023, Shri Rohit Sharma CGM, Maharashtra Circle informed that 90% of medical bills are posted and the payment will be made by Corporate office. Good number of Medical Bills as well as Medical Allowance have been paid on 31st March and 31st May, 2023.

In view of the unwarranted and unjustified delay in submission of Revised proposal of pension revision of BSNL/ MTNL absorbed retired employees of 15% fitment, Joint Forum of BSNL/MTNL pensioners Association issued the Notice for Agitation programme.

Important News on National Pension Scheme (NPS)

On 27th March, 2023 While moving the Finance Bill 2023 for consideration and passage in the Lok Sabha, Hon'ble Finance Minister Mrs. Nirmala Sitharaman said the new approach to the NPS will be designed for adoption by both central and state governments.

"I propose to set up a committee under the finance secretary to look into the issue of pensions and evolve an approach which addresses the needs of employees while maintaining fiscal prudence to protect common citizens," she said.

The approach will be designed for adoption by both the central government and state governments."

Letter issued for Setting up a committee

OM.No. 1(14/E-V/2023, Dated : 06th April 2023, From Ministry of Finance, Department of Expenditure, Government of India, New Delhi

Subject : Setting up of a committee to review the Pension System for Government Employees.

The undersigned is directed to invite attention to the announcement made by the Finance Minister in Lok Sabha on 24.3.2023 to, inter-alia, set up a committee under the Finance Secretary to look into the issue of pensions under the National Pension System in respect of Government employees and evelve an approach which addresses the needs of the employees while maintaining fiscal prudence to protect the common citizens.

2. Accordingly, it has been decided to set up a committee as under :

i) Finance Secretary & Secretary (Expenditure)	-	Chairman
ii) Secretary, Department of Personnel &		
Training Ministry of Personnel, Public Grievance & Pension	-	Member
iii) Special Secretary (Pers), Department of Expenditure		
Ministry of Finance	-	Member
iv) Chairman, Pension Fund Regulatory & Development		
Authority (PFRDA)	-	Member

3. The Terms of Referece of the Committee shall be as under :

i) Whether in the light of the existing framework and structure of the National Pension System, as applicable to Government employees, any changes therein are warranted;

ii) If so, to suggest such measures as are approprite to modify the same with a view to improving upon the pensionary benefits of Government employees covered under the National Pension System, keeping in view the fiscal implications and impact on overall budgetary space, so that fiscal prudence is maintained to protect the common citizens.

4. The committee may also co-opt any officer of the Central Government as part of its deliberations, whenever such a need is felt by the committee.

5. The committee shall devise its won procedure and mechanism, including consultation with states etc, to arrive at its recommendations.

6. Department of Expenditure (Personnel Division) will provide Secretarial assistance to the committee.

Subject : Migration of DoT Pensioners drawing pension from Post offices to 'SAMPANN'.

I am directed to say that Department of Telecommunication (DoT) has decided to migrate the DoT pensioners/family pensioners drawing pension from Post Offices to SAMPANN. In this regard, approval of Competent Authority is hereby conveyed to migrate all telecom pensioners in all the circles currently drawing pension from Post offices to "SAMPANN" starting from the month of May 2023 onwards. In order to smooth migration of these pensioners/family pensioners from DoP to DoT (CCAs) roles and responsibility of each office in DoP as well as timeline, are hereby assigned for strict compliance in a time bound manner: –

- 1. Role and Responsibility of CEPT.
- i. The Circle wise list of telecom pensioners/family pensioners to be migrated will be provided by DoP on receipt from DoT/CGCA in the 1st week of the month.
- ii. CEPT should verify and ensure that the list of pensioner's ID's as per list supplied, has been freezed in CSI. Any disbursement if found, should be stopped by CEPT while communicating it to the concerned DDO that this payment authorization has been withdrawn and no payment should be made to those pensioners from the month as agreed upon.
- 2. Role and Responsibility of DDOs/Head Post Offices: -
- i. Ensure that no pension is disbursed to DoT pensioner's/family pensioners as shown in the list provided by the PAO and credited to their PO SB Account by Head Post Office's under Department of Posts.
- ii. All DoT pensioner's/family pensioner's id's as shown in the list should be freezed /closed in CSI.
- iii. All disbursers half of PPOs along with relevant documents are compiled viz, recovery schedule, life certificate detail/non marriage, Income Tax etc. are sent to Postal Accounts offices (PAOs) along with a certificate that no further payment of pension will be made by his office by 20th of the Month.
- iv. Suitable note of transfer should be made in the register of Pension payment order maintained in his office and ensure that no futyre payment of pension in respect of the pensioners/PPOs migrated will be made after migration.
- v. In case of any disbursement/credit wrongly happened, entry should be reversed and equa amount, debited from their PO SB Account
- 3. Role and Responsibility of Postal Accounts Offices.
- i. To receive al disbursers half of PPOs ang other documents from DDOs/HPOs concerned as per the list which will be provided by the DoP in the 1st week of the month.
- ii. Suitable entries be made in the Pension Index/check registers and forward the list along with disbursers half of PPO an documents to the respective CCAs (Controller of Communication Accounts) by 24th of the Month.
- iii. Ensure that there should be no booking on account of Telecom pension under head of account except or otherwise as per point (i) above. In case, any booking is detected after migration, the same should be got reversed from the DDOs concerned immediately.
- iv. Ensure that the outstanding commission on payment of DoT pension/family pension is calculated and raised to respective O/o Controller of Communication Accounts and realized.
- v. PAOs will ensure to submit pension stoppage confirmation to this directorate by 24th of the Month through email id peasection.pa[at]indiapost.gov.in followed by post.
- 4. Following the migration, the pension of migrated telecom pensioner's/family pensioners would be paid directly by the Department of Telecom to these pensioners from the month of migration as per the list provided by DoT to DoP from time to time.

I am directed to convey the revision of the charges for Consultation fee, Intensive Care Unit and Room rent reimbursable in respect of treatment rendered to CGHS beneficiaries in all HCOs empanelled under CGHS. The revised rates in respect for the aforementioned items arc as under:

a) Consultation fee -

OPD Consultation Rs. 350 / IPD Consultation Rs. 350/

(For both NABH and Non-NABH accredited HCOs)

b) ICU Charges

Rs 5400/- for all categories of ward entitlement Room Rent (General Ward/Semi-private ward /Private ward) General ward (For non-NABH accredited hospitals the charges shall be 15% less) ICU charges are inclusive of Room Rent.

c) Room Rent.

General Ward - Rs.1500/-

Semi-private ward Rs.3000/-

However, due to financial situation of the company during last few years, the hospitals have apparently stopped providing credit facility to BSNL employees. It has been also reported that leading hospitals are not willing to provide services in view of outstanding dues of the past years.

2. With the commitment to provide better healthcare facilities to the employees, measures have being taken by BSNL Co to clear outstanding dues of the hospitals. Now, it is of paramount importance that BSNL teams in circles/SSAs/BAs take lead and pursure with take lead and pursure with sales team/representatives of the hospitals in their locality to maximize number of empaneled hospitals under BSNL MRS. The aim should be to empanel at least one reputed hospital in every BA on cashless/credit Facility basis.

3. Futher, the process of invoice processing and payment to hospitals providing credit facility should be streamlined to ensure timely payments, preferably in three months' time so that the hospitals continue to provide uninterrupted cashless healthcare facilities to BSNL employees.

JOINT FORUM MEETING HELD VIRTUALLY ON 13-05-2023.

A meeting of the Joint Forum of BSNL-MTNL Pensioners Associations was held virtually on 13-05-2023.

Com.D D Mistry , General Secretary, BDPA(I) presided over the meeting.

Com.K G Jayaraj, General Secretary, AIBDPA welcomed all and briefed on the circumstances under which the meeting is convened.

Coms. H F Chaudhari, General Secretary, AICGPA HQ Pune, V A N Namboodiri Advisor, AIBDPA, G L Jogi, General Secretary SNPWA, Dinesh Sharma, Vice President, SNPWA and D D Mistry actively participated in the discussion that followed.

The meeting finally decided to write to the MOC expressing strong protest against the undue and unjustified delay in processing the pension revision at DoT level and seeking his immediate intervention.

It was also decided to hold another meeting of the Joint Forum on 27-05-2023 to review the progress, if any, and to take appropriate decision on the issue.

14 reprentatives of the 8 constituent organisations participated in the meeting.

JOINT FORUM MEETING (VIRTUAL) HELD ON 15-06-2023

The meeting of the Joint Forum was held virtually on 15-06-2023.

15 representatives of the eight constituent associations participated in the meeting. Com. VAN Namboodiri, Advisor, AIBDPA presided. Com.K G Jayaraj General Secretary AIBDPA welcomed all the participants and narrated the circumstances under which the meeting is being held. There has been no significant progress on the burning issue of pension revision since we met the Member (F) and Member (S) on 21-03-2023.

The crucial meeting with the MOC by the Secretary DoT, Member(F) and Member (S) which was to be held in the first week of April,2023 has not yet taken place. So the file is held up with the Secretary DoT for the last 4 months indefinitely.

So we have to think about for a program of action seriously against the most unjustified and unwarranted delay. Com. V A N Namboodiri made the initial remarks. Coms. G L Jogi General Secretary SNPWA, D D Mistry, General Secretary, BDPA(I),

H F Chaudhari General Secretary, AICGPA HQ Pune, M R Das President, AIBDPA, R K Mudgil, General Secretary, MREWA, Rajender Prasad, General Secretary, MESA, D C Sharma, Vice President, SNPWA spoke and wanted to launch Agitational Program against the sheer neglect of the administration in settling our most important and burning issue of pension revision and presented various proposals.

Finally the Joint Forum decided to conduct the following three phased agitational program which was addressed to Minister of Communication as follows -

Subject : Notice for the three phased agitational program against the unwarranted and unjustified delay, based on completely misleading, false, fabricated and baseless grounds advocated by DOT Bureaucracy, in settlement of pension revision of BSNL/MTNL Pensioners due from 01-01-2017. Apathy and unprecedented insensitivity of DOT towards BSNL/MTNL Pensioners has crossed all the limits.

Sir,

We are constrained to inform you that the meeting of the Joint Forum of BSNL-MTNL Pensioners Associations held on 15-06-2023, after reviewing the present status of pension revision, and false and misleading narratives propagated by DOT enumerated below, to deny our legitimate demand of Pension Revision, has decided to launch a three phased agitational program under most compelling circumstances.

The Joint Forum of BSNL/MTNL Pensioners Associations consisting 8 BSNL and MTNL Pensioners Associations, has exhausted all rational means to impress and convince DOT bureaucrats on basis of

irrefutable facts to settle most burning and crucial issue of pension revision amicably through discussion/ negotiation. But, Sir, the negative and perverse approach of DoT, rather willful attempts to defeat the settlement of the issue of 5 lakh Pensioners of BSNL/ MTNL pending for the last seven years during which thousands and thousands of Pensioners died without getting their Pension Revision simply due to ruthless, merciless and pathetic attitude 0f DoT.

On 17th October, 2022, Dr. Mahesh Shukla, then Member (Services) emphatically informed 17 Associations of BSNL/ MTNL Pensioners that finally Pension Revision has been delinked from Wage Revision. And his offer of zero percent fitment was stoutly rejected by all the Pensioners Associations in one voice. At last the Member (Services) had assured a revised fitment proposal will be mooted in consultation with Secretary DoT and Hon'ble MOC. Thereafter it took about four months to calculate the financial implications of 5, 10 and 15% fitments.

When the Joint Forum representatives met Shri. Uma Shankar Pandey, Member (S) on 21- 03 -2023, we were told that all the internal consultations are over and final decision on fitment will be taken in the meeting with the Hon'ble Minister of Communications which is expected to be held in the first week of 2023.

Hon Sir four false, misleading and fabricated grounds advocated by DOT to defeat our legitimate demand of 15% fitment for Pension Revision in accordance to recommendations of 3rd PRC are mentioned below.

A. First fallacious and misleading narrative being widely propagated is that Pensioners of BSNL/ MTNL are drawing already Pension more in IDA scales than their counterparts in Central Govt in CDA scales. This is quite natural since IDA scales formulated by DPE and approved by the Union Cabinet for CPSUs are much higher than CDA scales. We obediently and in disciplined manner took absorption in BSNL/ MTNL in IDA scales, based on the decision and concrete assurance of the Union Cabinet in the year 2000, not of our volition, that we will be fully treated at par with Central Govt. Employees and that our Pension would be paid by the Govt. in terms of then 1972 CCS Pension Rules. So why this baseless narrative is being propagated all over to mislead everyone, including your Hon Self that we are drawing Pension more than Central Govt Pensioners which is obvious based on above stated facts.

B. Second baseless and untenable narrative being propagated is that huge financial implications will accrue on the Govt. by extending 15% fitment for our Pension Revision. Where and on what basis does question of financial implications arise for the Govt. since all through we have paid Pension Contribution on the maximum of IDA scales and this contribution is three times more than the Pension Contribution paid by Central Govt Employees on their actual CDA scales(not on maximum). Other liabilities that BSNL/MTNL may have are for different reasons. How and on what basis these liabilities are linked to our Pension Revision when we have met this liability on the Govt. in its totality.

C. The extent to which DOT can go to mislead can be easily concluded from the fact that they falsely misled everyone, including your Hon Self, that by extending 0% fitment, Pension Increase for everyone would be around 10%. Hon Sir, based on hard facts, by giving 0% fitment, hardly 1 to 2 % of Pensionets get any increase and out of the remaining 98%, some may get paltry increase, and a good number may draw minus. Based on this fact (that 1 to 2 % of Pensioners who are at beginning of their scales), DOT misled everyone, including your Hon Self by building a totally false narrative that everyone will get an increase of about 10% by extending 0% fitment. This unambiguously and without any doubt fully establishes the intentions of DOT that it can go to any extent to deny us our legitimate 15% fitment. We are astonished as to how can they muster courage to misled even your Hon Self by propagating that 0% fitment gives 10% increase in Pension to all the Pensioners.

The Hon'ble Minister of Communications had also assured to the various delegations that pension revision will be settled with reasonable fitment very soon.

As you are aware, this issue is pending unresolved for about 78 months. Another three months have passed and nothing worthwhile has happened. It is nothing but sheer negligence and cruelty towards the senior pensioners. So the BSNL/ MTNL pensioners have become restive and distressed against the unjustied and wilful delay in settling the issue. In these circumstances we are compelled to resort to agitational path. We hereby give notice for three phased program of struggle.

DEMAND. Pension revision of BSNL/ MTNL absorbed Pensioners from 01-01-2017 with 15% fitment as per 3rd PRC, delinking wage revision.

Fixed Medical Allowance was introduced with effect from 01/12/1997 vide DOP&W vide OM No. 45/57/97-P&PW(C) dated 19/12/1997. Shri H. S. Dixit residing in NON-CGHS area, was authorised FMA by Pension Distributing Authority(PDA) ie. Syndicate Bank after obtaining the required Undertaking, as provided vide para 4 of the order mentioned above.

CPPC Syndicate Bank vide a letter dated 30-11-2017 to the pensioner intimated that CPAO, New Delhi, vide Audit Report dated 14/06/2017 mentioned that Payment of FMA is to be made, if Special Seal authority issued by the CPAO. The copy of the letter is enclosed herewith for ready reference. CPPC Syndicate Bank stopped FMA from July, 2017 and recovered Rs. 27,200 from SB Account of pensioner on 05-01-2018.

Sir, Fixed Medical Allowance was authorised and paid to the pensioner by Syndicate Bank(PDA) as per the provisions of DOP&PW order dated 19/12/1997, hence stopping of FMA and recovery of FMA already paid, at no fault attributable to the pensioner, is not desirable.

Sir, We hereby request you to look into the matter personally and arrange to refund the amount recovered from the pensioner on account of observation of Auditor and also pay Medical Allowance for intervening period.

CPMG Karnataka Circle vide Order No. AP/16-1/Pensioners/DR dated 05.04,2023 directed to the subordinate offices to process disbursement of DR arrears to pensioners through off Cycle.

It is also intimated that counting of induction training/grant of financial upgradation under TBOP/BCR being administrative matter related with the fixation of pay and drawal of arrears. As such Commuted pension of Rs. 4070/- is due to be restored with effect from 1/4/2022 on completion of 15 years. Bank of Baroda did not restore the due commuted pension and his pension Accounts is migrated from Bank of Baroda in the month of July-2022. He registered his grievance vide Ticket no. 2023030555128.

We received one more such case detailed as follows :

Smt Vrishali V. Bhade migrated from State Bank of India. Her PPO No. is 402007021205545. As per original PPO issued, she had commuted Rs. 1778/- on 1/8/2007 which is due for restoration from 1/08/2022.

As Arrears have not been received as yet, Family pensioner applied in Pension Adalat in March, 2023, The case is not resolved.

We addressed to the grievance Chief Manager, CPPC, State Bank of India, Belapur, Navi Mumbai, who replied that the issue is pending with Telecom Department as they have to send us the corrected revised PPO. We are following up with them.

Subject : Provision of CGHS facilities at District Headquarters through Empanelment of private Hospitals in non-CGHS area.

Respected Sir,

At present Government provide the medical facilities to the pensioners as follows. CGHS facilities are available in Metros and large Cities only. Pensioners residing in the area of these cities can get registered under CGHS Wellness Centre after making payment of requisite subscription and avail both OPD and IPD facilities.

Pensioners who are residing in areas not covered under the CGHS are entitled for getting Fixed Medical Allowance of Rs.1000/- per month in lieu of Outdoor Medical treatment(OPD).

- i. They can avail Fixed Medical Allowance of Rs. 1000/- per month.
- ii. They can also avail CGHS benefits(IPD and OPD) by registering for CGHS in the nearest City after paying the requisite subscription.
- iii. They also have the option to avail CGHS facility of IPD treatment after paying the requisite subscription and avail Fixed Medical Allowance for OPD treatment.

On the Other hand

A large number of Pensioners are residing at District headquarters and villages having no excess to CGHS facilities. Good/Multispecialty hospitals are available at District Headquarters. We have been demanding, since year 2019, to extend the CGHS facilities at the District Headquarters to cover the pensioners residing at District Headquarters and nearby villages.

Parliamentary Standing Committee on personnel, Public grievances, Law and Justice(Report No. 120) is also in agreement with the views of Pensioners Associations that Government may explore opening of CGHS Wellness Centres at District Headquarters.

Secondly, Sanctioning the Wellness Centre at District Headquarter, Search and approval for the suitable accommodation, appointment of Medical Officer and paramedical Staff is a lengthy and cumbersome process. For example CGHS Wellness Centre at Aurangabad(District Maharashtra) was sanctioned vide DOH&FW letter dated 6th April, 2021 but CGHS Wellness Centre could be opened only on 24th March, 2023 ie it took two years to open.

Also, the following Issues are faced after opening the CGHS Wellness Centers:

- a) CGHS Authorities are facing the Shortage of Medical Officers and paramedical Staff.
- b) Medicines prescribed by CMO are not available on the day of consultation and pensioners require to visit second/third time to collect the medicines.
- c) Pensioners are required to travel distance of 7-10 kms to reach the designated CGHS Wellness Centre **Suggestion/Demand**

In view of the above, we suggest to review the policy of opening CGHS Wellness Centers at all District Headquarters and approve only Empanelled Private Hospitals for providing IPD facility to the Pensioners. Zonal Additional Directors will be sufficient to control the empanelled private hospitals.

Under such arrangement, Large number of pensioners residing at District Headquarters and nearby villages will have the option to avail CGHS facility of IPD treatment only after paying the requisite subscription and also avail Fixed Medical Allowance for OPD treatment(As available under **Para iii** above)).

Secondly Government may also satisfy the demand of pensioners Associations of providing Medical facilities to pensioners at District Headquarters/villages.

Sir, We here request your honor to review the polity and accept our suggestion so that most of the pensioners residing in District Headquarters and villages will be satisfied in respect of medical facilities.

A Reply in Line shall be obliged.

Regarding - Provision of CGHS Facilities at District Headquarters through empanelment of Private Hospitals in Non-CGHS areas We have received the reply from Directorate of CGHS as follow -F.No. S-11011/13/2023/CGHS(HEC), Dated : 16th June 2023 From Directed General CGHS, New Delhi addressed to H. F. Chadhari, General Secratary. AICGPA, HQ Pune.

Subject : Provision of CGHS facilities at district headquarters through empanelment of Private Hospitals in Non - CGHS areas.

Reference No. AICGPA/CGHS/2023-24/13. Dated 28.4.2023 and No. BPS/SG/CGHS/023/04 Dated 17.5.2023

With reference to the above subject, the undersigned is directed to clarify that, as a matter of policy and norms followed, CGHS does not consider empanelment of private hospitals in non-CGHS areas. CGHS pensioner beneficiaries residing in non CGHS areas have the option to avail treatment from any Government Institution and claim reimbursement later. In addition, they have option to avail treatment under emergency, even from non - empanelled hospitals under emergency and the claims are considered as per approved CGHS rates.

Respected Sir,

With reference to VC Meeting with Identified Pensioners Associations under your Chairmanship held on 24th May, 2023, we would like to submit the following suggestions for consideration please.

A. Family Pension:

1. On the death of the Government servant/ Pensioner the claimant is required to apply in Form-10. As per the List of documents to be submitted with Form 10, the proof of relationship with the deceased/missing Government servant/pensioner is required.

It is observed that even after submission of, Affidavit of No other Income, Affidavit of Family details indicating NOC from other members, PAN card, School leaving Certificate and Wedding Invitation Card etc Head of Offices/Pension Authorizing Authorities are asking to submit the documents showing the relationship. This result in abnormal delay in authorization of 2nd stage Family pension.

It is suggested that the DOP&PW may specify the documents as proof of relationship with the deceased/missing Government servant/pensioner. So that claimant will submit the required document at first instant along with Form-10 to avoid the delay in further communications.

2. On the death of the Government servant/ Pensioner a Family pension is payable to

(i) Widow or widower, up to the date of death or re-marriage, whichever is earlier;

(ii) Son / Daughter (including widowed daughter), up to the date of his/ her marriage/ re-marriage or till the date he/ she starts earning or till the age of 25 years, whichever is the earliest.

Unfortunately, if the Government Servant/Pensioner is survived by a Transgender who is wholly dependent on him/her, there is no provision for payment of family pension today.

It is suggested that the provision of Transgender may be inserted in the Definition of Family under Family pension Scheme.

B. Commutation of Pension;

In view of the demand of Pensioners Associations, 5th CPC, in para 136.10 recommended that the commutation value in respect of employees superannuating at the age of 60 years and commuting a portion of pension within a period of one year, would be equal to 9.81 years' (purchase). After adding thereto a further period of two years for recovery of interest, it would be reasonable to restore the commuted portion of the pension after 12 years, instead of 15 years as at present.

Government is not considering the recommendations/demand of pensioners Association even though the rates of Interest have been drastically reduced over the years.

Gujarat State Government has orderd the restoaration of Commuted pension after 13 years.

Pensioners Associations are hopeful Central Government should accept the Demand of Restoration of Commuted portion of pension after 12 years.

We wish to bring into your notice the feedback received from the pensioners and some suggestions.

1. Details shown in SMS on credit of Monthly Pension

The details shown in the SMS, sent to the pensioners, are not placed in the order resulting confusion. We here by suggest the order of details for easy understanding of the pensioners.

Dear sir/Madam, In respect of your PPO number ending......, for the month of

Basic pension...... Addl. Pension total Pension......

Add Dearness relief, Less commuted pension......

Add FMA Add Arrears......

Total Pension plus FMA.....

Less - Income Tax deducted including Cess......

Less - Recovery if any

Net Pension Rs. has been credited in your S/B account ending..... on

2. Life Certificate :

Before migration to SAMPANN, the pensioners used to submit Manual/Digital life certificate in the bank branch/ post office, where from they were distributed monthly pension. They were also aware that they are required to submit life certificate in the month of November every year.

On migration to SAMPANN, the pensioners are required to submit life certificate to the office of CCA, available at State Headquater/Zonal Office.

No arrangement for submission of life certificate is made at the CSC counter by BSNL BA/SSA as ordered by DOT. Moreover DOT has staggered the due dates for submission of life certificates depending on first payment received from DOT.

Majority of the pensioners are belonging to group C and D category and family pensioners spread over in rural area also. They are not conversant to english and not handy with android mobile. Pensioners are required to submit digital life certificate at nearest cyber cafe or camp arranged by the pensioners association.

In view of the above, pensioners/family pensioners are facing difficulties to submit the digital life certificate on due date resulting stoppage of pension.

It is suggested that outreach program may be arranged at district level explaining the facilities available in SAMPANN and submission of digital life certificate. A brochure explaining the facilities available in SAMPANN and procedure may also be distributed at the program.
