Let me share with you the latest Activities/developments in brief.

Talegaon Branch in its Extra- Ordinary General Body meeting held on 17<sup>th</sup> January, 2018, resolved unanimously to get merged with Pimpri Chinchwad branch for the better service to the members.

Dadar Mumbai Branch has been renewed and new Executive body is elected in the Extra-ordinary General Body meeting held at GPO Mumbai, on 3<sup>rd</sup> March, 2018, We wish all the best to the new office bearers for functioning and reaching the leftout pensioners/family pensioners.

DOP&PW had conducted 'Awareness Programme on Pensioners Portal' on 15<sup>th</sup> January, 2018 at Mumbai, for the Pensioners in and around Mumbai. I am thankful to the Branch Secretaries Mulund, Thane, Dombivli, Kalyan and Vasai for participation in good number in the programme, on a short notice and made it successful.

As you know, in respect of DOT pensioners, the work of revision of pension in accordance with 7<sup>th</sup> CPC has been almost completed by the concerned CCA/DOT as on 28.02.2018. The residual cases are done as and when the record is available. Pensioners, who did not receive the revised orders as yet, may approach us/CCA directly.

Good News for IITM Pensioners: The revision of pension of Pre-2016 pensioners has been approved by the administration and revised pension for the month of March will be paid in April, 2018.

While welcoming Shri S. K. Pande, joined recently as DAP Nagpur, we have addressed both the issues to expedite the revision of pension of Pre-2016, Postal pensioners as per 7<sup>th</sup> CPC and to expedite the work of endorsing the authorities issued by CCA, Mumbai in respect of DOT/BSNL pensioners.

It is informed by Sr. AO, that Out of total 36000 Postal pensioners (Approx), DAP office received the required Annexures in respect of 31000 pensioners, Out of which DAP has issued the revised orders in respect of 29300 pensioners upto 28th March, 2018. it is informed by the PAO Bangalore that there were about 15600 pre-2016 cases due for revision and out of that the revision work in respect of 12600 cases has been finalized. In respect of remaining 3000 cases, the annexures are yet to be received from the divisional heads/field units.


Pension Adalat for DOT/BSNL pensioners was held at Kolhapur on 09.03.2018, CCA in her inaugural speech, declared that the Centralized Payment Management System(CPMS) for the payment of all DOT/ BSNL pensioners may be introduced in near future. Secondly, CCA received the approval for opening the office of CCA for South Maharashtra and Goa at Kolhapur.

As per feedback from Secretaries, Medical Reimbursement Bills/Medical allowance due to BSNL pensioners, have not been credited to their Bank Accounts as yet. Branch Secretaries are requested to check up with the concerned SSAs whether they have completed/sent the required data to Circle office. On receipt of the required data from SSAs, as informed time to time, DGM Circle office, arrange the payments depending on the availability of funds.

During the Meeting with all Unions/associations of BSNL, held on 24<sup>th</sup> march, 2018, Hon'ble Minister of State for Communications Shri Manoj Sinha has agreed that the issue of 3<sup>rd</sup> Pay revision for BSNL employees would be processed for approval of DPE and the Cabinet. He also assured that needful action would be taken to settle the issue of pension revision of the existing pensioners.

O. M. F. No. 4/34/2017-P&PW(D) Government of India. Ministry of Personnel, Public Grievances and Pensions Department of Pension and Pensioners Welfare 3<sup>rd</sup> Floor, Lok Nayak Bhawan, Khan Market, New Delhi, Dated : 31-01-2018

Sub. : Grant of Fixed Medical Allowance to Central Government Civil Pensioners residing in areas not covered under Central Government Health Scheme-reg.

The undersigned is directed to refer to this Department's OM No. 38/99/99-P&PW© dated 17-4-2000 on the object mentioned above to say that in accordance with the instructions contained therein, Central Government Civil Pensioners, residing in an area not served by any CGHS dispensary or any corresponding Health Schemes administered by other Ministries/Departments, as the case may be, even though their places of residence may fall within the limits of a CGHS covered cities, are required to submit the following documents for claiming Fixed Medical Allowance :

- a) An undertaking in the prescribed format.
- b) A certificate from the Medical Authorities of CGHS or from authorities of corresponding Health Schemes of the concerned Ministries/Departments, as the case may be, that the area where the pensioner is residing is not served by any dispensary under CGHS or the corresponding Health Scheme administered by the Ministry/Department.
- 2. Keeping in view the difficulties being faced by the pensioners in obtaining the required certificate from the concerned Medical Authorities, the matter has been reconsidered in consultation with the Ministry of Health and Family Welfare. It has now been decided that the pensioners, residing in areas not covered by CGHS or any corresponding Health Schemes administered by other Ministries/Departments, as the case may be, would no longer be required to submit a certificate referred to in para 1(b) above.

However, such pensioners would continue to submit an undertaking in the following format :

- 3. A Central Government Civil Pensioner is also required to fill enclosed form along with above mentioned undertaking.
- 4. All the pension disbursing authorities area required to obtain the above undertaking along with the Form, as mentioned in Para 3 above, from such pensioners before sanctioning Fixed Medical Allowance. An entry to this effect should also be made in their PPOs.

#### Sub. : Revision of provisional pension sanctioned under Rule 69 of the CCS (Pension) Rules, 1972.

The undersigned is directed to say that in implementation of the decision taken on the recommendations of the 7<sup>th</sup> CPC, orders were issued vide this Departments' OM No. 38/37/2016-P&PW (A) (II) dated 04.08.2016 for revision of pension of pre-2016 pensioners/family pensioners w.c.f. 01.01.2016 by multiplying the pre-revised pension/family pension by a factor of 2.57 pension/family pension of all Central civil pensioners/family pensioners, who retired/died prior to 01.01.2016 by notionally fixing their pay in the pay matrix recommended by the 7<sup>th</sup> CPC in the level corresponding to the pay in the pay scale/pay band and grade pay at which they retired/dicd.

- Instructions were issued vide this Department's OM of even number dated 30.11.2016 for extending the benefit of OM dated 4.8.2016 to the following categories of pensioners drawing provisional pension under Rule – 69 of the CCS (Pension) rules, 1972.
  - (i) Retired before 1.1.2016 and sanctioned provisional pension under Rule-69 of the CCS (Pension) Rules on account of departmental/judicial proceedings or suspension.
  - (ii) Suspended before 1.1.2016 and sanctioned provisional pension, based on their pre-revised pay under Rule-69 of the CCS (Pension) Rules on retirement on or after 1.1.2016.
- It has now been decided that provisional pension sanctioned in the above cases may be revised w.e.f. 1.1.2016 in accordance with the instructions contained in this Departments' OM No. 38/37/2016-P&PW (A) dated 12<sup>th</sup> May, 2017. Higher of the two formulations i.e. OM dated 4.8.2016 or OM dated 12.5.2017 would be the revised provisional pension w.e.f. 1.1.2016 in such cases.
- 4. This issues with the approval of Department of Expenditure, Ministry of Finance ID No. 1(21)/E-V/2016 dated 15.01.2018.
- 5. Hindi version will follow.

# Subject : Timely commencement of family pension in favor of spouse by banks in the event of death of the pensioners.

Attention is invited to this office OM No. CPAO/Tech/Bank Performance / 2016-17/255 dated 27.02.2017 whereby Heads of all the CPPCs and Government Business Divisions of the Banks were advised to commence the family pension to the spouse immediately on receipt of death certificate of the pensioner, proof of spouse age/date of birth and undertaking of recovery of excess payment latest within a month.

However, analysis of reports prepared in CPAO regarding time taken in conversion of pension to family pension in favour of spouse of deceased pensioners shows inordinate delay in many cases. The details of these cases are available in CPPCs logins http://eppo.nic.in

In view of the above, Heads of CPPCs and Government Business Divisions of the banks are advised to review the latest position and ensure compliance of the above instructions and submit the status report to CPAO along with reasons for delay by 9<sup>th</sup> February, 2018 positively by e-mail at vijay.cpao@gmail.com.

It is, further, requested to give the acknowledgement of receipt of application and death certificate to the family pensioner regarding commencement of family pension.

# Sub. : Grant of Deparness Relief to Central Government pensioners/family pensioners Revised rate effective from 01.01.2018.

The undersigned is directed to refer to this Department's OM No. 42/15/2016-P&PW(G) dated 28.09.2017 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government pensioners/family pensioners shall be enhanced from the existing rate of 5% to 7% w.e.f. 01.01.2018

- 2. These rate of DR will be applicable to (i) Civilian Central Government Pensioners/Family Pensioners including Central Govt. absorbs pensioners in PUS/Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D) Vol.II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defense Service Estimates, (iii) All India Service Pensioners (iv) Railway Pensioners/family pensioners (v) Pensioners who are in receipt of Provisional pension (vi) The Burma Civilian pensioners/family pensioners and pensioners/families of displaced Government Pensioners from Burma/Pakistan, in respect of whom orders have been issued vide this Departments OM No. 23/3/2008-P&PW(B) dated 11.09.2017.
- These orders shall not be applicable on CPF beneficiaries, their widows and eligible children who are in receipt of ex-graita payment in terms of this Department's OM No. 45/52/97-P&PW• dated 16.12.1997 and revised vide this Departments OM 1/10/2012-P&PW• dated 27.06.2013. Separate orders will be issued of above category.
- 4. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 5. The payment of arrears of Dearness Relief shall not be made before the date of disbursement of pension/ family pension of March, 2018.
- 6. Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in this Department's OM No. 45/73/97-P&PW (G) dated 2.7.1999 as amended vide this Department's OM No. F. No. 38/88/ 2008-P&PW(G) dated 9<sup>th</sup> July, 2009. The provisions relating to regulation of DR where a pensioners is in receipt of more than one pension will remain unchanged.
- 7. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.
- 8. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 9. The offices of Accountant General and authorized Pension Disbursing Banks are requested to arrange payment of relief to pensioners etc. on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, II/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL)/81 dated the 21<sup>st</sup> May, 1981 addressed to State Bank of India and its subsidiaries and all nationalized Banks.
- 10. In their application to the pensioners/family pensioners belonging to Indian Audit and Accounts Department, these orders issue after consultation with the C&AG.
- 11. This issues in accordance with Ministry of Finance, Department of Expenditure's OM No. 1/1/2018-E. II(3) dated 15<sup>th</sup> March, 2018.

In the meeting with banks held on 31.01.2018, CPPCs were instructed to create their website/web page with facility to know the PPO status as registration of the pensioners grievances, Banks were also instructed to follow CPPCs guidelines and provide pension slip, breakup of pension and arrear payments and other required information to the pensioners. <b>Departments of Financial Services</b> Department of Financial Services vide its letter dated 02.03.2017 has asked the Public Sector Banks (PSBs) to take necessary action in the matter.
15.	Para 6, Item (29.6) of the minutes :- Empanelment of Hospitals/Health Centre with CGHS in Ambarnath/ Dombivli	Ministry of Health stated that there are 9 empanelled hospitals in Ambernath/Dombivli. The 14 enlisted hospitals in the freash agenda do not satisfy the criteria of minimum 40 beds for empanelment. The pensioners association requested if the above condition may be relaxed for the empanelment of these hospitals. (Action :- Ministry of Health and Family Welfare)	Ministry of Health & Family Welfare Action has been initiated for new empanelment process and revision of rates. However, the guidelines regarding empanelment of Hospitals/ Health Centres under CGHS cannot be in isolation and shall be common to all cities.

# **Guidelines for Pensioners**

#### • Submission of Claims:

Ensure to submit your claims in the prescribed proforma for grant of pension/gratuity/commutation/revision to your Head of Office atleast six months before the date of your retirement so that the Pension Payment Order (PPO) reaches you through your Head of Office before your retirement. Remember that the processing, verification and authorization of these claims may involve several levels and one or more offices which require sufficient time and effort to be accurate.

#### • Verification of PPO:

As soon as you receive your PPO, please verify the pensionary awards notified in the PPO for their correctness as per extant rules. In case of any correction(s) required in the PPO, please contact your Head of Office/Pension Disbursing Agency for necessary action in this regard.

#### • Physically Handicapped/Mentally Retarded Children:

If you have any physically handicapped or mentally retarded child/children, please ensure that his/their details are furnished to your Head of Office for making an endorsement in your service and pension record and obtain an acknowledgement of this intimation.

#### • Transfer of Pension Account:

If you desire to draw your pension from another paying agency, make a request to your current Pension Disbursing Agency (PDA) for transfer of your pension account to the PDA from where you now wish to draw your pension.

#### • Restoration of Commuted Pension:

Commuted portion of your pension can be restored on completion of 15 years from the date of receipt of the commuted value of your pension. In case the same has not been restored, contact your P.D.A./ pension paying bank.

#### • Commutation of Pension:

Commuted portion of pension is required to be reduced from pension from the date of payment of the commuted value of the pension or after three months from the date of issue of PPO or from the date, capitalized sum is credited to the pensionerýÿs account. If the commuted portion of pension is not reduced as above, bring this to the notice of your PDA immediately to avoid a heavy recovery later.

#### • Nomination for Life Time Arrears:

Please ensure to nominate the person to whom you want to authorize Life Time Arrears (LTA) on your demise. The nomination form should be submitted to your PDA. You can also change the nomination by submitting a change nomination form to your PDA to avoid any hardship to your nominee in receiving the amount of LTA.

#### • Loss of PPO:

Notify your PDA immediately if your PPO is lost. You should also request him to furnish a loss certificate to the concerned authority to obtain a duplicate copy of PPO.

#### • Annual Life Certificate:

For annual life certificate, you should appear before your PDA in the month of November every year. In case, you are unable to appear due to bodily illness or infirmity, you can submit your life certificate duly authenticated by any of the specified authorities. You also have option to submit your digital life certificate using your Aadhar card based authentication through Jeewan Pramaan. In case of NRI pensioners/family pensioners who are unable to come to India for personal identification may be allowed pension/family pension on the basis of a certificate to be issued by an authorised official of the India Embassy/High Commission of India or Consul of India consulate in the country where the pensioner is residing. This certificate is to be issued on verification of Pensioner/Family Pensioner on the basis of photograph pasted on Passport or any other such document. Otherwise, the pension may be stopped.

#### • Commercial Employment after Retirement:

Ensure to obtain prior permission from the competent authority for accepting any commercial employment within one year of your retirement.

#### • Post-retirement Conviction/Imprisonment:

If a pensioner is convicted or sentenced to imprisonment by a Court, his pension will be suspended. In the event of conviction/imprisonment by a court of law, full facts of the case should be reported to your PDA/Head of Office.

#### • Changes in the family after discharge from service:

Post discharge changes in the details of your family arising out of your marriage or children born to you after your retirement should be intimated to your Head of Office with full details and relevant certificates. Also ensure that a joint notification of your family pension is done by pursuing the matter with your Head of Office.

#### • Re-employment of pensioners:

In case of re-employment in any Central or State Government /autonomous bodies/Public Sector Undertakings, please submit the full facts of the same to your PDA immediately after its occurrence. In case of non-reemployment, a declaration to this effect should be given to your PDA periodically (once in a year in the month of May positively).

#### • Payment of pension through Authorised Banks:

Pension can not be paid in cash. Hence open an individual savings/current account in your name preferably joint account with your spouse, if the spouseýÿs name is notified for family pension in the PPO, in any of the branches of the Authorized Banks and furnish the details of the same to your Head of Office so that pension can be credited to your bank account.

#### • Court Attachment:

Pension, whether due or to become due, is free from attachment from any court until it has actually been paid as per the Pension Act. No pensioner can assign or sell any interest in respect of the pension not then due.

#### • Receipt of Two Pensions:

If you are in receipt of more than one pension, you should furnish full details to your PDA for revision of both the pensions and regulating dearness relief thereon.

#### • Submission of Periodic Certificates:

Submit periodic certificates regarding re-employment/employment, remarriage/marriage to your PDA on due dates in order to regulate your pension correctly.

#### • Missing Pensioner:

If a pensioner is found missing, his family should lodge an F.I.R. with the police authorities. If the pensioner is not traced by six months, a certificate should be obtained from the police authorities to this effect, and the matter should be reported to PDA, along with the submission of an Indemnity Bond so that the matter could be pursued with the concerned authorities for sanction of family pension from the date of lodging the F.I.R..

#### • Arrears of Pension:

If the pension is not drawn for more than a year, for any reason, it becomes time-barred and would require the sanction of the competent authority. The arrear claim should be submitted in the prescribed form to your PDA with explanation for delay, non-reemployment and non-conviction certificates for obtaining the sanction for payment of the arrears.

#### • Non-Resident Indian (NRI) Pensioners:

The NRI Pensioners should open an ordinary non resident bank account in any scheduled bank in India as per the provision of the exchange control. They should also submit life certificate and nationality certificate as prescribed to enable the credit of pension amount due to them in to their accounts.

In view of the present financial constraints it has become necessary to reduce the expenditure. A proposal is under correspondence of the management as follows :

- a) To reduce the annual outdor ceiling of serving and retired employee to 12 days of Pay (pay includes D.A. also as per the exting orders/provisions). However the existing provisions like amount of outdoor celing in case of chronic diseases etc. will remain unchanged.
- b) To withdraw the medical allowance without voucher facility under Outdoor treatments extended to retired employees residing in cities covered by CGHS facility.

It is proposed to implement the changes w.e.f. 01.04.2018. This is for your information. If you have any suggestion. It may please be submitted within fifteen days to take a decision in the matter.

# Sub. Review of Medical Allowance to Retired Employees. Reference : AGM (SR)'s Circular No. BSNL/ 39-1/SR-2018 Dated 01.03.2018

Respected Sr, All India Central Govt. Pensioners Association is the oldest (Formed in 1947) and one of the indentified Pensioners Assolations by Department of Pension & Pensioners Welfare. We also represent pensioners retired from pensioners covered under Rule 37-A of Pension Rules.

BSNL Corporate vide circular cited in the reference, proposed to withdraw the Medical Allowance without voucher facility for Outdoor treatment in respect of retired employees residing in the cities covered under CGHS.

#### In this regard we have to state the following request -

- 1. In Maharashtra state, CGHS facilities have its own limitations and the facilities are not sufficient to take the load of BSNL Retirees also.
- 2. For availing the facilities of CGHS, the Contribution as per prevailing rates as prescribed by CGHS authorities, are required to be paid in advance.
- 3. As the Retired employees in Cities are not enrolled as beneficiaries of CGHS, They have to incur the expenses on account of outdoor treatment at higher rates than the rates in the cities not covered in CGHS.
- 4. The Retired employees prefer to medical allowance because, the process of submission of medical bills and payment of the bills is cumbersome.

You are, in view of the above, requested to continue the Medical Allowance without voucher facility for Outdoor treatment for retired employees irrespective of their residence.
