#### Dear Brothers & Sisters,

We celebrate Pensioner's Day every year on 17<sup>th</sup> December in the memory of Shri D.S. Nakara and others who consistently fought in the court and brought self respect to the pensioners. On this day in 1982, Former Chief justice of India Shri Y. V. Chandrachud, delivered the historical judgement that gave dignity and purpose to the life of pensioners in India. On this pensioner's Day, let us resolve to reach all urban/rural pensioners/family pensioners and ensure that they get their pension and medical facility as provided by the Government.

Central Govt. Pensioners residing in NON-CGHS area get Medical Allowance of Rs. 1000/- p.m. to meet the Medical expenses. There is no arrangement to meet the huge expenditure charged by the Hospitals for indoor treatment. In response to the letter from Under Secretary, Min. Of Health & Family Welfare, We suggested that "Government should introduce Health Insurance Scheme for Central Government employees and pensioners including those residing in NON-CGHS area. In the interim, CGHS should empanel the Hospitals at the District Level for the benefit of the pensioners residing in the NON-CGHS area. In this way CGHS facilities (to provide IPD treatment on cashless basis) may be extended to all District headquarters till the Introduction of Health Insurance Scheme. "

We are receiving complaints from Secretaries/Pensioners that the Applications for revision of Pension in respect of Postmen are pending in the Head Post Offices without any action. They are not being forwarded by concerned Head Post Offices/SSPs to DAP Nagpur as per instructions. Also there may be some other pending cases with SSP / DAP Nagpur. Secretaries are requested to contact the concerned and submit the application for Pension Adalat for Postal Pensioners arranged by CPMG Maharashtra, Mumbai on 22.02.2019.

As informed earlier, We received one IRIS based Digital Life Certificate(DLC) machines from Department of Pension& Pensioners Welfare, New Delhi, under the programme for Awareness and promoting Digital Life Certificates. We received the expected response from Pune, Kalyan, Mulund, Panvel-Navi Mumbai, Pimpri-Chinchwad, Nandurbar, Akola, Ner-Sopant, Yavatmal, Nagpur branches. We generated 474 Digital Life Certificates under this activity.

The Union Cabinet on 23.10.2019 approved the proposal for revival of BSNL and MTNL by administrative allotment of spectrum for 4G services, debt restructuring by raising of bonds with sovereign guarantee, reducing employee costs, monetisation of assets and in-principle approval of merger of BSNL & MTNL. Government received the expected response from the employees. Now Government/BSNL has to take immediate steps to take the steps as agreed in the Revival Plan. Mangement of BSNL/MTNL have to restructure the functioning of the BSNL/MTNL to run the business further, so that the purpose of the revival plan to provide reliable and quality services through its robust telecommunication network throughout the country. Secondly, This is an opportunity for our association to approach these retired employees to provide the required guidance in terms of retirement benefits, Investment etc and in response to increase our membership.

About revision of pension in respect BSNL/MTNL pensioners, You are aware that we represented to Shri Ravi Shankar Prasadji, Hon'ble. Minister for Communications immediately on taking the charge for damanding delinking of revision of pension for pay revision. Hon. Minister Of Communication, during the meeting on 9<sup>th</sup> December, 2019, asked the representatives to wait till the BSNL earns the profit on revival of BSNL/MTNL.

#### ALL INDIA CENTRAL GOVT. PENSIONERS ASSOCIATION Hq. PUNE MINUTES OF CWC HELD ON 21<sup>st</sup> SEPT. 2019

- With prayer Itani Shakti Hame Dena Data ....., CWC of the Association was started at 14 hours on 21<sup>st</sup> Sept 2019 at the Sharada Nilayam Education Complex, Mulund East, Mumbai 400081. President Shri W.S.Bhome welcomed members C.W.C. He proposed to give standing ovation in the memory of departed members, dignitaries, and soldiers who lost their lives during the past one year. All members of CWC stood up for two minutes and observed silence in the memory of departed souls.
- 2. General Secretary shri H.F.Chaudhari read out the minutes of last CWC meeting held on 07-10-2018 at Pune. The same were approved by the CWC.
- 3. Gen. Secretary read out the Annual report for the period highlighting the various items of achievements as listed below.
  - i) Merger of Talegaon-Dabhade branch with Pimpri-Chinchwad branch. The revival of various branches like Dadar Mumbai, Jalgaon, Amravati, Solapur, Savada, Umerkhed, Panvel, Gadag and Goa which were almost Defunct for long time. With the Good response from some branches we could achieve the growth in membership from 29493 as on 01-04-2017 to 36440 as on 01-04-2019 registered with 92 branches.
  - ii) Compliance of the requirements of Public Trust : Change reports pertaining to the trustees (CWC members elected) between the year 1989 to 2017 have been filed with the office of Charity Commissioner, Pune on 14.06.2019.
  - iii) 'Verification of Title' and 'Registration' of PENSIONERS PROGRESS BULLETIN" with RNI. Finally 'PENSIONERS PROGRESS BULLETIN' in Bilingual, English and Marathi was registered successfully in December, 2018 with RNI No. MAHBIL/2018/76457, reducing expenditure on postage charges for dispatch of Bulletin.
  - iv) Meeting with Shri H. C. Agarwal, CPMG Mumbai on 9<sup>th</sup> August, 2019 raising the issues of Holding of Pension Adalats regularly at Regional/Divisional level, Holding Informal meetings at regional (PMG)and divisional level (SSP), Stabilization of Core System Integration(CSI), Issue of Pension Slip on increase/decrease in amount, Delay in Revision of Pension on account of notional monetary benefit to the Postmen/Mail guards w. e. f. 01.01.1996 to 10.10.1997 and toexpedite the process of Family pension for 2<sup>nd</sup> stage eligible member of family.
  - v) Active participation in the Pension Adalat arranged by CCA Mumbai to solve the pending cases of the pensioners.
  - vi) He reported about Implementation of Core System Integration( CSI), Enrolling Data for PDA by CCA, Mumbai and inauguration of Comprehensive Pension Management System (CPMS)
  - vii) Due to the expansion of cities and increase in the beneficiaries Additional wellness centers/Doctors are required in Pune, Mumbai, Thane, Nasik, Nagpur etc.

Shri V. G. Kelkar, AGS read out the Accounts for the period, The same were approved after discussions.

- viii) The present position of revision of pension in respect of BSNL and MTNL pensioners was discussed in the house. Shri Chaudhari informed the house that our Association has made correspondence with Hon,ble minister of Communication and IT with the pleading to delink the issue of pension revision from pay revision as the pay revision of BSNL employees is not being done due to the restrictions imposed by the affordability clause.
- 4&5 Organizing Secretaries Shri Sonalkar, Shri Nimbalkar, Shri Rohidas and Shri Sarwar one by one presented the organizational position in their area and brought forward the difficulties faced by them . G.S. requested them to make efforts to reach all pensioners/Family pensioners in Urban/Rural and ensure they are getting the Pensionary benefits/Medical facilities.
- 6. To consider about the necessity for carrying out amendments in the Memorandum of Association and Rules and Regulations of Charitable Society/Trust and to take necessary steps for the same.

President Mr. W. S. Bhome took this subject for discussion and informed the members that, the present charitable society is registered in the year 1974. The constitution was formed and registered at that time. After

registration of the present trust, long period of 45 years have been passed. During this period various changes have occurred in the society at large, in economic system, surrounding situation and relevant laws. Due to this for keeping pace with the changing time, it is necessary to make amendments in it. Upon this discussion was held in the meeting. General Secretary Shri. H. F. Chaudhari placed the certified copy of Memorandum of Association and Rules and Regulations before the meeting. All CWC members and office bearers present for the meeting carefully scrutinised the said certified copy. Thorough discussion was held in the meeting. During discussion, it is observed that, Name and Registered office address of the society have been changed. Change in name is registered with the office of Charity Commissioner, Pune Region, Pune. However, change in registered office address is not reported to the concerned authority. G. S. Shri. Chaudhari further intimated that, scope of activities is also changed and widened. Various clauses in the Rules and Regulations were also considered carefully in the meeting.

All the CWC members/office bearers present for the meeting carefully considered the need for making amendments/changes/additions/deletions in clause numbers 1, 2 and 3 of the Memorandum of Association and clause numbers 1, 3, 4, 5, 6, 7, 8, 9, 10, 11, 14, 17, 18, 19, 20, 22 of Rules and Regulations and Title of the Rules and Regulations. CGDA informed that corrigendum PPOs for revision of pension after 7<sup>th</sup> CPC are being issued to all pensioners and this would cover those pensioners in whose case revised pension authority was not issued after 6<sup>th</sup> CPC. CGDA was further requested to reconcile the number of Air Force Pensioners whose pension is to be revised after 6th CPC/7<sup>th</sup> CPC in consultation with Directorate of Air Veterans, Air HQ, New Delhi. Therefore, CGDA is required to interact with Directorate of Air Veterans to reconcile the number of Air Force Pensioners whose pension is yet to be revised in terms of provisions contained in 6<sup>th</sup> / 7<sup>th</sup> CPC and also ensure that revised pension authority is issued in respect of all Defence pensioners including Air Force Pensioners.

A monthly status report in this regard will be sent by CGDA to Department of Pension & Pensioners' Welfare. (Action : CGDA)

#### ii) Health Insurance Scheme for pensioners including those residing in Non CGHS area.

Ministry of Health and Family Welfare informed that proposal / EFC memo for the Health Insurance Scheme had been submitted to Department of Expenditure. A revised EFC memo has been sent to Department of Expenditure in April, 2019 and the same is pending for approval by the Department of Expenditure.

Joint Secretary (P & PW) mentioned that this issue has been pending for a long time and it needs to be resolved at the earliest. He requested Ministry of Health and Family Welfare to pursue this matter vigorously with Department of Expenditure.

#### (Action : Ministry of Health & Family Welfare and Department of Expenditure)

# iv) Anomaly in fixation of pension of DoT employees who were absorbed in BSNL between 01.10.2000 and 30.07.2001.

Department of Telecom informed that Hon'ble CAT has allowed a petition filed by the affected pensioners of BSNL for fixation of their pension based on their IDA Pay in BSNL. DoT has filed a writ petition i.e. WP No. 10019 / 2017 against the order dated 16.12.2016 of Hon'be CAT and Hon'ble High Court has directed that no coercive steps shall be taken by the pensioners for implementing the order of Hon'ble CAT. The matter is sub-judice in the High Court.

Department of Telecom also informed that in regard to the alternate formulation suggested by DoPPW, views of Department of Public Enterprise (DPE) were sought as to whether any similar case of anomaly of pension has been reported by any Ministry. DPE have informed that there is no such precedent.

Department of Expenditure had earlier asked DoT for the financial implications on implementation of the said formulation suggested by DoPPW and DoT is working on that.

Department of Telecom was advised to calculate the financial implications in respect of both the formulation i.e. the one which has been allowed by Hon'ble CAT in its order dated 16.12.2016 and the other suggested by DOPPW and submit the same to DoPPW/ Department of Expenditure.

#### (Action : Department of Telecom)

### iv) Extension of benefit of upgraded Grade Pay to pre-2006 retirees of S-12 grade (Issue of grant of grade pay of Rs. 4600/- instead of Rs. 4200/-)

It was informed that DoPPW has since issued orders dated 04.01.2019 and 09.07.2019 for  $6^{th}$  and  $7^{th}$  CPC respectively for revison of pension based on grade pay of Rs. 4600/-. Therefore the matter stands resolved.

The item was closed.

#### viii) Delay in commencement of family pension to spouse on death of pensioners.

CPAO informed that they have obtained data regarding time taken in commencement of family pension from all banks. As per the report prepared by CPAO, there has been significant improvement in this regard since the last SCOVA meeting

Department of Financial Services (DFS) informed that difficulties are faced by banks in commencement of family pension on account of delay in receipt of death certificate of the deceased pensioner and completion of other paperwork formalities by family pensioner.

Representatives from State Bank of India (SBI), Punjab National Bank (PNB) and Bank of Baroda (BoN) informed that in almost all cases, family pension is started within one month after receipt of the death certificate / documents from the family pensioner.

In respect of family pensioners from Defence, CGDA informed that necessary guidelines have been issued vide PCDA (P), Allahbad Circular No. 203 dated 17.07.2018 whereby PDA have been advised to make sure that acknowledgement is invariably given by the PDAs to the family member on receipt of death certificate of the deceased pensioner / application for commencement of family pension and family pension is paid within one month.

Representatives of Pensioners Associations said that banks like United Commercial Bank, Indian Bank, Canara Bank are following the old procedures and are taking up to 3 month time or even longer, to start family pension. DFS was requested to issue suitable instructions to banks.

The item was closed. However, it was decided that CPAO/CGDA/DoPPW would continue to monitor the status of timely commencement of family pension by the Banks.

## ix) Timely (a) Restoration of commuted pension and (b) Commencement of Additional Pension on attaining the age of 80 years by the Banks.

It was informed by Department of Financial Services that most of the banks have automated system for restoration of commuted pension after 15 years and also for commencement of additional pension on attaining the age of 80 years. The banks where automated system is not presently available were requested to take action to make the system fully automated.

Representatives of Pensioners Associations and CGDA mentioned that in respect of family pensioners of Defence, as regards proof of age/date of birth and payment of additional pension, PCDA (P) Allahabad issued circulars whereby PDAs have been advised to folow the orders for payment of additional pension, but PDAs are not following circulars. PCDA will issue particular reiterating the instructions.

The data complied by CPAO shows that there has been significant improvement intimely restoration of commuted pension and commencement of Additional Pension on attaining the age of 80 yeas, and the position in this respect is quite satisfactory. The item was closed.

#### x) Item wise details of payment made to be shown in the pass books of pensioners.

It was informed that most of the banks have been providing the details / breakup of pension to the pensioners through SMS/Email ect. Further, personal and pension related information could be viewed from the dashboard facility provided by the CPAO.

SBI and PNB inforemed that they have also provided facilities on their web portals for viewing the pension deails / breakup by the pensioners.

In view of the baove, item was closed.

#### xiii) Empalelment of Hospitals / Health Centre with CGHS in Ambernath / Dombivili.

Ministry of Health & Family Welfare further informed that a few private hospitals near Ambarnath have been empanelled. In case any hospital agrees to the rates / terms and fulfills the conditions empanelment under CGHS comes forward, the same will be employed under CGHS. The Item was closed.

#### xiv) Revision of PPOs of pre-2016 pensioners / family pensioners as per 7<sup>th</sup> CPC orders.

CPAO informed that out of 9.03 lakh cases, 7.75 lakh cases have been revised. CPAO also informed that they are monitoring the progress of the same on daily basis.

Ministry of Railways informed that out of 13.87 lakh cases, they have issued revised authorities in respect of 12.30 lakh cases.

Department of Telecom informed that out of 98,300 cases, 97,400 cases have been revised.

Department of Posts informed that out of 2.58 lakh cases, 2.30 lakh cases have been revised.

CGDA informed that out of 4.95 lakh cases of Defence Civilian pensioners / family pensioners, revised authority has been issued in respect of 4.53 lakh cases. CGDA further informed that in respect of pensioners from Defence Forces, out of 25 lakh cases, approximately 13 lakh cases have been revised so far.

The Departments were requested to complete the revision of pension and the remaining cases at the earlierst.

#### (Action : CPAO, Ministry of railways, Department of Posts, DOT, Ministry of Defence / CGDA)

# xi) Payment of arrears accruing in respect of deceased pensioners / family pensioners to the nominee / legal heir.

CPAO informed that on death of the pensioners / family pensioners, the pension account is closed by the bank and the balance amount in the account of pensioners / family pensioners is paid to the nominees / legal heirs. However, it is observed that the life time arrears arising subsequently on account of Pay Commission etc are not paid to the nominees / legal heirs of the deceased pensioners / family pensioners either on account of fact that the pension / family pension is not revised by the concerned Pension Sanctioning Authority (PSA) or the amount of arrears of revised pension / family pension is not paid due to closure of the bank account.

DoPPW informed that as per the instructions, revised pension payment authority has to be issued in respect of all pensioners / family pensioners who were alive as on 01.01.2016 and lifetime arrears has to be paid to the families of such pensioners / family pensioners who died after 01.01.2016. It was also informed that in accordance with the Para 23 of the Scheme booklet of CPAO, where the bank account of the deceased pensioner or family pensioner has been closed, the lifetime arrears are re quired to be paid by the pension disbursing bank through the bank pay order after making suitable note on both the halves of the PPO. It was decided that the DoPPW will reiterate the above instructions to all pension sanctioning authorities / pension dusbursing authorities for compliance.

#### (Action : DoPPW and CPAO)

# xvi) Extension of benefit of modified parity/revision of pension by pay fixation method to pensioners drawing Compulsory retirement pension / Compassionate Allowance (on dismissal/removal).

It was informed that a fresh proposal has been referred to Department of Expenditure on 16.08.2019. for their consideration based on a decision taken in the recent JCM meeting. This item has also been included in the New Agenda Items. Therefore, this item may be closed here.

# (xvii) Revision of CGHS package rates suitable for attracting more private hospitals for empanelment.

Ministry of Health & Family Welfare informed that Empanelment of private hospitals under CGHS is a continuous process. Revision of rates is an administrative matter. Many Hospitals and Diagnostic Centres are applying for empanelment under CGHS at the current rates in all CGHS cities. As on date, a total of 681 private hospitals, 374 Eye Centres, 176 Dental Clinics and 229 Diagnostic Centre and Imaging are empanelled under CGHS. In view of the above explanation of Ministry of Health and Family Welfare, the item was closed.

#### 5) Discussion on New Agenda Items of 31" SCOVA meeting

# (31.1) Negligence by the Departments / Banks for disposals of grievances of Pensioners within reasonable time.

It was informed in the meeting that 83% cases in the CPENGRAMS are being resolved within stipulated period of 60 days. DoPPW had conducted a third party evaluation of the delay in pending grievances. On the analysis of the report it was found that most of the cases was pending at the level of Banks. it has been impressed to them to make their system automated and streamline.

Banks present in the meeting informed that they have developed their own grievances redressal portals for the redressal of the grievances. Further, banks also informed that they are also taking grievances from CPENGRAMS.

Joint Secretary (P&PW) informed that the DoPPW is also holding Pension Adalats for the redressal of the grievances. In addition to this, All India Pension Adalats by various Ministries/Departments in different ° regions of the country were conducted on 23.08.2019 for the resolution of the grievances. Further, JS (P&PW) informed that DoPPW has developed a Dashboard for monitoring of the grievances at different levels of the Ministries/Departments. In addition to this, an integrated Call Centre has also been functioning for facilitating the pensioners and strengthen the grievance redressal machinery.

It was also informed that DoPPW is conducting monthly meetings with the concerned Ministries/ Departments where the grievances are pending for more than 60 days and also where the pensioners are not satisfied with the reply given by the Ministries/Departments.

In view of the position explained above, the item was closed

# (31.5) Revision of pension/family pension under 7\*" CPC in terms of Do P&PW OM dated 12th May, 2017 in respect of the pensioners who were in receipt of compulsory retirement pension and compassionate allowance under Rules 40 and 41 of CCS(Pension) Rules, 1972

It was informed that a fresh proposal has been referred to Department of Expenditure on 16.08.19 for their consideration based on a decision taken in the recent JCM meeting. The matter will be followed up with Department of Expenditure.

#### (Action:- DoPPW)

# 31.6) Booking of Holiday Homes for Central Government Pensioners- enhancement of time limit from 30 days to 60 days.

Although, no representative from Ministry of Housing and Urban Affairs was present in the SCOVA meeting, in a communication dated 03.09.2018, Directorate of Estates, informed that the provision for time limit for booking of Holiday Homes of 60 days for the serving Central Government has been made considering their official tours (which are mostly decided on urgent basis/unplanned and short in nature) and availing LTC during the service period wherein they have to plan the tour well in advance considering the availability of tickets and leaves(s) grant Retired Government officials, PSU, State Govt. etc. can avail the services of Holiday Homes at different time period without any sort of restriction.

It was, however, observed that the touring officers can avail hotel accommodation as per their entitlements. The holiday homes are basically for providing suitable accommodation for employees/ pensioners who are on vacation. The pensioners who have got limited resources are more deserving

for accommodation in the holiday homes. It was therefore, decided that the matter would again be taken up with Ministry of Housing and Urban Affairs, Directorate of Estates for reconsideration.

#### (Action:- Ministry of Housing and Urban Affairs/DoPPW)

#### (31.11) CGHS contribution at the rates prevailing while the old P&T pensioners retired from service.

Ministry of Health and Family Welfare informed that CGHS contribution is always to be made as per the rates prevalent at the time of enrolling under CGHS. This is applicable to all beneûciaries. Pensioners have the option to contribute subscription on yearly basis for upto 10 years, if they consider that paying 10 year subscription in one go for the life time card is at burden.

It was, however, observed that the facility of CGHS was not provided to the P&T pensioners on their retirement as per the instructions existing at that time. Now, that this facility has been extended to P&T pensioners, it may not be fair to ask them to pay the contribution as per the current rates instead of the rates prevailing at the time of their retirement. Ministry of Health and Family Welfare agreed to reconsider this matter.

#### (Action:- Ministry of Health and Family Welfare)

**31.12)** CGHS Facility for BSNL Pensioners at rates prevalent at the time of formation of BSNL in 1999. Ministry of Health and Family Welfare informed that there is no provision under CGHS for refund of subscription, if someone opts out of it. The eligible BSNL retirees have to submit CGHS contribution as per the rates prevalent at the time of enrolling under CGHS. This is applicable to all beneûciaries. The eligible retirees of BSNL have the option to contribute subscription on yearly basis for upto 10 years, if they consider that paying 10 years subscription in one go for life time car is a burden.

It was observed that some of the BSNL pensioners had earlier paid the required contribution for availing the CGHS facility and later switched to the medical facilities from BSNL. The contributions deposited by the BSNL pensioners with the CGHS were however not refunded to them. In case they are allowed to switch over to the CGHS facility again by surrendering the medical facilities of BSNL, they should not be made to pay the CGHS contribution again. Ministry of Health and Family Welfare stated that they would reconsider this matter accordingly.

#### (Action:- Ministry of Health and Family Welfare)

- 6. In view of the large number of health relating issues, it was decided to hold review meetings with Ministry of Health and Family Welfare.
- 7. Secretary (P&PW) said that Department of Pension and Pensioners' Welfare has continuously been taking numerous steps for the welfare of the pensioners like setting up of Integrated Grievance Cell and Call Center, recently commissioned Dashboard for real-time monitoring tool of grievances and Bhavishya cases.
- 8. Hon'ble MOS(PP) said that it had been a pleasant and fruitful interaction, which is indicative of the efforts being made by Department of Pension & Pensioners' Welfare. He said that we must devolve a mechanism in utilizing pensioners' expertise and energy in a creative way.
- 9. Hon'ble MOS(PP) referred to recent initiative by DoPPW in broad basing the use of DLC, especially for those old and inûrm pensioners who are unable to visit bank branches and stand in queues for submission of life certiûcate in coordination with the Pensioners' Association all over the country. He further said that pensioners of 80 years (super senior citizens) and above may now submit their Digital Life Certiûcate w.e.f 1<sup>st</sup> October, which will be valid up to 30"' November of subsequent year.
- 10. One of the SCOVA Pensioners' Associations requested to hold SCOVA meetings on quarterly basis. However, Hon'ble MOS(PP) agreed to holding of SCOVA meetings twice a year.

The meeting ended with the vote of thanks to the Chair.

#### Sub : Submission of Life Cetificate.

It has been observed that Authorized Banks are not adhering to the extant rules regarding submission of life certificate issued vide OM No. CPAO/Tech/Life Certificate/2014-15/31-72 dated- 30.01.2015 and subsequent OM No CPAO / Tech / Life certificate / 2 Vol - V / 2017- 18/178 dated- 08.01.2018, OM No. CPAO / Tech / Life / Certificatel 2 Vol - V / 2017- 18 / 147 dated - 23.10.2018 and OM No. CPAO / Tech / Life Cetificate I 2 Vol - V / 2017-18 / 64 dated. 26.07.2019 (Copies Enclosed)

- 2. This office is receiving number of grievances from pensioners that Banks are -insisting on submission of life certificate online and not accepting the life certificate submitted in physical form.
- 3. It is reiterated that at present, the following three options are available with pensioner / family pensioner to authenticate his / her life.
  - i. By presenting himself / herself to the authorised bank officer to record the life certificate.
  - II. According to Para 15.2 of the "Scheme for Payment of pension to Central Civil Pensioner" which states that "Incase a pensioner is unable to obtain a life certificate from an authorised Bank, officer on account of serious illness / incapacitation etc., an intimation to this effect supported by a medical certificate from a registered medical practitioner about his inability to appear in person may be sent to officer-in-charge of the paying branch so that the latter may nominate an officer to visit the pensioner at his / her residence / hospital for the purpose of recordingthe life certificate". Further, vide Correction Slip No. 14 of "Scheme for payment of pension to Central Government Civil Pensioners by Authorized -Banks" (Copy Enclosed), a pensioner who produces a life certificate in the prescribed form in. Annexure-VII signed by any person specified in the said Correction Slip, is exempted from personal appearance.
  - III. Moreover, as a part of Prime Minister's Mission 'Digital India' and with the development of software application by Deptt. of information Technology circulated, as, per Correction Slip No.22 to the "Scheme for payment of pension to Central Government Civil Pensioners by Authorized Banks" (Copy Enclosed) the pensioner can prove their existence though Aadhaar based authentication of Life Certificate.
- 4. All Heads of CPPCs/Government Business Departments are requested to direct concerned officials of Bank branches to strictly adhere to the provisions mentioned above and accept the life certificate physically or electronically from the Pensioners

## Sub: Grant of Dearness Relief to Central Government pensioners/family pensioners - Revised rate effective from 01.07.2019-reg

The undersigned is directed to refer to this Department's OM No. 42/04/2019- P&PW(D) dated 06.03.2019 on the subject mentioned above and to state that the President is pleased to decide that the Dearness Relief admissible to Central Government pensioners/family pensioners shall be enhanced from the existing rate of 12% to 17% w.e.f 01.07.2019.

 These rates of DR will be applicable to (i) Civilian Central Government Pensioners/Family Pensioners including Central Govt. absorbee pensioners in PSU/ Autonomous Bodies in respect of whom orders have been issued vide this Department's OM No. 4/34/2002-P&PW(D)Vol.II dated 23.06.2017 for restoration of full pension after expiry of commutation period of 15 years (ii) The Armed Forces Pensioners, Civilian Pensioners paid out of the Defence Service Estimates, (iii) All India Service Pensioners (iv) Railway Pensioners/family pensioners (v) Pensioners who are in receipt of provisional pension.

- (vi) The Burma Civilian pensioners/family pensioners and pensioners/families of displaced Government Pensioners from Burma/ Pakistan, in respect of whom orders have been issued vide this Department's OM No. 23/3/2008-P&PW(B) dated 11.09.2017.
- 3. The payment of Dearness Relief involving a fraction of a rupee shall be rounded off to the next higher rupee.
- 4. Other provisions governing grant of DR in respect of employed family pensioners and re-employed Central Government Pensioners will be regulated in accordance with the provisions contained in this Department's OM No. 45173/97-P&PW (G) dated 2.7.1999 as amended vide this Department's OM No. F.No. 38/88/2008-P&PW(G) dated 9th July, 2009. The provisions relating to regulation of DR where a pensioner is in receipt of more than one pension will remain unchanged.
- 5. In the case of retired Judges of the Supreme Court and High Courts, necessary orders will be issued by the Department of Justice separately.
- 6. It will be the responsibility of the pension disbursing authorities, including the nationalized banks, etc. to calculate the quantum of DR payable in each individual case.
- 7. The offices of Accountant General and authorised Pension Disbursing Banks are requested to arrange payment of relief to pensioners etc. on the basis of these instructions without waiting for any further instructions from the Comptroller and Auditor General of India and the Reserve Bank of India in view of letter No. 528-TA, II/34-80-II dated 23/04/1981 of the Comptroller and Auditor General of India addressed to all Accountant Generals and Reserve Bank of India Circular No. GANB No. 2958/GA-64 (ii) (CGL) / 81 dated the 21<sup>st</sup> May, 1981 addressed to State Bank of India and its subsidiaries and all Nationalised Banks.
- 8. In their application to the pensioners/family pensioners belonging to Indian Audit and Accounts Department, these orders issue after consultation with the C&AG.
- 9. This issues in accordance with the Ministry of Finance, Department of Expenditure's OM No. 1/3/2019-E.II(B) dated 14thOctober, 2019. Hindi version will follow.

Vide the reference letters cited above, BSNL CO had issued guidelines regarding extension of CGHS facilities to retired BSNL employees and procedure for opting CGHS Scheme by BSNL Pensioners.

In this connection, the following guidelines are issued for following by the retired pensioners of BSNL who are opting for CGHS Scheme:

- 1. The prescribed form obtained from CGHS authorities is to be filled up.
- 2. The existing BSNL MRS Card is to be surrendered to DE/SDE Admn or HQrs of the unit and the surrender certificate to be obtained. The same is to be submitted to CGHS.
- 3. CGHS will indicate the amount to be deposited as onetime payment to CGHS.
- 4. On depositing the amount, CGHS will issue index card for availing ofCGHS facility.
- 5. Copy of CGHS index card and copy of BSNL MRS card surrender certificate to be submitted with a request letter to Accounts Officer of concerned Business Area from where they were availing of MRS facility.
- 6. AO (Cash/Claims) of Business Area concerned is to process for reimbursement of onetime payment made by the retired official to CGHS authorities.

This is issued with the approval of competent authority.

# Subject : Revival of BSNL and MTNL by reducing employee costs, administrative allotment of spectrum for 4G services, debt restructuring by raising of sovereign guarantee bonds, monetization of assets and in principle approval for merger of BSNL and MTNL –reg.

The Union Cabinet in its meeting held on 23.10.2019 considered and approved the proposals of DoT for "Revival of BSNL and MTNL" vide its Cabinet Note dated 22.10.2019.

- 2. The Cabinet, inter-alia, approved the following:
  - (i) Reduction in the employee cost by immediately offering VRS on Gujarat Model (with modifications as per Para 2(ii) below) to the employees of age 50 years and above.
  - (ii) The ex-gratia amount is limited so that total of ex-gratia amount (as per Gujarat Model) and admissible pension for the remaining period of service does not exceed 125 % of the salary that the employee would have drawn on the date of voluntary retirement in the remaining period of the service.
  - (iii) The payment for ex-gratia on VRS (Rs. 17,169 Cr) and proponed pensionary liability (Rs. 12,768 spread over a period of ten years) is to be supported through budgetary allocation of GOI. The ex-gratia on VRS is to paid in two installments of 50% each during FY 2019-20 and during Q1 of FY 2020-21.
  - (iv) Staggered payment of Commutation/ Gratuity to the employees opting for VRS as below :
  - a. For the employees currently more than 55 years of age, on opting for VRS, the pension will be commuted only when they attain 60 years of age (current retirement age). For the employees, currently of age 55 years and less, on opting for VRS, the pension will be commuted in the sixth year i.e. 2024-25.
  - b. Similarly, payment of Gratuity is postponed in the same manner. However, in case of death of the VRS opted before the date on which gratuity is to be paid, the deferred retirement gratuity will be released immediately to the eligible claimants. Simple interest at the prevailing GPF rates from the date of voluntary retirement till the gratuity is released, will be paid on the deferred gratuity amount.
  - (v) Administrative allotment of spectrum to BSNL/MTNL for providing 4G services through capital infusion by the Government. The payment of GST on the spectrum cost will be paid through budgetary support.
  - (vi) Sovereign Guarantee Bonds of Rs. 15000 Cr of tenure of ten years or more to be raised and serviced by BSNL/MTNL for the purpose of debt restructuring.
- (vii) Monetization of land/building assets following DIPAM guidelines for asset monetization. The proceeds of asset monetization will be credited to BSNL/MTNL to service the debt, CAPEX and other requirements. The progress of asset monetization will be reviewed by a committee formed under the chairmanship of Pr. Advisor to Hon'ble Prime Minister with Cabinet Secretary, Secretary (DEA), Secretary (T), Secretary (DIPAM) and Secretary (MoHUA) as members.
- (viii) Monetization of tower and fiber assets using an appropriate model including leasing after considering the market conditions with the aim to maximize the returns.
- (ix) In principle approval for merger of BSNL and MTNL as per relevance rules/guidelines of Gol. Meanwhile, MTNL to be made subsidiary of BSNL by transferring the Government shareholding of MTNL to BSNL to derive the synergy in network operations and sales till the merger is completed. CMD BSNL & CMD MTNL and administrative heads of all wings of DoT are requested to take note of the above Cabinet approval and take immediate steps for strict and time bound compliance of the same.

### Sub: BSNL Voluntary Retirement Scheme- 2019 – Notification of the scheme and circulation of guidelines to facilitate the exercise of option by employees.

#### Sir,

In pursuance to the decision of the Union cabinet conveyed by DOT vide OM No. 30-04/ 2019-PSU Affairs dated 29.10.2019, I am directed to circulate herewith the "BSNL Voluntary Retirement Scheme-2019" as per **Annexure-I** for information of all concerned and to invite options from employees eligible under the scheme for seeking voluntary retirement as per the provisions of this 'scheme'.

- Options for seeking voluntary retirement under this 'scheme' shall remain open from 04.11.2019 up to 03.12.2019 (5:30 P.M.). The effective date of voluntary retirement under this scheme will be 31.01.2020(A/N).
- 3. Employee seeking voluntary retirement under this scheme shall give option in ERP/ ESS portal and take physical printout. Physical copies in triplicate signed by blue ink by the employee concerned shall be submitted to the concerned administrative office within three days of giving option in ESS.
- 4. You are requested to give wide publicity to this Scheme to enable all the eligible employees to take an informed decision and exercise the options for YRS within prescribed time period.
- 5. To facilitate the process, it is, therefore, requested to take following steps for effective implementation of VRS:
  - a. A '**Help-Desk**'with Computer and ESS connectivity be set up at Circle Office and SSA/SDCA level manned by suitable officer who will provide information and technical assistance to employees to exercise options for this Scheme within time period prescribed.
  - b. The Controlling Officers at respective levels (Circle/SSA/Smaller Units) be asked to make the employees, under their administrative control, aware of this scheme, and assistance be provided in exercising the options for VRS within the prescribed time period.
  - c. The employees who are on deputation to other organizations or on authorized long leave or deputed for training in other organization, may be communicated with a copy of this Scheme. Such officers may be provided with necessary assistance for exercising options for this Scheme within the time period and they may be asked to submit duly signed hard copies (in triplicate) of their option to their Administrative Unit. The respective Administrative Unit, in turn, will process their case and intimate the concerned borrowing organizations to repatriate the officer latest by 31.12.2019 who opts for this Scheme.
  - d. The Administrative Office of the employee will acknowledge the receipt of hard copy of VRS application to the optee under signature of an officer not below the rank of SDE / AO level.
  - e. The Officer in charge of Service Books is required to verify the correctness and completeness of the entries made by the employees on the VRS option form. If any discrepancy is found, the same may be rectified by the HR administrator in consonance with the service book record, both on ERP as well as the hard copy.
  - f. Upon successful completion of verification of Option form, the process for vigilance clearance be initiated online by the Administrative Office within two days, and the Vigilance Branch will intimate VC status to the Administrative Office, also within two days.
  - g. On receipt of vigilance status, Administrative Office will process the case for acceptance of VRS by the Competent Authority, who will decide the case within a week's time keeping in view the provisions as mentioned in clause 7 (ii) of the VRS Scheme 2019.
  - h. The employees who are on unauthorized absence and/ or absconding are not to be allowed to exercise the options for this Scheme. Disciplinary action may be initiated against such employees immediately, or complete the proceedings, if on going.

- 6. Additionally, you are also required to arrange to place Bill Boards at Circle Office, Zonal Office, District Office or any other prominent locations indicating the salient features of VRS.
- 7. You are requested to conduct open house sessions at Circle/SSA/SDCA levels to provide maximum awareness to the employees enabling them to take an informed decision.
- 8. You are requested to make team of members who will drive this scheme to the lowest level. A copy of Step by Step guide for exercising option by the eligible employees for this scheme is enclosed as **Annexure-II**.

#### Subject : Revamping of Central Government Health Scheme.

#### Ref: Your No. Z15025/78/2019/DIR/CGHS Dated 9<sup>th</sup> October, 2019.

#### Respected Sir,

We first of all offer thanks to DOH&FW for considering some of the issues recently and issuing the guidelines about "Direct consultation from specialist in respect of pensioners aged 75 years", "Clarification regarding issue of medicine prescribed by specialists "etc. We are happy to submit the following suggestions for Revamping of Central Government Health scheme.

- 1. During last Seven years, the Cities having CGHS facilities have been remarkably expanded. CGHS facilities have been extended to BSNL/MTNL pensioners also. We observed the following.
  - a) Wellness Centres , Doctors are not made available to the extent of expanded areas of the cities.
  - b) In Pune, the pensioners aged 80 years and above have to travel 7 to 10 Kms to reach the earmarked Wellness Centre.
  - c) It is observed that the Medicines, prescribed by the Wellness Centre-Doctor, are not available on the same day. The pensioner suffering from ailment has to visit twice or thrice to the Wellness Centre to collect the medicines.
  - d) Due to the increase in the no of CGHS beneficiaries in the suburban of Mumbai, CGHS decided to open CGHS Wellness Centre at Kalyan but they could finalize the accommodation as yet. The pensioners have to travel to Thane or Ambarnath to reach Wellness Centre to get the Outdoor treatment.
  - e) In spite of justified no of beneficiaries in and around Panvel-Navi Mumbai Area, CGHS Wellness Centre is not available in the area. Department of Post and the Postal Service Union have also demanded the CGHS facilities in the area. It is understood that accommodation for Wellness Centre, may be made available in the space owned by Department of Posts.

#### Suggestions:

a) We suggest that "Wellness Centre should be within the radius of 5 Kms from the cluster of CGHS beneficiaries and If Wellness Centre is found justified It should be opened on priority basis. In the interregnum, CGHS authority may empanel the Hospital in the locality within 5 kms. on urgent basis."

- b) We suggest that the opening of CGHS Wellness centre at Kalyan may be expedited.
- c) We suggest that the opening of CGHS Wellness centre at Panvel-Navi Mumbai may be reviewed and accommodation available with Department of Post may be considered.
- d) The proposal for providing CGHS facilities at Hubbali-Dharwad (Karnataka State) is pending in the Department of Health & Family Welfare.

Govt. Of India declared Belagavi city as Smart city. We suggest that CGHS facilities may also be extended to Belagavi.

- e) When there is a requirement of Two Doctors in the CGHS Wellness Centre, It is suggested that One of them may be Lady Doctor.
- f) We suggest that If the Medicine is not available in the Wellness Centre, the pensioner may be allowed to collect the medicine on the same day, from the nearby authorised shop, who will supply the medicine and submit the bill to the Wellness Centre. This is followed in the CSMA facility.

#### 2. Health Insurance Scheme:

Sixth Central Pay Commission and Seventh Pay Commission recommended the Health Insurance Scheme for Central Government employees and pensioners including those residing in NON-CGHS area. On 12<sup>th</sup> July 2016 Minister of State of Health & Family Welfare answered in the Loksabha that the Department of Health & Family Welfare has prepared the Draft of Health Insurance Scheme and sent to MOF, Department of Expenditure for approval. As per the minutes of SCOVA meeting held on 5<sup>th</sup> September, 2019 A revised EFC memo has been sent o Department of Expenditure in April, 2019.

#### Suggestions:

- a) We suggest that Department of Health & Family Welfare may pursue the approval of Health Insurance Scheme for Central Government employees and pensioners including those residing in NON-CGHS area.
- b) We suggest that CGHS should empanel the Hospitals at the District Level for the benefit of the pensioners residing in the NON-CGHS area. In this way CGHS facilities (to provide IPD treatment on cashless basis) may be extended to all District headquarters till the Introduction of Health Insurance Scheme. The proposals for CGHS Hospitals at Nashik and Sangli have alredy been moved earlier.

We had brought some of the issues vide our letter cited above in the reference. Now CCA Maharashtra & Goa has rolled out the CPMS on 24<sup>th</sup> May, 2019 for the retired employees from BSNL and receiving Pension from Banks. On the introduction of CPMS the Banks don't get the EPPO and the Pension is directly credited through NEFT to the Saving Bank Accounts by CCA, Maharashtra. Due to this change Pensioners are facing the following issues.

- 1. Regarding Submission of Annual Life Certificates: The pensioners are required to submit the Life Certificate, in the month of November each year. Banks are telling that hereafter the pension distributing authority will be CCA Maharashtra. For Submission of Online Digital Life Certificate, Jeevan Pramaan App do provide for Pension Distributing Authority as ' Department of Telecom.' But 'CCA Maharashtra' is not available in the list of Distributing Agencies in the App.
- 2. Certificate from Pension Distributing Agency for CGHS: CGHS facility is extended to BSNL Pensioners. The Application for CGHS is to be submitted along with the Certificate from Pension Distributing Agency. Now Bank says, 'As CCA Maharashtra is PDA now, the certificate may be obtained from them.' The format of the Certificate is enclosed herewith for your information.
