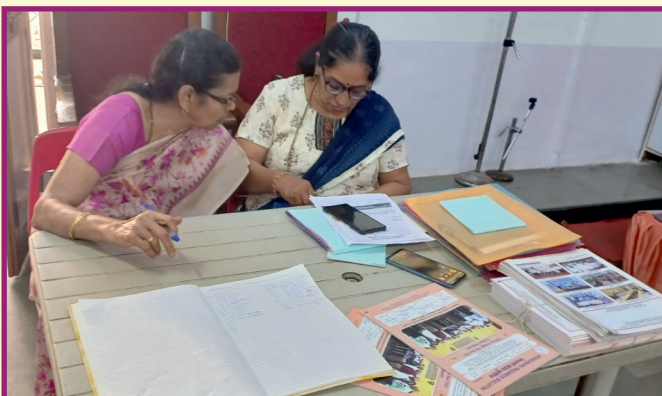

## GS SPEAKS

In a major development for government employees, Cabinet approved the formation of Eighth Central Pay Commission on 17<sup>th</sup> January, 2025. The move has been awaited by over one crore central government employees and pensioners, CWC Meeting of AICGPA Hq Pune was held on 03-03-2025 at Pune. The items for Agenda of SCOVA meeting and Items for inclusion in the Terms of reference for Eighth CPC were discussed and finalized. Which are addressed to Secretary, DOP&PW for inclusion in the Terms of reference for Eighth CPC.

Passed in Lok Sabha on 25th March 2025. The legislation regarding Validation of the CCS (Pension) Rules and Principles for expenditure on Pension liabilities from the Consolidated Fund of India was passed in Lok Sabha on 25.03.2025 as part of the Finance Bill, 2025. The validation legislation validates the principle that without prejudice to the Pension Rules, the Central Government has the authority to establish distinctions among pensioners as a general principle and that a distinction may be made or maintained amongst the Pensioners, which may emanate from the accepted recommendations of the Central Pay Commissions, and in particular the distinction may be made on the basis of the date of retirement. The legislation has been made effective from 1.6.1972 thereby validating all Rules made under Article 309 of the Constitution for CCS (Pension) Rules, 1972, CCS (Pension) Rules, 2021, CCS (Extraordinary Pension) Rules, 2023 including all instructions issued thereunder as amended from time to time.

Raising a point of order Kerala MP K C Venugopal demanded that the government clarify its underlying intent in amending pension rules to differentiate between pensioners. There was a protest from all existing pensioners/Pensioners Associations.

Speaking in Rajya Sabha on 27<sup>th</sup> March, 2025, the Finance Minister clarified that all Central government pensioners who had retired before January 1, 2016 are receiving pension at par with employees, who retired after January 1, 2016. There will be no change in pension for defence as well as Central government pensioners due to validation of existing rules. She further added that validation of existing rules was done in view of the recommendations made by the 6th Central Pay Commission (CPC) to ensure a distinction among pensioners. She said that it is not an amendment to any pension Rules or instructions but only a reaffirmation of the same with effect from June 1, 1972, i.e. the date the CCS (Pension) Rules were promulgated. The 6th Central Pay Commission made a distinction between the retirees of pre-1.1.2006 and those of post-1.1.2006 periods. The then-Government had accepted the recommendations of 6th Central Pay Commission and decided that there will be a distinction between pensioners with reference to the cut-off date of 1.1.2006. The 7th Central Pay Commission has brought in parity between pre 1.1.2016 and post 1.1.2016 Pensioners. I again reiterate that this is only a Validation of existing rules.

Virtual CWC meeting held on 31st March, 2025 decided unanimously that it is too early to take decision to organize demonstration/Agitation program. We may wait for the clarification from Secretary (Pension). Based on the Clarification, we should write to Hon'ble Finance minister and Secretary (Pension), DOP&PW to confirm their position regarding continuation of pension revision as per the recommendations of 8th CPC. we may go for Post card campaign for insisting protection of Pension revision to the pre-2026 pensioners while giving terms of reference to 8 CPC.

DOP&PW conducted the virtual meeting on 29<sup>th</sup> March, 2025, with NJCM Secretary/ members and Identified Pensioners Associations under the chairmanship of Secretary(Pension), Shri V. Srinivas. Responding to the apprehensions, fear and anguish, Secretary Pension clarified that it will not affect the revision of pension of pre-2026 pensioners as per recommendations of 8<sup>th</sup> CPC and agreed to issue a clarification.

Hon'ble Minister of Finance, Smt Nirmala Sitaraman presented the Budget for 2025-26 on 1<sup>st</sup> February. There is no change in INCOME Tax slabs/rates under Old regime, where pensioners get the exemptions / deductions for Savings under 80C and exemptions on Interest etc. **Under the new Tax regime**, No income tax payable upto income of Rs 12 lakh (other than special rate income such as capital gains) This limit will be Rs 12.75 lakh for salaried tax payers, due to standard deduction of Rs 75,000.

You are aware that DOPT has issued the instructions dated 14-10-2024 in compliance of the interim orders of Hon'ble Supreme Court dated 06.09.2024 in MA Dy. No. 2400/2024 and advised to allow the increment on 1<sup>st</sup> July/1<sup>st</sup> January to the Central Government employees, who retired/are retiring a day before it became due ie. on 30<sup>th</sup> June/31<sup>st</sup> December. Grant of notional increment is also extended to DOT employees absorbed in BSNL/MTNL who retired/are retiring a day before it became due in any month of the year. The effect of notional increment will be given to third parties(who have not approached to the COURT) and counted for pension only. The revised pension by taking into account the notional increment will be given wef. 01.05.2023.

34<sup>th</sup> SCOVA meeting was held under chairmanship of Dr. Jitendra Singh, Hon'ble Minister Of State(PP) at Vigyan Bhawan, New Delhi on 11<sup>th</sup> March, 2025. I participated actively in the discussions. Most of the items of our agenda are discussed and decided in our favor. The minutes issued by DOP&PW are printed on page no. 5.

Circle Level Postal Pension Adalat for Postal pensioners was held under Chairmanship of Smt. Ms. Jayati Samaddar, GM Finance. 05/03/2025., Shri Ramachandran. P, Sr. Account Officer was present. We raised the long pending issue of non consideration of TBOP/MACP Promotion, Stepping up of pay and disciplinary cases involving policy matters and cases pending for review of DPC will not be considered in Pension Adalat as notified in the notice of adalat issued by CPMG. On behalf of our Association, we welcomed Shri. Amitabh Singh CPMG Maharashtra circle with bouquet followed by introduction of Association in detail.

In the afternoon We met Ms Geetha Anandan, Addl. Director CGHS, Mumbai and sorted out the issue of nomination of our members on ZAC/LAC in place for Mumbai CGHS.

The Pension Adalat for BSNL/DOT Pensioners was conducted by CCA, Maharashtra & Goa at Pune on 25<sup>th</sup> March, 2025 at 11 am followed by meeting with Pensioners Welfare Association at 2.30pm.

The case of Pension Revision in Delhi High Court was listed on 11<sup>th</sup> March, 2025. Due to the paucity of time, the matter could not be heard on that day. The next hearing of the matter is fixed on 22<sup>nd</sup> April, 2025. Joint forum has addressed a letter for grant of meeting to discuss the burning issue of non revision of pension of BSNL/MTNL pensioners with effect from 01.01.2017. We have requested for inclusion of Pension revision of BSNL/MTNL pensioners in the terms of reference of 8<sup>th</sup> CPC addressed to Secretary.

**Please find enclosed herewith** the minutes of the 34th Meeting of Standing **Committee** of Voluntary Agencies (SCOVA) held under the Chairmanship of Hon'ble MoS (PP) on 11.03.2025 at Vigyan Bhawan, New Delhi.



**Minutes of the meeting of 34th SCOVA held on 11.03.2025 under the Chairmanship of Hon'ble MOS (PP) at Vigyan Bhawan (Annexe)**

34th meeting of the Standing Committee of Voluntary Agencies (SCOVA) was held on 11.03.2025 under the Chairmanship of Hon'ble MOS (PP) at Vigyan Bhawan (Annexe) with members of Pensioners' Welfare Associations and representatives of different Ministries/Departments. List of participants is annexed.

2.The meeting was attended by Secretary (pension), Controller General of Accounts and other senior officers from various Ministries/Departments including Ministry of Defence, Ministry of Railways, Ministry of Health and Family Welfare, Department of Expenditure, Department of Personnel and Training, Department of Telecommunications, Department of Posts, Department of Financial Services, CPAO, bank officials from J&K bank and Indian bank, officials from DoPPW and members of 13 Pensioners' Welfare Associations.

**3.At the outset. Secretary (Pension) welcomed the Hon'ble Minister and other participants in the SCOVA meeting for a fruitful discussion on agenda items for the meeting.**

**4.Joint** Secretary (Pension) made a brief presentation on the various initiatives taken by the DoPPW for easing the difficulties faced by the pensioners and their general welfare including **the 100 days' action plan of the Department and other** achievements during the last one year. He also presented the future road map of the Department which includes digital empowerment of Pensioners, integration of Bhavishya portal with eHRMS and CGHS and timely redressal of Pensioners' grievances.

5.Thereafter, the deliberations were initiated on the new agenda items categorised into four parts viz. CGHS facilities, SPARSH portal of MoD, Pension Policy and other issues etc. which were taken up one by one for discussion by the SCOVA members.

**I. CGHS ISSUES**

**Issue - CGHS-Infrastructure** and Posting of Manpower

**Pensioners' Associations from Pune, Jammu, Bengaluru, Chennai, Balasore and Nagpur raised various issues related to CGHS which include:**

- Adequate manpower posting at all Wellness centers(WCs)
- Opening of new WCs at Pune, Bengaluru, Balasore, Nagpur, (Chennai, Puducherry and Jammu)
- Opening of a polyclinic at Jammu with testing lab facilities
- In addition to the empanelled labs already available, setting up of a diagnostic lab
- Timely payment of bills of the vendors
- Empanelment of private hospitals at the district H.Q. (Pune and other places) under CGHS
- Continuous supply of life saving medicines
- Extending the services of CGHS to employees of the Central Government offices which may have been closed on account of administrative restructuring
- Reduction of delay in release of medical reimbursement claims
- Improvement of the existing infrastructure like buildings and facilities of WCs (Chennai, Bengaluru and Nagpur)

**Discussion/Decision on agenda item**

·DG CGHS informed that the proposal for recruitment of manpower for CGHS Wellness Centres is in active consideration through Staff Selection Commission(SSC) and the issue of manpower shortage would be resolved soon.

·DG CGHS was requested to consider the issues related to upgradation of existing WCs, improvement of infrastructure and manpower on priority as per the availability of resources

·The issue of empanelment of private hospitals without opening of WCs, being a policy matter was decided to be examined separately.

·CGHS was requested to examine the need of opening of new WCs in States/UTs after assessing the requirement based on the present population/beneficiaries at a place.



- CGHS was requested to consider opening of a Polyclinic with a testing lab facility at Jammu.
- Emphasis was given to consider maintaining continuous supply of life saving drugs in the WCs based on previous demands rather than just based on demand of indent.

**(Action: Ministry of Health and Family Welfare/CGHS)**

## **SPARSH PORTAL RELATED ISSUES**

**Ex-Servicemen Welfare League, Pensioners' Associations from Pune and Chennai** raised the issues being faced by Defence pensioners after migration of pension accounts from bank to SPARSII portal of Mot/ The issues of payment of additional pension, restoration of commutation of pension etc. were highlighted. The issue related to Digital Life Certificates(DLCs) especially for pensioners residing in foreign countries was raised. The Pensioners also raised the issue of One Rank One Pension (OROP).

### **Discussion/Decision on agenda item**

Jt. CGDA, MOD briefed about the benefits of SPARSH and its hassle-free transition for the new pension cases. She however, agreed that difficulties were being faced in the older cases where incomplete data was maintained with the banks. It was informed that the existing physical method of submission of DLC is also available along with other digital modes for Pensioners. It was also informed that for those Pensioners residing abroad, the provision for submission of DLC through Indian Embassies is already available. However, the matter of facilitation of submission of DLCs through other digital modes is also being explored.

It was directed to MOD to issue FAQs on the issues being raised by Pensioners on migration of their pension disbursement from bank to SPARSH to increase their awareness and redressal of their grievances.

It was decided that OROP related policy matters may be taken up separately with Department of Expenditure.

**(Action: MOD/Controller General of Defence Accounts)**

## **PENSION POLICY**

### **(i) Issue: Restoration of commutation period from 15 years to 12 years:**

The 5th Central Pay Commission (CPC) and various state governments recommended for reducing the recovery period for commuted pension from 15 years to 12 years to align with changing economic conditions. With the decrease in RBI interest rates, the current 15-year recovery period leads to excess recovery. Reducing the period to 12 years will ensure fairness and better matches the impact of lower interest rates on pension calculations.

### **Discussion/Decision on agenda item**

It was informed by Department of Expenditure that this issue may be included in the Terms of Reference (TOR) of 8th Pay Commission.

**In view of the above, the item was closed.**

### **(ii) Issue: Laying down Standard Operating Procedure (SOP) for streamlining the process of starting of Family Pension:**

Pensioners' Association raised the issue of difficulties being faced by family pensioners for grant of family pension after death of pensioner/family pensioner. They, therefore, requested to issue a Standard Operating Procedure (SOP) for streamlining the process of starting of Family Pension.

### **Discussion/Decision on agenda item**

It was informed by DoPPW that comments have been sought from banks, CPAO and other concerned Ministries/Departments on the question of a Standard Operating Procedure for grant of family pension. **DoPPW in consultation with other stakeholders will issue instructions in this regard. (Action: DoPPW)**

**(iii) Issue : Notional Increment in pursuant to Judgement of Hon'ble SC:** The notional increment granted on 1 st July/1st January for pension calculations, as per the Supreme Court/CAT decision, should be extended to all eligible employees, including those who retired on 30th June 2006 or 31st December 2006. This group of Pensioners, who had the requisite qualifying service, should not be excluded from receiving the

benefit of the notional increment. A new Office Memorandum (OM) is requested to ensure the implementation of this provision for these retirees.

**Discussion/Decision on agenda item**

it was informed that necessary instructions have been issued by DOPT on grant of Notional Increment due from 1st Jan I I st July to those who retired on 30th June or 31 st December respectively after its finalisation by Hon'ble Supreme Court.

**In view of the above, the item was closed.**

**IV. OTHER ISSUES**

**i) Issue : Increase in the Grant-in-Aid to PWAs:**

Requests have been made For an increase in the annual budget to account for inflation and rising operational costs. This includes adjusting the salary of the computer operator to align with Jharkhand Government rates (Rs. 16,000/- to Rs. 18,000/-), as well as providing additional funding for electricity bills, stationery, computer maintenance, and the salary of an office boy. The proposal highlights the valuable social welfare initiatives being provided, particularly those supporting tribal women and environmental work.

Some Associations raised the issue of including the TA expenditure in heads of expenditure from CIA.

**Discussion/Decision on agenda item**

It was informed that the proposal of increasing the Grant-in-aid from existing Rs. 75000/- to Rs. 5,00,000/- per annum per association has been approved by DOI /IFD.

The process for payment for enhanced grant in aid to PWAs from next financial year is being finalised.

It was informed that the heads of expenditure from GIA is also being discussed by a committee and this would be kept flexible.

**(Action: DoPPW )**

**(ii) Issue : Physical verification at the time of starting of Additional Pension by. J & K Bank:**

The issue was raised by Pensioners' Association of Jammu that Pensioners in J&K are required to appear in person for verification before receiving additional pensions after 80 years, unlike other nationalized banks. Additionally, the process for changing pension banks is slow and needs simplification.

**Discussion/Decision on agenda item**

It was informed by the Representative of J&K bank that the existing process being followed at district Treasury was on account of the instructions by the state government prior to 2016.

In order to facilitate the Pensioners, J&K bank further informed that they had already provided the services of Bank employees making personal visits to the respective pensioner and furnish details to the treasury in order to avoid physical presence.

However, **the** Treasury has now agreed to delegate the power to the banks to certify and henceforth, **in J&K, the** same procedure as followed in other states with regard to verification will be followed

**In view of the above, the item was closed.**

**(iii) Issue Integration of Indian Bank with Bhavishya Portal:**

Pensioners' Association, Chennai raised the issue of integration of Indian bank with Bhavishya portal which is preventing the pensioners from downloading pension slips and Form 16.

**Discussion/Decision on agenda item**

It was informed that DoPPW is already **in** the process **to** integrate, all bank portals with Bhavishya. Some banks have already been integrated.

The Indian Bank representatives informed that the matter of integration with Bhavishya portal is under active consideration and would be completed soon.

**In view of the above, the item was closed.**



**(iv) Issue Fixed Medical Allowance (FMA):**

Increase in the Fixed Medical Allowance (FMA) to Rs. 3000 per month, as the current allowance is insufficient due to rising medical costs, as recommended by the Parliamentary Standing Committee.

**Discussion/Decision on agenda item**

It was informed by Department of Expenditure that this issue may be included in the Terms of Reference (TOR) of **8th** Pay Commission.

**In view of the above, the item was closed.**

**(v) issue SAMPANN portal of DOT**

Pensioners' Associations from Pune and Odisha raised that the implementation of the Comprehensive Pension Management System (SAMPANN) should also be extended to Postal pensioners, as it has already been implemented for DOT pensioners.

Associations also raised the concern of reminders sent for updation of DLCs periodically almost every month in the SAMPANN instead of a fixed month which is creating confusion to some of the Pensioners.

**Discussion/Decision on agenda item**

**Jt. CGCA, DOT** informed that DoT had already written to Department of Posts(DoP) in January offering extension of SAMPANN to Postal employees and some other state governments also. Some of the state governments have responded in affirmation. However, response from Department of Posts is awaited.

DoP informed that **the** issue of migration to SAMPANN portal is being examined in the **Department**.

Secretary (**P**) also suggested to DoP to convene a meeting to resolve the issue of migration to SAMPANN or Bhavishya portal as the case may be.

Regarding updation of DLCs, it was clarified by Jt. CGCA, DOT that an additional facility is being provided to the Pensioners to update their DLC in any month of the year as per their convenience. It is only a reminder SMS which is sent periodically to the Pensioners. Nevertheless, it was suggested that the concerns with respect to any technical difficulties faced by **the** Pensioners may be looked into.

**(Action: Department of Posts/Department of Telecom)**

6.The meeting ended with a vote of thanks to the Chair and all the participants.



**MINISTRY OF FINANCE (Department of Financial Services)**

**NOTIFICATION OF UNIFIED PENSION SCHEME**

New Delhi, the 24th January, 2025

**F. No. FX-1/3/2024-PR.** In partial modification of the Ministry of Finance (Department of Economic Affairs) Notification No. F. No. 5/7/2003-ECB&PR dated 22nd December, 2003 and Ministry of Finance (Department of Financial Services) Notification No. F. No. 1/3/2016-PR dated 31st January, 2019, the Central Government has decided to introduce Unified Pension Scheme, as an option under the National Pension System for the employees of the Central Government who are covered under the National Pension System.

**2. The Unified Pension Scheme** shall be applicable to such Central Government employees who are covered under National Pension System and who choose this option under National Pension System. It will have the following features, namely: -

**Eligibility under the Scheme**

(i) Assured Payout shall be available only in the following cases, namely: -

(a) in case of an employee superannuating after qualifying service of ten years, from the date of

superannuation;

(b) in case of the Government retiring an employee under the provisions of FR 56 (j) (which is not a penalty under Central Civil Services (Classification, Control and Appeal) Rules, 1965) from the date of such retirement; and

(c) in case of voluntary retirement after a minimum qualifying service period of 25 years, from the date such employee would have superannuated, if the service period had continued to superannuation.

(ii) Assured Payout shall not be available in case of removal or dismissal from service or resignation of the employee. In such cases, the Unified Pension Scheme option shall not apply.

#### **Benefits under the Scheme**

(iii) Subject to other conditions stated in this notification, Assured Payout under the scheme shall be as follows, namely: -

(a) the rate of full assured payout will be @50% of twelve monthly average basic pay, immediately prior to superannuation. Full assured payout is payable after a minimum 25 years of qualifying service;

(b) in case of lesser qualifying service period, proportionate payout would be admissible;

(c) a minimum guaranteed payout of Rs. 10,000 per month shall be assured in case superannuation is after ten years or more of qualifying service; and

(d) in cases of voluntary retirement after a minimum 25 years of qualifying service, assured payout will commence from the date on which the employee would have superannuated, if he had continued in service.

(iv) In case of death of the payout holder after superannuation, family payout @60% of the payout admissible to the payout holder, immediately before his demise, will be assured to the legally wedded spouse (spouse legally wedded as on the date of superannuation or on the date of voluntary retirement or retirement under FR 56(j), as may be applicable).

(v) Dearness Relief will be available on the assured payout and family payout, as the case may be. The Dearness Relief will be worked out in the same manner as Dearness Allowance applicable to serving employees. Dearness Relief will be payable only when payout commences.

(vi) A lump sum payment will be allowed on superannuation @10% of monthly emoluments (basic pay + Dearness Allowance) for every completed six months of qualifying service. This lump sum payment will not affect the quantum of assured payout.

(vii) The corpus under the Unified Pension Scheme option will comprise of two funds, namely:-

(a) An individual corpus with employee contribution and matching Central Government contribution; and

(b) A pool corpus with additional Central Government contribution.

(viii) The contribution of employees will be 10% of (Basic pay + Dearness Allowance). The matching Central Government contribution will also be 10% of (basic pay + Dearness Allowance). Both will be credited to each employee's individual corpus.

(ix) Central Government shall provide an additional contribution of an estimated 8.5% of (basic pay + Dearness Allowance) of all employees who have chosen the Unified Pension Scheme option, to the pool corpus on an aggregate basis. The additional contribution is for supporting assured payouts under the Unified Pension Scheme option.

(x) The employee can exercise investment choices for the individual corpus alone. Such investment choices shall be regulated by the Pension Fund Regulatory and Development Authority. A 'default pattern' of investment may be defined by Pension Fund Regulatory and Development Authority from time to time.

If an employee does not exercise an investment choice on individual corpus, the 'default pattern' of investment will apply.

(xi) The investment decisions for the pool corpus built through the additional Central Government contribution will solely rest with Central Government.

(xii) In respect of employees who have retired before the date of operation of Unified Pension Scheme and who opt for the Unified Pension Scheme option, Pension Fund Regulatory and Development Authority will



determine the mechanism for making available the top- up amount.

**Explanation:** *For the purpose of this notification basic pay includes non-practicing allowance granted to medical officer in lieu of private practice.*

**3.** The existing Central Government Employees under National Pension System, on the effective date of operationalisation of the Unified Pension Scheme option, as well as the future employees of Central Government can choose to either take the Unified Pension Scheme option under the National Pension System or continue with the National Pension System without the Unified Pension Scheme option. In case an employee chooses the Unified Pension Scheme option, all its stipulations and conditions shall be deemed to have been opted for and such option once exercised, shall be final.

**4.** Once an employee covered under National Pension System, who is in service on the effective date of operationalisation of the Unified Pension Scheme option, exercises the Unified Pension Scheme option, the outstanding National Pension System corpus in the employees Permanent Retirement Account Number shall be transferred to the employee's individual corpus under the Unified Pension Scheme.

**5.** For each employee covered under National Pension System who has exercised the Unified Pension Scheme option, a 'benchmark corpus' value shall be computed, in such manner as may be determined by the Pension Fund Regulatory and Development Authority, with the following assumptions, namely: -

(i) regular receipt of applicable contributions for both the employees and the employer for each month of qualifying service;

(ii) in case of missing contributions, an appropriate value, to be determined by the Pension Fund Regulatory and Development Authority, shall be assigned; and

(iii) investment of such contributions is made as per the 'default pattern' of investment, as defined by the Pension Fund Regulatory and Development Authority.

**6.** The value or units in the individual corpus with investment choices of the employee shall be informed to such employee on a periodic basis. Alongside, the value or units of the benchmark corpus corresponding to the employee, computed as per para 5 above will also be informed to the employee.

**7.** At superannuation or retirement, the qualifying service of the employee under the Unified Pension Scheme option, will be determined by the Head of Office, where he is employed.

**8.** At superannuation or retirement, the employee under Unified Pension Scheme shall authorise transfer of the value or units in the individual corpus to the pool corpus, equivalent to the value or units of the benchmark corpus for authorisation of Assured Payout. In case the value or units of individual corpus is less than value or units of the benchmark corpus, the employee will have an option to arrange for additional contribution to meet this gap. In case the value or units of individual corpus is more than the value or units of the benchmark corpus, the employee shall authorise transfer of value or units equivalent to the benchmark corpus and the balance amount in the individual corpus will be credited to the employee.

**9.** In case the values or units transferred by the employee from the individual corpus to the pool corpus, is less than the value or units of the benchmark corpus, payout proportionate to the assured payout shall be authorised.

**10.** The Unified Pension Scheme, being a 'fund-based' pension system, relies on the regular and timely accumulation and investment of applicable contributions (from both the employee and the employer) for Assured Payout to the employees.

**11.** For the sake of clarity, it is made clear that any employee who has exercised the Unified Pension Scheme option under National Pension System under this notification, shall not be entitled for and cannot claim, any other policy concession, policy change, financial benefit, any parity with subsequent retirees etc. later including postretirement.

**12.** The provisions of Unified Pension Scheme will also be applicable, *mutatis mutandis* to past retirees of National Pension System, who have superannuated before the date of operationalising of Unified Pension Scheme. Such superannuated employees will be paid arrears for the past period along with interest as per Public Provident Fund rates. The monthly top-up amount for such superannuated employees, to be determined by the Pension Fund Regulatory and Development Authority, will be paid after adjusting the withdrawals made

by, and annuities paid to, them.

**13.** The provisions regarding assured payout under the Unified Pension Scheme option for employees facing disciplinary proceedings at the time of superannuation or where disciplinary proceedings are contemplated postretirement, shall be separately notified.

**14.** Illustrative examples as to working of payouts of Unified Pension Scheme under different scenarios are given in the Annexure.

**15.** Pension Fund Regulatory and Development Authority may issue regulations for operationalising Unified Pension Scheme.

**16.** The effective date for operationalisation of the Unified Pension Scheme shall be 1st April, 2025.



## **Report of meeting with GM (Finance),CPMG, Maharashtra Circle**

The 56th Postal Pension Adalat for pensioners/family pensioners of Postal Department was held on 05/03/2025 at 11.00 AM, in the Office of General Manager (Finance), Maharashtra Circle, Mumbai -400 001, under chairmanship of Ms. Jayati Samaddar, GM Finance. attended by S/Shri. N.M.Tikekar, Vice President, H. F. Chaudhari G.S., Manohar Patki AGS and K.S.Kulkarni AGS. From Administration side Shri.Ramchandran, Sr.A.O. was present.

We raised the long pending issue of non consideration of TBOP/MACP Promotion, Stepping up of pay and disciplinary cases involving policy matters and cases pending for review of DPC will not be considered in Pension Adalat as notified in the “notice of adalat issued by CPMG.

G.M.(Finance) agreed to remove this restriction keeping only legal portion in the notice.” “She has also agreed to issue the minutes for the meeting.

Regarding Notional increment in case of the pensioners who have not approached to the Court (Third parties) as per DOPT order dt. 14.10.2024, We requested that , instead of asking pensioners to apply for the same, administration should try at par with CPMG Karnataka procedure, for which administration replied favourably and asked us to supply the copy of same.

Regarding the pensioners who have gone to court (CAT) and awarded favourably. After speaking with DOP Establishment section, It is learnt that clarification is expected from DOPT. While discussing the issue with GM (Finance). Regarding preservation period of service book of 5 years after retirement, we said it should be permanent record for which GM (Finance) responded positively. Today’s Pension adalat received only two cases, which were resolved. Adalat concluded with thanks.

We had a informal meeting with Shri. Amitabh Singh, CPMG Maharashtra circle in his chamber.

As First meeting we welcomed Shri. Amitabh Singh CPMG Maharashtra circle with bouquet followed by introduction of Association in detail. we discussed the issue of Pension Adalat and Notional increment. Meeting was cordial one.

We also met Shri. Abhijeet J. Bansode, Director Postal Services (HQ) Mumbai. Regarding CGHS, DPS suggested the enhancement of CGHS rates at par the Health Scheme exist for Defence pensioners. while discussing the issue regarding allotment of accommodation in place of Mint Colony CGHS dispensary, he informed us that allotment of place at Dadar is not feasible but they are trying to give in some other place.

We are thankful CPMG Maharashtra Circle, G M Finance and DPS for sparing time and listening to our demands.

## **Report of Meeting with Additional Director CGHS, Mumbai held on 5th March-2025 at 14.30 hrs**

S/Shri. N.M.Tikekar, Vice President, H.F. Chaudhari G.S., Manohar Patki AGS and K.S.Kulkarni AGS had a scheduled meeting with Ms.Geetha Anandan Additional Director Mumbai.

As per our Agenda, The issue of nomination of association members on Local/Zonal advisory Committee was taken. She replied now a days number of associations is increasing and there are limitation for nomination



and they are going with the constitution. We brought into her notice the status of our association as Identified Pensioners Association and also a SCOVA member. Finally She agreed to include the name of Association member in ZAC as well as LAC.

While discussing the issue of opening of CGHS dispensaries, Additional director informed us that the issue of opening of CGHS dispensary at Vasai, Panvel and Panjim is in active consideration and requested us to supply the number of CGHS beneficiaries in these dispensaries. The meeting was cordial one. We thanked the A.D. CGHS for cooperation.

**Subject : Standard Operative Procedure for transition to online mode for processing of permission for respiratory devices such as CPAP, BIPAP and Oxygen Concentrator**

The processing of permission for respiratory devices such as CPAP, BiPAP and Oxygen Concentrator in respect of CGHS pensioner beneficiaries is currently in offline mode, starting from submission of physical documents in Wellness Centre by the beneficiary to physical transport through dak to Office of Additional Director to submission of physical file to O/O Additional Director (Reimbursement and Hospitalization) CGHS (HQ), sending to Committee of Respiratory Medicine Specialists for opinion regarding admissibility of the respiratory device and finally the physical file travelling back to the concerned Additional Director for physical letter to be issued to the pensioner beneficiary. The entire process takes anywhere between 15 to 45 days or longer, during which time the pensioner beneficiary often has to rent these respiratory devices, the cost of which is not reimbursable.

In order to expedite the processing of these critical respiratory devices and provide relief to the beneficiaries, it has been decided to transition the processing of permission for such devices, to an end-to-end online mode as follows:

1. At the Wellness Centre, the application for permission to purchase the respiratory device complete in all respects, as per the attached check list at Annexure A including the duly filled and endorsed proforma for the respiratory devices annexed as Annexure B, C, D along with affidavit (Annexure E) (all Annexures are also available on CGHS website) shall be scanned and emailed to the Office of the concerned Additional Director of Zone and city.
2. In case high speed scanners are not available in the Wellness Centre at present, physical documents for the said permission shall be sent through dak to the Office of Additional Director within a day or two of receiving the application. Additional Directors shall procure high speed scanners for every Wellness Centre so that maximum possible dak including requests for permissions can be emailed to Office of Additional Director. Besides expediting the processing of permissions for beneficiaries, this would also be a step forward in enabling end-to-end ebill processing.

The concerned section in the Office of Additional Director shall, on priority, scrutinize the application for permission to purchase respiratory devices received through email/dak for any deficiency. Any deficiency shall be communicated the same day to the beneficiary telephonically and through email for fulfilment. **The application complete in all respects shall then be put up in efile with all relevant documents hyperlinked, by the concerned section in the Office of Additional Director of city/Zone.**

The **subject matter of efile shall include the name of the beneficiary and the Beneficiary ID. All respiratory devices henceforth issued to the particular beneficiary shall be put up in the same efile.** This shall enable maintenance of an electronic record of permissions issued to the beneficiary.

5. An excel sheet having the Computer Number of the efile, name and Beneficiary ID of the beneficiary, name of device and the details of permission issued may be maintained separately in the concerned section dealing with permissions in the Office of the Additional Director, **for ease of tracking the efile.**

6. The efile shall be sent to the Office of Additional Director (Reimbursement and Hospitalization), CGHS (HQ) (directly by Delhi Additional Directors and through ADDG by outside Delhi cities) for forwarding to the Committee of Respiratory Medicine Specialists. **The recommendation of the Committee shall be uploaded in efile** and sent back to CGHS HQ and subsequently to the concerned Additional Director of the city/Zone. (In cities where a similar Committee of Specialists exists locally, they may continue sending the requests for permission for respiratory devices to their local Committee).
7. **The letter addressed to the beneficiary, conveying the recommendation of the Committee (recommended/rejected) shall be issued through eOffice, duly digitally signed by the Additional Director.** The soft copy of the permission shall be emailed to the beneficiary through his email ID or collected as a physical copy by the beneficiary as per his convenience.

**Subject: Grant of notional increment to absorbed of BSNLIMTNL who retired/are retiring a day before it became due in any month of the year, for the purpose of calculating the pension admissible — reg.**

Sir,

I am directed to refer to the subject mentioned above and to forward DoT OM No.38-45.12024-Pen(T) (Part-1) dated 22.01.2025 conveying its decision to extend the benefit of notional increment for pension to the absorbed employees of BSNL, who retired/are retiring on superannuation a day before it become due in any month of the year, for necessary action. The conditions stipulated in the said OM dated 22.01.2025 shall be followed scrupulously while allowing notional increment in cases covered under the ambit of DoT OM dated 22.01.2025.

2.in this regard, it is intimated that the benefits flowing out of the DoT's decision for grant of notional increment for pension is to be allowed by the concerned CCAs. Hence, the Circles/Units are requested to forward the notional increment cases to concerned CCAs.

3.The Circles/units shall prioritize the **cases** of such retired employees, who have got favourable orders from the Hon'ble Central Administrative Tribunal for grant of notional increment. and such cases along **with** orders of Hon'ble Tribunal may be sent to CCA for further action as per DoT OM dated 22\_01.2025. Further, the matter may be pursued with CCA for early implementation of orders of Hon'ble Central Administrative Tribunal.

4.In some cases, the retired employees, who have been allowed notional increment by the Hon'ble Central Administrative Tribunal, have also filed Contempt cases. **In** contempt cases, a compliance report may be filed immediately after sending the cases of notional increment to **concerned A**. In cases where there is any order for personal appearance of CM D, BSNL or CGMS concerned or **any other authority**, a prayer may also be made for dispensing from personal **appearance citing the compliance of orders of Hon'ble Tribunal**.

5.With regards to other pending court cases on Notional increment, suitable reply may be filed before the appropriate Tribunal/Courts to dispose of the cases after taking action as per above-mentioned DoT OM dated 22.01.2025.

6.This issues with the approval of the Competent Authority.

**Subject : Grant of notional increment to absorbed employees of BSNL/MTNL who retired/are retiring a day before it became due in any month of the year, for the purpose of calculating the pension admissible — reg.**

The undersigned is directed to refer to the subject cited above and to say that the matter of grant of notional increment to the absorbed employees of BSNL/MTNL has been examined in consultation with DoP&T and DoP&PW.

2. It has been decided that notional increment will be extended to the absorbed employees of BSNL/MTNL also who retired/are retiring a day before it became due in any month of the year. Notional increment shall be reckoned only for the purpose of calculating the pension admissible and not for the purpose of calculation of other pensionary benefits. Notional increment will be given to only those employees who completed one year of qualifying service as on the date of their superannuation with satisfactory work and good conduct for calculating the pension admissible to them, subject to the conditions as per Interim Order dated 06.09.2024 of the Hon'ble Supreme Court in MA No.2400/2024 filed by M/o Railways along with several intervention application tagged therewith. Hon'ble Supreme Court of India took note of the pending petition (Dy. No. 36148/2024) filed by Union of India seeking review of its order dated 11.04.2023 in CA No 2471/2023 in the matter. While observing that the issue raised in the applications requires consideration in so far as the date of applicability of the judgement dated 11.04.2023 in CA 2471/2023 to third parties is concerned. Hon'ble Court issued the following directions, by way of an interim order, to prevent any further litigation and confusion:

(a) The judgment dated 11.04.2023 will be given effect to in case of third parties from the date of the judgment, that is, the pension by taking into account one increment will be payable on and after 01.05.2023. Enhanced pension for the period prior to 30.04.2023 (erroneously mentioned as 31.4.2023 in the Order) will not be paid.

(b) For persons who have filed writ petitions and succeeded, the directions given in the said judgment will operate as pre judicata, and accordingly, an enhanced pension by taking one increment would have to be paid.

(c) The direction in (b) will not apply, where the judgment has not attained finality, and cases where an appeal has been preferred, or if filed, is entertained by the appellate court.

(d) In case any retired employee has filed any application for intervention/ impleadment in Civil Appeal No. 3933/2023 or any other writ petition and a beneficial order has been passed, the enhanced pension by including one increment will be payable from the month in which the application for intervention/impleadment was filed.

This interim order will continue till further orders of this Court. However, no person who has already received an enhanced pension including arrears, will be affected by the directions in (a), (c) and (d).

3. The action taken on notional increment shall be subject to the final outcome of the Review Petition (Dy. No.36418/2024) pending before the Hon'ble Supreme Court of India.

**Subject : BSNLMRS - Clarifications regarding**

In view of requests for clarifications and standardizing procedure under BSNLMRS following clarifications are being issued herewith :

1. Validity of prescription and purchase of medicine thereof under outdoor medical claim:

i) Validity of the prescription shall solely depend upon the time period for which registered medical practitioner (RMP) is advising medicine(s).

ii) In non-chronic cases, medicines can be purchased for a period of one month at a time.

iii) In chronic treatment cases, medicine may be purchased for three months at a time during the entire treatment period indicating clearly (e.g. six months/one year) on the prescription.

2. Government Hospitals :

i) Vide para 1 of BSNMRS O.M. Dated 8.8.2005, CGMs are empowered to approve the expenditure incurred on the treatment taken in GOvt. Hospitals.

ii) Definition of government hospitals as defined under CGHS O.M. dated 9.10.2020 (ennclosed) and subsequent amendments, if any, is equally applicable under BSNLMRS.

iii) Reimbursement for treatment in government hospitals shall be

a) Full reimbursement for the expenditure on invoices raised by the government hospitals subject to ward/room eligibility of the employee.

b) Reimbursement for implants and any other third party medical services from other private agencies on the advice of treating government doctor shall be restricted to CGHS prescribed ceiling rates.

3. Medical claim from two sources i.e. Insurance company and BSNLMRS:

i) Procedure for reimbursement of two sources has been defined under BSNLMRS O.M. dated 2.9.2009 (copy enclosed)

ii) Eligible amount of reimbursement from two sources i.e. medical insurance of the beneficiary and BSNL shall be restricted as per this office clarification dated 30.8.2022. (enclosed)

4. Rembursement of Artificial appliances and eligibility criteria :

i) Guidelines and rates for Artificial appliances defined under CGHS order no 11011/25/2014 CGHS(P) dated 8.7.2014 (enclosed) is equally applicable under BSNLMRS. However, reimbursement of the artificial appliances will be subject to outdoor medical ceiling of the employee/retiree.

**Subject: Additional Wellness Centers at Pune & Pimpri Chinchwad Area and additional staff at Pune and Wellness Centre at Chhatrapati Sambhaji Nagar(Aurangabad).**

**Respected Madam,**

**On behalf of ALL India Central Government Pensioners Association Hq. Pune an identified Pensioners Association and SCOVA-Standing Meber, We wish you a Happy New Year 2025.** We represent the most of the Central Govt. Pensioners and BSNL Pensioners in Maharashtra. We wish to bring into your notice the justification for Additional Wellness Centers at Pune & Pimpri Chinchwad Area and additional staff at Pune and Sambhaji Nagar(Aurangabad).

At present there are only 9 CGHS Wellness Centres in Pune and Pimpri Chinchwad area. Last Wellness Centre was sanctioned at Pune in the year 1986, when Pune City was having population of 12.03 Lakh and Pimpri Chinchwad was having population of 82000 in 1984.

Pune and Pimpri Chinchwad are expanded since 1986 and spread far and wide covering new areas ie. Kothrud, Nigadi, Lohagaon, Kharadi, Hadapsar, Katraj, and Khadakwasla etc. Due to such huge expansion Government has decided to develop these areas through Pune Metropolitan Region Development Authority(PMRDA) as per notification in 2015. The population of Pune Metropolitan region (covering area of 7256.46 Sq KMs) is 72.76 Lakh and estimated at 73.99 lakh in 2025.

In spite of such expansion and development of these areas, No additional CGHS Wellness center was sanctioned/opened to meet the demand of CGHS beneficiaries resided in the expanded area. On the other hand CGHS Wellness Centre at Deccan Jimkhana was closed due to the reasons known to CGHS. It is

resulted in the difficulties for CGHS beneficiaries residing at Kothrud, Bhusari Colony. They are required to travel 10 to 12 kms to reach CGHS Wellness Centre at Bajirao Road.

On the strong demand of ZAC members, Additional Director, CGHS Pune has sent the proposal to the Director CGHS-Hq. for sanctioning/opening of 5 additional CGHS wellness centers at Kothrud, Hadapsar, Pimpri, Lohagaon and Katraj on 01.05.2024. Copy of Additional Director(CGHS) , Pune is enclosed herewith for ready reference.(Encl. 1)

We suggested the space available at Karve Road Telephone Exchange Building, where CGHS Wellness Centre may be opened. Sanction from CGHS director is awaited.

The Shortage of staff in CGHS was discussed during 33rd SCOVA meeting held at New Delhi on 22/03/2024. But there is no improvement in the situation prevails at CGHS Pune which is facing the shortage of staff of all positions. It is heard that the sanctioned strength of the Pharmacists working in CGHS Pune are reduced from earlier 33 to 27 in spite of increase in the number of CGHS beneficiaries.

**Chhatrapati Sambhaji nagar(Aurangabad):**CGHS had sanctioned/opened the CGHS Wellness Centre, Chhatrapati Sambhaji nagar(Aurangabad) and managed by Doctor 1, Pharmacist 1, Staff nurse 1 and MTS 1. It serves 3650 CGHS beneciarires. The pensioners from nearby districts ie. Buldhana jalgaon,Jalana, Parbhani, Beed are also taking the benefit. Good number of CGHS beneficiaries have to go back at 2 pm, without consultation/treatment. There is a demand of one Ayurvedic dispensary to meet the additional demand. Additional Director is not in a position to meet the demand due to shortage of staff.

**Madam, We hereby request your honor to consider the facts mentioned above and arrange to sanction the additional CGHS Wellness Centers under CGHS, Pune and additional posts for the satisfaction of the CGHS beneficiaries, who paid the required subscription for health services in their old age.**

**Thanking you for your attention to the matter. We look forward to a positive response.**

1. Parliamentary Standing Committee on Personnel, Public grievances, Law and Justice(Report No. 120) was in agreement with the views of Pensioners Associations that Govt. may explore opening of CGHS Wellness Centers at District Headquarters.

2. Some District headquarters are expanded, well developed cities. Sufficient number of Central Govt. employees /pensioners/ BSNL pensioners are residing at the District headquarters. The demand of extension of CGHS facilities at Kolhapur, Sangli-Miraj, Solapur, Nanded, Satara in Maharashtra and Belagavi (Karnataka) are pending at CGHS Directotote.

3. In response to the strong demand from Service/ Pensioners Associations and Hon'ble MP at Kolhapur, CGHS Directorate responded vide letter dated 13-03-204 stating that opening of a new wellness centre involves creation of new posts of staff and has financial implications. For this the approval of the Department of Expenditure is required. It seems they closed the proposal ignoring the huge demand. The copy of the letter of Director, CGHS is enclosed for ready reference.



4. In response to the proposal of opening CGHS Wellness Centre at Sangli-Miraj, Under Secretary, Deptt of Health & family Welfare vide letter in March, 2020, informed the criteria for setting up CGHS Wellness centre ie. Minimum 2000 Cards in existing CGHS City and 6000 cards in new City.

As per the minutes issued by Supdt. RMS, Division Miraj, (Copy of which is enclosed herewith **Encl: 1**) there are 1631 Central Govt. pensioners and 416(357+59) working employees in Postal and RMS division. Our Secretary has also ascertained the no of employees working in the Central Govt offices. **As such there are total 628 Working employees( ie. 416 Postal and RMS division , Central Excise 42, GST 95, Income Tax 35, Prasar Bharati 40) and 1631 Central Govt. pensioners . You may see there is full justification for opening of CGHS Wellness Centre at Sangli-Miraj.**

5. In response to the strong demand from Service employees/Pensioners at Nanded, CGHS Directorate responded vide letter dated 11-09-2024 stating that as per new SIU report opening of new CGHS Wellness Centre involves creation of new posts of staff and has financial implications. Even with creation of minimum posts of staff would involve a recurring expenditure of Rs. 4.2 Cr. per year and one time non-recurring expenditure of Rs. 0.75Cr. to Rs. 1 Cr. For this the approval of the Department of Expenditure is required. The ministry takes a considered view of opening of CGHS Wellness Centers at a new places at an appropriate time. The copy of the letter is enclosed for ready reference. **Encl-2**

6. Secretary AICGPA Hq. Pune, Belagavi Branch addressed a request for extension of CGHS facilities at Belagavi with full justification on the basis of data of Central Govt. Working employees and Pensioners in the Belagavi District. As per data furnished there are 1654 working employees and 3480 pensioners. There will be more than 6000 CGHS Cards, which is the criteria for opening of CGHS Wellness Centre at New City. Even after submission of full justification, CGHS Directorate responded with same statement of Financial Constraint. The copy of the letter from Under Secretary (CGHS Admin) is enclosed herewith for reference. **Encl:3**

**We hereby request your honor to consider the demand of potential CGHS beneficiaries in these Cities and arrange to sanction the additional CGHS Wellness Centers with additional staff. OR**

**After going through the responses received from CGHS Directorate in respect of Proposal for extension of CGHS facilities at Kolhapur , Nanded and Belagavi mentioned above, It is crystal clear that opening of new CGHS Wellness Centre involves creation of new posts of staff and has financial implications and it is not easy to get the approval from Department of expenditure.**

Keeping in view

a) demand of Pensioners Associations and recommendation of Parliamentary Standing Committee on Personnel, Public grievances, Law and Justice (Report No. 120) mentioned in para 1 above,

b) Difficulties faced in opening of new CGHS Wellness Centre involves creation of new posts of staff and has financial implications

We had already submitted the suggestions vide our letter dt. 27/04/2023 addressed to Addl. Secretary, Ministry of Health & Family Welfare, New Delhi as follows.

**Government may review the policy of opening CGHS Wellness Centers to open CGHS Wellness Centers at District Headquarters and Approve only CGHS Empanelled Private Hospitals for providing IPD facility to the CGHS beneficiaries in Non-CGHS area. Under such arrangement, On payment of the requisite subscription of CGHS, Pensioners will have the option to avail CGHS facility of IPD treatment only and Fixed Medical Allowance for OPD treatment as available for outdoor treatment in NON-CGHS area. Bharat Pensioners Samaj had also addressed similar proposal in the year 2023.**

**Madam, We hereby request your honor to consider the request to**

**Sanction the additional CGHS Wellness Centers with additional staff at Ahmednagar, Kolhapur, Sangli-Miraj, Solapur, Nanded, Satara (Maharashtra) and Belagavi (Karnataka) Or**

**Consider the suggestions to review the policy of opening CGHS Wellness Centers at the District headquarters.**

**Respected Sir,**

AICGPA is the oldest Pensioners Association formed by P&T pensioners in August, 1947. Considering its activities, achievements and network, DOP&PW recognized it as identified Pensioners Association and a Standing Group member of SCOVA constituted in September, 2023.

We wish to bring into your notice the orders issued by DOPT and Department of Posts cited under reference above regarding Grant of Notional increment on 1<sup>st</sup> July/1<sup>st</sup> January to the employees who retired from Central Govt. service on 30<sup>th</sup> June/31<sup>st</sup> December respectively for the purpose of calculating their pensionary benefits. Copies of the orders are enclosed herewith for ready reference.

The DOPT vide OM dated 14.10.2024 has advised all Departments to grant Notional increment on 1<sup>st</sup> July/1<sup>st</sup> January to the employees, who are retired /retiring a day before the increments became due to them ie. 30<sup>th</sup> June/31<sup>st</sup> December respectively. These instructions were issued in implementation of the interim order of Hon'ble Supreme Court dated 6.9.2024 in order to prevent further litigation and confusion,

- a) 'The judgment dated 11.04.2023 will be given effect to in case of third parties from the date of the judgment, that is, the pension by taking into account one increment will be payable on and after 01.05.2023.

- b) For employees who have filed writ petitions and succeeded, an enhanced pension by taking into one increment would have to be paid.
- c) The direction in(b) will not apply, where the judgment has not attained finally and cases where an appeal has been preferred or if filed, is entertained by the appellate court.
- d) In case any retired employee has filed any application for intervention/impleadment in Civil Appeal No. 3933/2023 or any other writ petition and a beneficial order has been passed, the enhanced pension by including one increment will be payable from the month in which the application for intervention/impleadment was filed.

Vide Para 8 of the DOPT's letter it was to be noted "these instructions are being issued in compliance of the interim orders dated 06.09.2024 of the Hon'ble Supreme Court in MA Dy. No. 2400/2024 without prejudice to the legal stand of the Union of India in the matter and without prejudice to any change of law in this regard. Further the action taken shall be subject to the final outcome of the Review Petition (Dy. No. 36418/2024) pending before the Hon'ble Supreme Court which is expected to be heard by the Apex Court in the week commencing 04.11.2024."

In the meantime the Hon'ble Supreme Court while hearing the Misc. Application Diary No. 2400/2024 filed on 16.01.2024 UOI Vs M. Siddaraj , heard on 13.12.2024. While adjourning the matter, observed as follows "However, we observe that the applicant Union Of India must comply with the Interim order passed by the court. In case we find non-compliance with the said order in letter and spirit, cost as well as interest may be imposed"

In the latest development, Hon'ble Supreme Court has dismissed the Review petition (Diary No. 36418/2024 pending at that time ), on 18.12.2024 on the grounds of defects and also on merits.

**In view of the above the interim order as detailed above should be implemented without further delay in letter and spirit.**

**We therefore request your personal attention in the matter to arrange to issue the instructions to all Pension Sanctioning authorities to initiate necessary action to grant one increment to eligible retirees and revise the pension at the earliest.**

- 1) With reference to progress report of quarterly meeting June 2024. The complaint of Smt Shubhada Narhari Pujari Wife of late N. D. Pujari, PPO Number 401994111122055 is pending. Bank of Maharashtra



had already recovered the excess payment of Rs. 1,21,850/- /- from her pension account on 10.01.2023. The payment of family pension from 05.10.2022 to December, 2022 is to be settled as yet.

- 2) With reference to progress report of quarterly meeting June 2024. Shri. K. R. Patil, PPO No. 402000101211137 and Shri. S.V.Kamble PPO No. 402001051203575. In progress report it was mentioned that the case "will be examined". The pensioners are waiting for settlement.
- 3) With reference to progress report of quarterly meeting held in December 2024, Smt. Kamrunisa Abdul Rahiman Siddiki (401987091142851) submitted the required documents. The case is pending at CCA office.

**FRESH ITEMS: For Quarterly meeting scheduled on 25<sup>th</sup> March, 2025.**

**A. Common Items:**

1. DOT (Pension Section) vide OM. No.38-45/2024- Pen(T) (Part-1) dated 22.01.2025 clarified about the Grant of notional increment to absorbed employees of BSNL/MTNL, who retired/are retiring a day before it became due in any month of the year. Pension of such pensioners will be revised wef. 01.05.2023. BSNL Corporate Office vide No. BSNLCO-A/12(17)/3/2021-ESTAB Dated 28.01.2025 advised BSNL Circle/Units to forward the cases to CCA for revision of pension. We will have to decide the procedure to expedite the implementation of the orders.

**In view of the Service Books are under the custody of CCA Office, It is suggested that BSNL Units will forward the revised FORM 7 along with the application of the pensioner to CCA Office, who will check with reference to service book, make suitable entry and authorize the revised pension.**

2. Non deduction of TDS at Source: It is reported by some of our branches that, Some VRS-2019 retirees, who completed 60 years of age in 2020-21, 2021-22, 2022-23 and 2023-24 received full amount of Gratuity without deduction of TDS on interest and while issuing Form 16 it has shown under section VI10.
3. Updating of CCA Maharashtra and Goa web site : Since there are changes in the portfolio of the Officers, the website need to be updated with the changes for the information of the stakeholders.
4. Some employees retired between 2017 to December 2019 complained that they have not received and do not have the copy of their PPO (Pension Book). It was discussed in the earlier meeting that In respect of the migrated pensioners, on updation of the KYP in SAMPANN, the copy of the PPO will be available in SAMPANN documents. So that the copy may be printed by the pensioner if required. Whether this copy will be considered as a record for future correspondence. ?

With reference to your letter dated 20<sup>th</sup> February, 2025, We hereby suggest the following items for 34<sup>th</sup> SCOVA meeting scheduled on 11<sup>th</sup> March, 2025.

**1. Additional Wellness Centers at Pune & Pimpri Chinchwad area: The proposal of 5 additional Wellness Centers at Kothrud, Hadapsar, Pimpri, Lohagaon and Katraj area.**

#### **Justification:**

At present there are only 9 CGHS Wellness Centres in Pune and Pimpri Chinchwad area. Last Wellness Centre was sanctioned at Pune in the year 1986, when Pune City was having population of 12.03 Lakh and Pimpri Chinchwd was having population of 82000 in 1984.

Pune and Pimpri Chinchwad are expanded since 1986 and spread far and wide covering new areas ie. Kothrud, Warje, Nigadi, Lohagaon, Kharadi, Hadapsar and, Katraj etc. Due to such huge expansion Government has decided to develop these areas through Pune Metropolitan Region Development Authority(PMRDA) as per notification in 2015. The population of Pune Metropolitan region (covering area of 7256.46 Sq KMs) is 72.76 Lakh and estimated at 73.99 lakh in 2025.

The proposal of 5 additional Wellness Centers at Kothrud, Hadapsar, Pimpri, Lohagaon and Katraj recommended by Addl. Director(CGHS), Pune is pending at CGHS Directorate.

**2. Extension of CGHS facilities at Kolhapur, Sangli-Miraj, Solapur, Nanded, Satara in Maharashtra State are pending at CGHS Directorate.**

**3. Extension of CGHS facilities at Belagavi(Karnataka) is pending at CGHS Directorate in spite of justification in terms of the criteria.**

**Justification:** We addressed a request for extension of CGHS facilities at Belagavi with full justification on the basis of data of Central Govt. Working employees and Pensioners in the Belagavi District. As per data furnished there are 1654 working employees and 3480 pensioners. There will be more than 6000 CGHS Cards, which is more than criteria for opening of CGHS Wellness Centre.



**4. Empanelment of Private Hospitals at District Levels for IPD treatment at the District headquarters without opening CGHS Wellness Center and continue Fixed Medical Allowance in lieu of OPD treatment for CGHS beneficiaries.**

This item was not included in the Agenda but we suggested and discussed in the 33<sup>rd</sup> SCOVA meeting.

**Justification:**

Parliamentary Standing Committee on Personnel, Public grievances, Law and Justice (Report No. 120) was in agreement with the views of Pensioners Associations that Govt. may explore opening of CGHS Wellness Centers at District Headquarters.

On receipt of the proposal of opening CGHS Wellness Centre at Kolhapur, Nanded, Sangli-Miraj, Solapur (Maharashtra) and Belagavi (Karnataka), CGHS Directorate close the proposal stating “ *As per new SIU report opening of new CGHS Wellness Centre involves creation of new posts of staff and has financial implications. Even with creation of minimum posts of staff would involve a recurring expenditure of Rs. 4.2 Cr. re per year and one time non-recurring expenditure of Rs. 0.75 Cr. to Rs. 1 Cr. For this the approval of the Department of Expenditure is required.*”

It is crystal clear that the proposals of opening of new CGHS Wellness Centre at District Headquarters involves financial implications.

**The demand of Pensioners/Sr. Citizens and recommendation of Parliamentary Standing Committee can be satisfied with Empanelment of Private Hospitals on demand by CGHS beneficiaries for IPD treatment.**

**5. Additional Staff to manage the CGHS Wellness Centers efficiently at Pune and Sambhajinagar in Maharashtra.**

The Shortage of staff in CGHS was discussed during 33<sup>rd</sup> SCOVA meeting. But there is no improvement in the situation at CGHS Pune, which is facing the shortage of staff of all positions. It is heard that the sanctioned strength of the Pharmacists working in CGHS Pune are reduced from earlier 33 to 27 in spite of increase in the number of CGHS beneficiaries.

CGHS had sanctioned/opened the CGHS Wellness Centre, Chhatrapati Sambhaji nagar (Aurangabad) and managed by Doctor 1, Pharmacist 1, Staff nurse 1 and MTS 1. It serves 3650 CGHS beneficiaries. The pensioners from nearby districts i.e. Buldhana, Jalgaon, Jalana, Parbhani, Beed are also taking the benefit. Good number of CGHS beneficiaries have to go back at 2 pm, without consultation/ treatment. There is a demand of one Ayurvedic dispensary to meet the additional demand. Additional Director is not in a position to meet the demand due to shortage of staff.

**6. Additional Staff to manage the CGHS Wellness Center at Coimbatore.**

As on 31.12.2024, there are 3006 primary CGHS Card holders and 7401 beneficiaries attached to CGHS, Coimbatore (Tamilnadu). The present staff strength is quite inadequate to cater to the needs of the CGHS beneficiaries.

**7. Updation of ward entitlement automatically without any manual intervention in CGHS BIS Portal.**

CGHS Card Portal used in the office of Addl. Director (CGHS) and CGHS BIS (Beneficiary Identification System) Portal are linked with each other. It is observed that on update of ward entitlement, CGHS staff is required to send the email to Director CGHS, New Delhi to update the Ward entitlement in the CGHS BIS portal used at the empanelled Hospital. If these two Portals are maintained, it should be possible to update the ward entitlement automatically without any manual intervention.

**8. Enhancement of Fixed Medical Allowance to Rs. 3000/- for pensioners residing in the Non-CGHS area.**

**9. Restoration of Commuted portion of pension on completion of 12 years instead of 15 years.**

**10. Implementation of Compressive Pension Management System (SAMPANN) for Postal pensioners.**

**11. Since 8<sup>th</sup> CPC is approved and will be appointed shortly. Following item may be included in the terms of reference of 8<sup>th</sup> CPC.**

“To examine and recommend the modalities for revision of pension of former DOT employees absorbed in BSNL and retired before the date of effect of the Pay scales recommended by Pay Revision Committee and to maintain the parity between pre and post PRC retirees by delinking with the Pay Revision.”

12. Release of retirement benefits to the retired employees against whom caste certificate verification is pending in accordance with DOP&PW OM No. 38/09(02)2020 P&PW(A) (6721) dated 30.11.2021 and recent communications from BSNL Corporate Office dated 18-11-2024 and CGM Maharashtra Telecom Circle dated 12-11-2024. Copy of these letters are enclosed for ready reference.

13. Appointment of Nodal Bank or posting of CCA official in BSNL BA unit for satisfying the queries/complaints of DOT/BSNL pensioners migrated to SAMPANN.

**Subject: Memorandum of Demands for inclusion in the terms of reference to be submitted to 8<sup>th</sup> CPC.**

**Respected Sir,**

It is understood that Secretary, JCM, DOPT North, Block, New Delhi have called for Terms of Reference from the Secretary Staff Side, NC-JCM and the same would be forwarded to 8<sup>th</sup> CPC. Since our association is the oldest, identified Pensioners Association and also a SCOVA member, we hereby submit the memorandum of demands, which may be considered for inclusion in the Terms of Reference to be submitted to 8<sup>th</sup> CPC.

1. Fixation of pension/Family pension in 8<sup>th</sup> CPC:- On the recommendation of 7<sup>th</sup> CPC, to maintain the parity between pre and post 2016 retirees, the Cabinet approved the procedure for revised pension/family pension w.e.f. 01.01.2016 in respect of all Central civil pensioners/family pensioners, including CAPF's, who retired/died prior to 01.01.2016. The pension/family pension was revised by notionally fixing their pay in the pay matrix recommended by the 7<sup>th</sup> CPC in the level corresponding to the pay in the pay scale/pay band and grade pay at which they retired/died. The revised procedure followed in 7<sup>th</sup> CPC may be adopted in 8<sup>th</sup> CPC also.

2. **Restoration of Commuted portion of pension on completion of 12 years instead of 15 years:** The restoration of Commuted pension on completion of 12 years instead of 15 years was recommended by 5<sup>th</sup> CPC. There is a full justification for restoration of commuted pension on completion of 12 years. Discussed and recommended on various forums. While Kerala Govt. has been restoring the commuted pension on 12 years,

Gujarat Govt. issued the orders for restoration on 13 years. In view of recent court orders, we urge the commission to consider the Restoration of Commuted portion of pension on completion of 12 years instead of 15 years

**3. Empanelment of Private Hospitals at District Levels for IPD treatment at the District headquarters without opening CGHS Wellness Center and continue Fixed Medical Allowance in lieu of OPD treatment for CGHS beneficiaries.**

**Justification:**

Parliamentary Standing Committee on Personnel, Public grievances, Law and Justice(Report No. 120) was in agreement with the views of Pensioners Associations that Govt. may explore opening of CGHS Wellness Centers at District Headquarters.

On receipt of the proposal of opening CGHS Wellness Centre at Kolhapur, Nanded, Sangli-Miraj, Solapur(Maharashtra) and Belagavi (Karnataka), CGHS Directorate close the proposal stating "As per new SIU report opening of new CGHS Wellness Centre involves creation of new posts of staff and has financial implications. Even with creation of minimum posts of staff would involve a recurring expenditure of Rs. 4.2 Cr.re per year and one time non-recurring expenditure of Rs. 0.75Cr. to Rs. 1 Cr. For this the approval of the Department of Expenditure is required."

It is crystal clear that the proposals of opening of new CGHS Wellness Centre at District Headquarters involves financial implications.

**The demand of Pensioners/Sr. Citizens and recommendation of Parliamentary Standing Committee can be satisfied with Empanelment of Private Hospitals on demand by CGHS beneficiaries for IPD treatment.**

**4. Enhancement of Fixed Medical Allowance to Rs. 3000/-:** The FMA of Rs 1000/- is being paid w.e.f. 01.07.2017. Since COVID-19, the consultation fees and cost of medicines have gone up manifold. The consultation fees of specialist doctors are ranging from Rs 500/- to Rs 1000/- at a time. Parliamentary standing committee has also recommended the enhancement of Fixed Medical Allowance to Rs. 3000/- . It was informed in one of the meeting that the demand of Enhancement of Fixed Medical Allowance would be referred to 8<sup>th</sup> CPC.

**5. Payment of Additional Quantum of Pension @ the rate of 5%/10%/15% on completion of 65/70/75 years respectively:-** 7<sup>th</sup> CPC has recommended to pay @ the rate of 10% Additional Quantum of Pension on completion of 75 years but it was not accepted. Further the Standing Committee of Parliamentarians has also recommended Additional Quantum of Pension @ the rate of 5%/10%/15% on completion of 65/70/75 years respectively.

**6. Inclusion of the Issue of Pension Revision of DOT Employees absorbed in BSNL/MTNL:**

We strongly urge Govt. of India to include the issue of pension revision of DOT Employees absorbed in BSNL/MTNL "To examine and recommend the modalities for revision of pension of former DOT employees absorbed in BSNL/MTNL and retired before the date of effect of the Pay scales recommended by Pay Revision Committee and to maintain the parity between pre and post PRC retirees by delinking with the Pay Revision." This will eliminate uncertainty and ensure pension revision to the erstwhile government employee.

आपणास कल्पना आहे, २६ ऑक्टोबर २०२३ च्या ठरावाद्वारे Standing Committee of Voluntary Agencies (SCOVA) चे पुनर्गठन करण्यात आले. तीत आपल्या असोसिएशनची स्थायी सदस्य म्हणून निवड झाली आहे. ३४वी स्कोवा बैठक दिनांक ११ मार्च २०२५ रोजी विज्ञान भवन, नवी दिल्ली येथे बैठक आयोजित करण्यात आली होती. आपल्या असोसिएशन तर्फे या बैठकीत चर्चा करणेसाठी आपल्या असोसिएशन तर्फे पाठविलेले पत्र पान क्रमांक २२ वर छापले आहे.

दिनांक ११ मार्च २०२५ रोजी माननीय केंद्रीय राज्य मंत्री श्री जितेंद्र सिंग यांचे अध्यक्षेखाली विज्ञान भवन, नवी दिल्ली येथे बैठक संपन्न झाली. मी बैठकीस हजर होतो. पेन्शन व पेन्शनर्स कल्याण विभागातर्फे बैठकीचे इतिवृत्त (इंग्रजीत) आल्यावर तुम्हाला कळेलच.

स्कोवा मध्ये समाविष्ट १२ पेन्शनर्स असोसिएशन्सच्या पदाधिकाऱ्यांना आणि केन्द्र सरकारच्या संबंधित विभागातील पदाधिकाऱ्यांना ११ वाजता उपस्थित राहण्याचे कळविण्यात आले होते. माननीय राज्य मंत्री १२. ३० वाजता येणार होते. साधारणतः १२ वाजता डॉ. सतीश, डायरेक्टर सीजीएचएस, नवी दिल्ली सभागृहात आल्याबरोबर मी त्यांच्या शेजारी बसून खालील महत्वाचे विषयावर चर्चा करण्याची संधी घेतली. महाराष्ट्र राज्यातील कोल्हापूर, नांदेड, सांगली-मिरज, सातारा, सोलापूर तसेच कर्नाटकातील बेळगांव येथे सीजीएचएस सुविधा विस्तारित करावी अशी रास्त मागणी आपल्या कार्यालयात प्रलंबित आहे. परंतु आपल्या कार्यालयातर्फे सीजीएचएस वेलनेस सेंटर सुरू करण्यासाठी येणार्या खर्चाचा हिशेब देऊन प्रकरणे तेथील सीजीएचएस लाभार्थ्यांची मागणी फेटाळून लावत आहे. पत्राद्वारे असे कळविण्यात येते की नवीन वेलनेस सेंटर उघडण्यासाठी नवीन पदे निर्माण करावे लागतात. त्यावर १ कोटी रुपये एक वेळचा व दरवर्षी ४.२ कोटी रुपये खर्च समाविष्ट आहे. यासाठी वित्त मंत्रालय, खर्च विभागाची मान्यता आवश्यक आहे.

ह्या संदर्भात, आमच्या असोसिएशनतर्फे दोन वर्षांपूर्वीच एक प्रस्ताव पाठविण्यात आला आहे. मागच्या वर्षी झालेल्या ३३ व्या स्कोवा बैठकीत आम्ही प्रस्ताव मांडला होता. आज होणाऱ्या स्कोवा बैठकीत सुद्धा मी तो प्रस्ताव मांडणार आहे. तो असा..

सीजीएचएस सुविधा नसणार्या जिल्हा स्तरावरील शहरातून सीजीएचएस सुविधा विस्तारित करण्याची रास्त मागणी आल्यास तेथे सीजीएचएस वेलनेस सेंटर सुरू करण्याच्या भानगडीत न पडता, सीजीएचएस लाभार्थ्यांना इनडोअर सुविधा प्रदान करण्यासाठी खाजगी रूग्णालयांना मान्यता देऊन सीजीएचएस अंतर्गत सूचीबद्ध करावे. जेणेकरून सीजीएचएस लाभार्थ्यांना इनडोअर ट्रिटमेंट घेता येईल.

अशा व्यवस्थेत सरकारला पेन्शनर्सची मागणी पूर्ण करता येईल तसेच संसदीय स्थायी समितीची शिफारस मान्य केल्याचे समाधान प्राप्त होईल. यावर डायरेक्टर साहेबांनी समाधानकारक उत्तर दिले. ते म्हणाले, हो प्रस्ताव माहिती आहे. ज्या शहरातून अशी रास्त मागणी येत आहे. तेथे जर चांगल्या प्रतीच्या वैद्यकीय सुविधा प्रदान करणारे व सीजीएचएस च्या अटी पूर्ण करणारे रूग्णालये असतील तर अशा रूग्णालयांना मान्यता देण्यात येईल.

दुपारी ठीक १२.३० वाजता माननीय राज्य मंत्री श्री. जितेंद्र सिंग यांचे आगमन झाले व स्कोवा बैठकीस सुरुवात झाली. उपस्थित पेन्शनर्स असोसिएशन चे पदाधिकारी व संबंधित विभागाचे पदाधिकाऱ्यांच्या परिचयानंतर लगेच अजेंड्यातील विषयावर चर्चा सुरू करण्यात आली.

१. पुणे शहरात आणि आसपासच्या परिसरात अतिरिक्त सीजीएचएस वेलनेस सेंटर ची आवश्यकता.

चर्चेदरम्यान मी सांगितले की पुणे आणि पिंपरी-चिंचवड शहराचा १९८६ पासून मोठ्याप्रमाणात विस्तार होऊन कोथरूड, निगडी, लोहगाव, खराडी, हडपसर, कात्रज इत्यादी नवीन उपनगरात प्रसार झाला आहे. या विस्तारामुळे सरकारने २०१५ च्या अधिसूचनेनुसार पुणे महानगर प्रदेश विकास प्राधिकरण(पीएमआरडीए) मार्फत या भागाचा विकास करण्याचा निर्णय घेतला आहे. २०२५ साली पुणे महानगराची लोकसंख्या ७३.९९ लाख होईल असा अंदाज आहे. येथे अॅडिशनल डायरेक्टर सीजीएचएस पुणे यांच्या कार्यालयातर्फे पाठवलेली पाच अतिरिक्त वेलनेस सेंटर्स ची मागणी सीजीएसएस मुख्यालयात प्रलंबित

आहे. तसेच इतर पेन्शनर्स असोसिएशन तर्फे सुद्धा अतिरिक्त वेलनेस सेंटर्स च्या मागणीचा उल्लेख केला. यावर डायरेक्टर सीजीएचएस यांनी सांगितले की नवीन वेलनेस सेंटर्स मंजूर करण्यासाठी प्रक्रिया सुरू आहे.

यावर मा. अध्यक्षांनी अशा शहराची मागणी रास्त आहे तरीही धोरणात्मक बाब असून त्याबाबत आरोग्य व कुटुंब कल्याण विभागातर्फे उचित निर्णय घ्यावा असे निर्देश दिले.

पेन्शन व पेन्शनर्स कल्याण विभागासोबत झालेल्या आभाशी बैठकीत SCOVA त समाविष्ट पेन्शनर्स असोसिएशन्स ना आठव्या वेतन आयोगासमोर संदर्भ अटी (Terms of Reference) मधील मुद्दे मांडण्यासाठी संधी मिळावी ह्या मागणी बाबत मा. सहसचिवांनी सांगितले की पेन्शनर्स असोसिएशन्सनी आपले मुद्दे पेन्शन व पेन्शनर्स विभागाकडे पाठवावेत. Terms of Reference तयार करतांना विचार करण्यात येईल.

पेन्शनर असोसिएशन सोबतची तिमाही बैठक दुपारी २.१५ वाजता सुरू झाली. बैठकीच्या सुरुवातीला, उपस्थित असलेल्या पेन्शनर्स असोसिएशन कडून श्रीमती विभा गोविल मिश्रा, श्री. शशांक भारद्वाज आणि श्रीमती निर्मला देवी डी. सीनियर ए.ओ. (पेन्शन) यांचे पुष्पगुच्छ देऊन स्वागत करण्यात आले. श्री. शशांक भारद्वाज जॉईंट सीसीए यांनी सर्व पेन्शनर्स असोसिएशनच्या पदाधिकाऱ्यांचे स्वागत केले आणि पेन्शनर्सच्या तक्रारींचे निराकरण करण्यासाठी असोसिएशनच्या सहकार्याबद्दल आभार मानले. असोसिएशनच्या नेत्यांनी आभार मानताना असे निदर्शनास आणून दिले की, पेन्शनर्स आणि संघटनांना सीसीए कार्यालयाशी संपर्क साधण्यास अडचण येत आहे, कारण त्यांना टोल फ्री क्रमांकावरून कोणताही प्रतिसाद मिळत नाही आणि मागील बैठकीत ठरल्याप्रमाणे ई-मेल आणि व्हाट्सअप क्रमांकावर पोच पावती देण्यात येत नाही. जॉईंट सीसीएने त्यांच्या कर्मचाऱ्यांना याची नोंद घेण्यास आणि आवश्यक ती कारवाई करण्यास सांगितले. सीसीएने त्यांच्या कार्यालयाबाबत माहिती देताना असे विदित केले की, कार्यालयात १०४ मंजूर कर्मचार्यांपैकी सध्या फक्त ६० कर्मचारी काम बघत आहेत.

सामाईक मुद्द्यांवर (जनरल अजेंडा) चर्चा करताना वरिष्ठ अधिकारी (पेन्शन) यांनी सांगितले की, त्या व्हीआरएस २०१९ अंतर्गत निवृत्त झालेल्या पैकी सर्व २३३० यांनी कम्प्युटेशनसाठी अर्ज करणे अपेक्षित आहे. त्यापैकी फक्त ९९४ अर्ज प्राप्त झाले आहेत. ज्या पेन्शनधारकांनी अजूनही अर्ज केले नसतील त्यांना अवगत करण्यासाठी, प्रशासनाशी सहकार्य करण्याची विनंती आहे.

मूळ पीपीओ उपलब्ध नसल्याच्या मुद्द्यावर चर्चा करताना, विशेषतः २०१७ ते २०१९ दरम्यान निवृत्त झालेल्यांना त्यांचा पीपीओ मिळालेला नाही. सीसीए तर्फे असे सांगण्यात आले की पेन्शनर्स नी दिलेल्या केवायपी फॉर्मच्या नोंदी करून त्यांचे ई-पीपीओ संपन्नमध्ये उपलब्ध करून दिले जातील आणि ते भविष्यातील पत्रव्यवहारात पीपीओची प्रत म्हणून ते स्वीकारले जातील. अशा परिस्थितीत आलेल्या केवायपी फॉर्म ची नोंद करणे आवश्यक आहे असे आपल्यातर्फे सुचविले.

नोशनल इन्क्रिमेंटबाबत असे ठरविण्यात आले की सीसीए कार्यालयाकडे इन्क्रिमेंटची माहिती उपलब्ध नाही म्हणून महाराष्ट्र सर्कलच्या अधिकाऱ्यांसोबत संयुक्त बैठक घेण्यात येईल.

लाईफ सर्टिफिकेट च्या पावती बाबत लेखा अधिकाऱ्यांनी सुचविले की पेन्शनधारकांनी, DLC सादर करताना, त्यांनी Pension Distributing Agency म्हणून CCA Maharashtra निवडावे. अशारितीने DLC मिळाल्यानंतर, ते SAMPANN पोर्टलवर ४८ तासांच्या आत अपडेट केले जाते, बैठकीत असेही सांगण्यात आले आहे की ७६६ पेन्शनधारकांचे पॅन नंबर, आधार शी जोडले गेले नसल्यामुळे Inoperative स्थितीत आहेत आणि ह्या बाबत पेन्शनर्स असोसिएशनला या समस्येचे निराकरण करण्यासाठी ज्ञात पेन्शनधारकांना मदत करण्याची विनंती केली आहे.

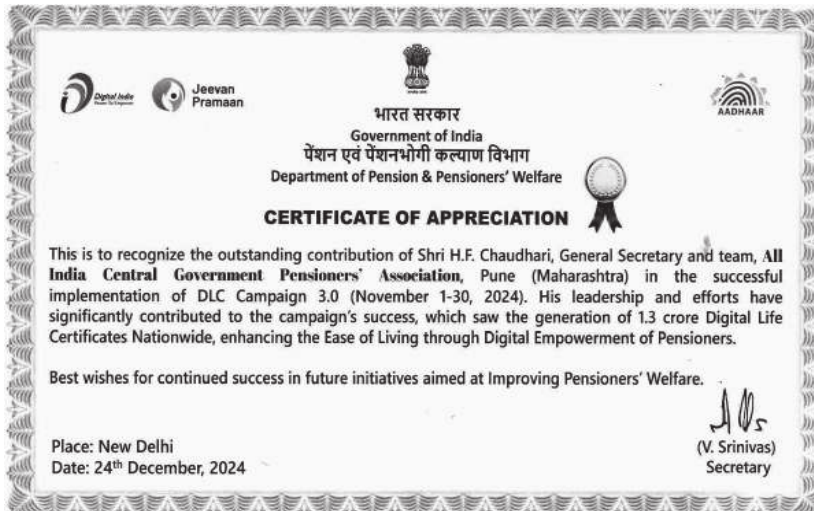
