

We congratulate the Indian Armed Forces for the successful Operation Sindoor.

I am pleased to inform you that 73rd Annual General Body Meeting of our Association will be held at Shri Kalika Devi Mandir Sansthan Bhakt niwas, Old Agra Road, Nashik - 422002 on 11.10.2025 at 2.30 PM. Branch Presidents/Secretaries are requested to remain present, participate and make it grand successful. The Notice is placed at Page no.4

Regarding Validation of CCS Pension rules and their principles as part of Finance Bill 2025, we have issued a detailed note. In view of Clarification submitted by Hon'ble Minister of Finance in Rajya Sabha on 27th March, 2025 and Meeting conducted by Secretary, DOPT on 29th March, 2025, we have decided to refrain from participation in the agitation program. We have already submitted the items for inclusion in the Terms of Reference for 8th CPC. We have also addressed the issue of Delay in Constitution of 8th CPC and Notification of Terms of Reference for 8th CPC to Cabinet Secretary, Govt. India on 24th June, 2025. We will keep a close watch on Constitution of 8th CPC, Terms of Reference, Recommendations of the Commission and the Govt's decision on pensionary benefits.

On final outcome of petition filed by DOPT, seeking the review of the order dated 11.04.2024 of Hon'ble Supreme Court in CA No. 2471/2023, DOPT has finally issued a detailed order dated 20th May, 2025 on granting a notional increment to the employees, who retired from Central Govt. service on 30 June /31st December respectively for the purpose of calculating their pensionary benefits. DOT has also endorsed the order vide Om dated 26.05.2025 for notional increment to absorbed employees of BSNL/MTNL.

In success of our efforts for empanelment of Private Hospitals in NON CGHS area, the Application of Pvt. Hospital in Nanded has been scrutinized by Addl. Director CGHS Pune and forwarded to Director(CGHS Hq), New Delhi for approval.

Govt. implemented Health Management Information System developed by CDAC w.e.f. 28th April, 2025. Initially CGHS Beneficiaries from all the corners have reported the difficulties in Online registration of appointment, Sluggishness in software, resulting in throughput and waiting hours to get the treatment, delay in getting LP Medicines etc. We addressed the issues in writing and also discussed in the ZAC. We have also met and

discussed issues and our demands with ADDG, Dr. Parveen Bala, New Delhi on 2.06.2025. She informed that the problems are faced initially due to conversion of existing data by NIC. Now the issues are brought into the notice of CDAC team and the position is improving day by day. She agreed to consider the Application for Empanelment of Pvt. Hospitals in Kolhapur, Sangli-Miraj and Nanded case by case. She also agreed to submit fresh proposal for additional Wellness Centre at Kothrud. Pune.

Case of Revision of Pension of BSNL-MTNL Pensioners the Hon'ble Bench Delhi High Court is again adjourned and the next hearing is scheduled on 29.07.2025 at 03:30 PM. DOT will not agree for Pension Revision, when the matter is subjudice.

VALIDATION OF CCS PENSION RULES AND THEIR PRINCIPLES AS APART OF FINANCE BILL 2025.

While submitting the Finance Bill in Parliament on 25th March 2025, a case has been included for the validity of the CCS Pension Rules and their principles.

"Without prejudice to the Pension Rules, the Central Government has the authority to establish a distinctions among pensioners as a general principle and that a distinction may be made amongst the pensioners, which may emanate from the accepted recommendations of the Central Pay Commission in particular and in particular the distinction may be made on the basis of the date of retirement. The legislation has been made effective from 1st June 1972."

On this issue discontent was expressed in the Lok Sabha by MPs as well as pensioners association expressed dissatisfaction.

There were apprehension and fear that the government might use the authority to discriminate against the existing pensioners while giving the benefits of the next Pay Commission.

On 27th March 2025, Hon. Finance Minister Smt. Nirmala Sitharaman clarified that the 6th Pay Commission had made a distinction between pensioners pre 01.01.2006 and post 01.01.2006. Accordingly, their pensions were also revised. Whereas 7th Pay Commission and this Government has brought parity between pre 01.01.2016 and post 01.01.2016 retirees.

She clarified that the validity clause passed in Parliament is only a validation of the existing rules. No amendment has been made in any pension rules or instructions. Rather, it is only a confirmation of the rules that were in place since 1st June 1972, i.e. the date of promulgation of the CCS Pension Rules.

In order to remove this confusion and fear among the pensioners, as per the demand of the Pensioners Association, a virtual meeting was held by the DOP&PW on 29th March 2025 under the chairmanship of Shri V. Srinivas, Secretary. Shri H. F. Chaudhari, General Secretary, participated in that meeting on behalf of our association. At that time, the Hon'ble Secretary clarified that the 5th Pay Commission had made a distinction between pensioners who retired before 01.01.1996 and after. Similarly, the 6th Pay Commission has maintained the difference between pensioners who retired before 01.01.2006 and after. However, according to Supreme Court, the government was not having authority in Pension Rules to make such a distinction. Hence the government for having the authority the provision have been incorporated in the CCS Pension Rules. The apprehension the the parity brought by 7th CPC and implemented by Government will be taken away, is not correct.

Ignoring all the above facts, some Pensioner Associations are creating confusion and fear in the minds of pensioners by saying that the government will not implement the revision of pension for existing pensioners as per the recommendations of 8th Pay Commission or perhaps the pension will be discontinued.

Our association immediately called a virtual meeting of the Central Working Committee on 31st March, 2025 and discussed the pros and cons of it.

AS the Clarification was not issued by the Secretary Pension, as agreed in the meeting held on 29th March, 2025, we expressed our deep concern, anxiety and dissatisfaction over the Validation od CCS (Pension) Rules and their principles as a part of the Finance Bill, 2025. We respectfully made an appeal to Hon'ble Minister of Finance/Secretary to initiate an action to review the Validation legislation to ensure an harmony with the land mark judgment of Supreme Court of India in year 1982.

Again we have discussed the issue in detail with AGS on 21/4/2025 and issued a detailed note for the information of the members.

A close study of the Ammendment and the clarification given by Hon'ble Finance Min ister and Secretary Pension during the meeting with JCM members and identified Pensioners Associations, revealed that the government had the right to differentiate between pensioners on the basis of retirement date. Fifth and Sixth Pay Commissions, while making recommendations, have also maintained the distinction between the pre and post retirees. Seventh Pay Commission recommended parity between pensioners who retired before 1.1.2016 and after 1.1.2016.

After the bill was passed in Parliament, the Hon'ble Finance Minister and Secretary clarified that no change has been made in the pension rules and pensioners who retired prior to 1.1.2026 will also be given the benefit of pension revision, as per the recommendations of the Eighth Pay Commission.

Believing this, it was decided that : since we have already presented our demands before the Secretary DOP&PW, New Delhi, we will keep a close watch on constitution of 8th CPC, Terms of Reference and the recommendations of the Eighth Central Pay Commission as well as the government's decision.

We addressed to cabinet Secretary on 24th June for delay in constitution of 8th CPC and notification of Terms of reference. Our association is always keeping watch on the Government's decisions for the just rights of the Central Government pensioners as well as BSNL MTNL pensioners.

12.04.2025: THE GOVERNMENT TESTS ITS VALIDATION LEGISLATION WITH A SUBMISSION IN A CONTEMPT PETITION BY ALL INDIA S-30 PENSIONERS WELFARE ASSOCIATION & OTHERS*

In a contempt petition filed by All India S-30 Pensioners Welfare Association and two others in Delhi High Court, which was heard on 08.04.2025, on behalf of the UOI, the Addl. Solicitor General submitted that Finance Act 2025 has been passed in the parliament validating decision of the Central Government that ""the Central Government has the authority and shall always deemed to have the authority to classify its pensioners, and may create or maintain distinction amongst pensioners as deemed expedient for implementing the recommendation of the Central Pay Commissions" and "in the light of the extant legislation, the High Courts order dated 20th March 2024 is no longer applicable and the Government is not obliged to implement the said order and hence no contempt arises".

However the High Court opined that "a clarification by the Division Bench of this Court, is necessitated, with regard to the order of 20th March 2024 - as to whether the said Finance Act 2025, shall obliterate and eclipse the orders passed by this Court, thereby giving the authority to the Central Government to recognise and endorse the distinction between the various categories of the pensioners" and has referred to the Division Bench, subject to the orders of Hon'ble the Chief Justice.

The matter is being placed before the Division Bench on 23rd April 2025, subject to the orders of Hon'ble the Chief Justice. *the Order of Delhi High Court

23.04.2025: DIVISION BENCH OF DELHI HIGH COURT HEARS THE REFERRAL FROM SINGLE BENCH REGARDING THE IMPACT AND CONSEQUENCE OF FINANCE ACT 2025 ON THE DECISION OF THIS (DELHI HIGH) COURT:

The Delhi High Court Division Bench today heard the referral from a single Judge on 8th April 2025 'regarding the impact and consequence of the Finance Act 2025, on the decision of this (Delhi High) Court'.

Attorney General made a submission, whether the contempt court can make such a referral.

The Bench said the Government can agitate that submission either in the contempt court or by making an appeal against the referral.

However, the Bench renotified the hearing on the referral for 8th May 2025 at 2.30 PM.

Both the parties are required to make a written submission 48 hours before that date. It is heartening that, during the hearing the Bench observed that earlier decision of a court cannot be undone by making a legislation later.

19.5.2025, All India S 30 Pensioners Association files Writ Petition (civil) No. 525/2025 in Supreme Court praying to *declare Validation of the CCS (Pension) Rules inserted by the Finance Act, 2025 as unconstitutional, ultra vires and illegal* besides praying direction to the Government to implement court order on pension revision with penal interest.

Written Reply on Validation of CCS (Pension) Rules through Finance bill 2025 F.No. 13/1/2024-E.Coord.II, Date: 1May 2025, from Ministry of State For Finance, Government of India Dear Shri ShanmugamJi

Please refer to your D.O. letter dated 1.4.2025, addressed to the Hon'ble Finance Minister regarding Validation clause in part IV (Clauses 147 to 150) of the Finance Bill, 2025, which relates to pension rules and related instructions issued from time to time.

- 2. In this regard, I would like to inform that the legislation regarding validation of the CCs (Pension) rules and principles for Expenditure on Pension liabilities from the consolidated fund of India, is a validation of the existing pension rules and does not alter or change existing civil or defence pensions.
- 3. The Government has announced setting up of the 8th central pay commisiion (CPC) in January, 2025, The 8th CPC will make appropriate recommendations with regard to the issues related to pay and other benefits of the Central Government employees.

Subject: Grant of notional increment on 1st July/1st January to the employees who retired from central govt. service on 30th June/31st December respectively for the purpose of calculating their pensionary benefits - regarding

The undersigned is directed to invite reference to the instructions issued vide this departments OM of even number dated 14.10.2024 (copy enclosed) regarding grant of 'notional increment' on 1st July January to the central government employees, who retired / are retining from service a day before, it became due i.e. on 30th June/31st December and have rendered the requisite qualifying service as on the date of their superannuation with satisfactory work and good conduct for calculating the pension admissible to them. The said instructions were issued in compliance of the Interim order dated 6.9.2024 passed by the Hon'ble supreme court while hearing MA No. 2400/2024 filed by M/o railways along with several Intervention applications tagged therwith. It was indicated therin that the action taken shall be subject to the final outcome of petition (Dy. No. 36418/2024) filed by this Department seeking review of the order dated 11.4.2023 of the Hon'ble supreme court in CA No. 2471/2023 on the subject matter.

- 2. Hon'ble supreme court, vide order dated 18.12.2024 had dismissed the review petition (Dy.No. 36418/2024) filed by this department with the observation that there is no error apparent on the face of the record, warranting reconsideration on the order impugnes.
- 3. Hon'ble supreme court has subsequently disposed of MA No. 2400/2024 filed by M/o railways and other petitions vide order dated 20.2.2025 while issuing the following final directions in the matter.
- a. The judgment dated 11.4.2023 will be given effects to in case of third parties from the date of the judgment, that is, the pension by taking into account one increment will be payable on and after 1.5.2023, Enhanced pension for the preiod prior to 30.4.2023 (erroneously mentioned as 31.4.2023 in the order) will not be paid;
- b. For persons who have filed writ petitions and succeeded, the directions given in the said judgment will operate as resjudicata, and accordingly an enhanced pension by taking one increment would have to be paid.
- c. The direction in (b) will not apply, where the judgment has not attained finality, and cases where an appeal has been preferred, or if filed, is entertained by the appellate court,
- d. In case any retired employee filed an application for intervention/impleadment/writ petition/original application before the central administrative tribunal/high courts/supreme court, the enhanced pension by including one increment will be payable for the period of three years prior to the month in which the application for intervention/impleadment / writ petition/ original application was filed.
- 4. The Hon'ble supreme court has decided that the direction referred at para3(d) above will not apply to the retired government employee who filed a writ petition/original application or an application for intervention before the central administrative tribunal/high courts.supreme court after the judgment in "Union of India & Anr. Vs M. Siddaraj," as in such cases directions referred in Para3(a) will apply.

- 5. In addition, Hon/ble supreme court has clarified that in case any excess payment has already been made, including arrears, such amount paid will not be recovered. Court has decided that pending applications shall stand disposed of this order.
- 6. The matter has been examined in consulation with D/o expenditure and D/o Legal affairs. It is advised that in pursuance of the above referred order dated 20.2.2025 of the Hon'ble supreme court, action may be taken to allow the increment on 1st July/1st January to the central government employees who retired/are retiring a day before it became due i.e. 30th June/ 31st December and have rendered the requisite qualifying service as on the date of their superannuation with satisfactory work and good conduct for calculating the pension admissble to them. As specifically mentioned in the orders of the Hon'ble supreme court, grant of the notional increment on 1st January/1st July shall be reckoned only for the purpose of calculating the pension admlssible and not for the purpose of calculation of other pensionary benefits.
- 7. This issue with the concurrence of D/o expenditure vide their Dy. No. 08.09.2019-E-IIIA (VolIII) (4265134) dated 29.4.2025 and D/o Legal Affairs vide computer Dy.No. E-144903 dated 17.3.2025.

Difference of UPS from OPS and NPS:

RAJYA SABHA: UNSTARRED QUESTION NO. 3440 ANSWERED ON TUESDAY, 01 APRIL, 2025/11 CHAITRA, 1947 (SAKA) DIFFERENCE OF UPS FROM OPS AND NPS 3440.

Shri Parimal Nathwani: Will the Minister of Finance be pleased to state:

- (a) the details of how the new Unified Pension Scheme (UPS) differs from the Old Pension Scheme (OPS) and/or the National Pension Scheme (NPS)?
- (b) the details of State Governments who have shown interests to implement the same in their respective States for their employees? and
- (c) whether the Central Government mulls extending additional financial support etc to the State Governments that adopt the UPS, if so, the details thereof?

ANSWER: MINISTER OF STATE FOR FINANCE (SHRI PANKAJ CHAUDHARY)

(a) Unified Pension Scheme (UPS) has been notified by the Government on 24.01.2025, as an option under National Pension System (NPS) with the objective of providing assured monthly payout after retirement to the Central Government employees covered under the NPS. UPS is defined contribution scheme with elements of defined benefit. It relies on the regular and timely accumulation and investment of applicable contributions (from both the employee and the employer) for assured payout to the employees.

The Old Pension Scheme is a defined benefit non-contributory scheme, fully funded by Government. It is applicable to Central Government employees who have joined the service on or before 31.12.2003 The National Pension System (NPS) is a defined contribution-based scheme with market linked returns for post-retirement benefits. It is applicable to Central Government employees, except armed forces, who have joined the service on or after 01.01.2004

(b) and (c) The regulation of service conditions of State Government employees falls under the administrative domain of respective State Governments.

RESTORATION OF COMMUPTED PENSION ON COMPLETION OF 15 Years:

Latest Judgemnt in WRIT PETITION NO: 24822 of 2024

Thupakula Venkateswar Rao and others Vs. The State of AP and others Hono'ble Judges Recommended

17.34. This issue was put forth before the earlier PRCs as well. The PRC 1999 did not agree for reducing the period of restoration on the ground that the age of retirement in the State Government was 58 years but not 60 years as was being followed in other states like Kerala, Orissa, Punjab and Madhya Pradesh. This position is no longer relevant though since the age of retirement has been revised to 60 years in 2014. The PRC 2005

suggested to adopt the principles which are followed by the Government of India. The 2010 and 2015 PRCs reiterated the recommendation of the 2005 PRC.

- 17.35. We would like to highlight four different aspects which have a bearing on this issue:
- i) Firstly, commutation of pension is a voluntary act and the employee can even exercise this option at any time after his retirement. He/she can also decide the portion of pension which he/she wants to commute, subject of course to the prescribed limit. The employee is therefore free to judge the benefits and drawbacks of the scheme and then decide whether to opt for it or not.
- ii) Secondly, the rules provide for restoration of the commuted portion of pension in the unfortunate event of demise of the original pensioner i.e. in such cases no further recovery is made from the Family Pensioner. This introduces an element of mortality risk which has been factored in for the purpose of calculating the restoration period.

The Supreme Court, vide their judgment dated 09.12.1986, allowed restoration of pension after 15 years because of the presence of this risk factor. We are aware that this conclusion has been contested in some quarters by arguing that the Supreme Court decision was delivered long time back and since then the expectancy of life at birth has increased (from 56.60 to 69.04 years). Nevertheless, considering the fact that the normal age of retirement is 60 years and the restoration of pension takes place at the age of 75 (or more) there is still a mortality risk involved in the scheme although it has reduced quite a bit.

- iii) Thirdly, one of the most attractive benefits of the scheme is that it makes available to the pensioner a lump sum amount by capitalising the pension over several months. The pensioner can use it either to meet some urgent family needs such as acquiring a suitable shelter, meeting marriage/educational/health care expenses etc. or simply invest it for financial return. In the earlier case the true value of this amount cannot be expressed only in monetary terms.
- iv) Fourthly, as mentioned above, the pensioner may choose to invest the amount for financial benefit. Although there are many alternative avenues of investment, we would make an attempt to compare the financial returns that the pensioner would get if he/she deploys the lump sum commuted amount in a Bank fixed deposit, which is the safest mode of investment, with the amount that one would have made by investing the amount recovered every month towards commutation i.e. had he not opted for commutation. The contention of the pensioners is that the Government recovers more than it pays in lump sum on commutation. While making this comparison one has to keep in mind the fact that the Commutation Value received in lump sum, is not taxable but the monthly pension as well as the interest accrued on Bank deposits are taxable. The following realistic assumptions and formulae have been used in drawing this comparative Table:
- a) The lump sum commuted value of pension is deposited in a Bank fixed deposit for a period of 15 years at an interest rate of 8% p.a. compounded at quarterly intervals;
- b) Alternatively, an amount equivalent to the monthly commuted portion of pension is deposited every month in a Bank Recurring Deposit for a period of 15 years, at an interest rate of 8% p.a. compounded at quarterly intervals;
- c) For simplicity of calculation, it is assumed that 1 .1,000/- is the commuted portion of pension. The lump sum Commuted Value then comes to 1 .1000 x 8.194 x 12 = 1 .98,328/-.
 - d) Total Future Value of investment in Fixed Deposit including interest is given by
- A= P(1+r/n)nt, where P= Principal Amount, r= Annual Rate of Interest (in decimal), n= number of times that interest is compounded per unit <math>t, t the time for which money is invested
- e) Total Maturity Value (M) of investment in Recurring Deposit including interest is given by M= R[(1+i)n-1]/1-(1+i) -1/3, where R= Monthly Instalment, n= number of guarters, i= Annual Rate of Interest/400
- 17.36. The above Table shows that the Commuted Value based on present number of years of purchase yields better ¹ 3,01,594 ¹ 2,33,961 ¹ 1,92,812 returns post tax, as compared to the recoveries made in a period of 15 years, at 8% compounded rate of interest. Hence, coupled with the mortality risk covered, and the advantage and flexibility associated with the lump sum amount received, opting for commutation is at present more advantageous to the employees.

- 17.37. We may also mention here in passing that the above issue was judicially tested in the Hon ble Delhi High Court in the case of Forum of Retired IPS Officers vs. Union of India and the Hon ble High Court, in its judgement delivered on 17 January, 2019, dismissed the case of the petitioners.
- 17.38. In the totality of the matter discussed above, the Commission therefore recommends continuance of the period of restoration of commuted portion of pension at the present level of 15 years."
- 35. The fact that even after 15 years, receipt of a lump sum amount by a pensioner if invested rightly earns better returns as compared to receiving full pension on a monthly basis, goes to show that the scheme framed by the Government, even when it envisages restoration of full pension upon completion of 15 years, is not detrimental to the interest of the petitioner.

Moreover, whereas the pensioner is liable to pay income tax on the monthly pension which he receives at the end of the year, the amount if paid in lump sum upon commutation is not liable to be taxed at all.

- 36. All these factors persuade us to hold that the impugned rule does not suffer from any perversity or arbitrariness.
- 37. Be that as it may, we do not find any merit in the present set of writ petitions which are accordingly dismissed. No order as to costs. Pending miscellaneous applications if any, in these petitions, shall stand closed.

Subject: Implementation of Health Management Information System developed by C-DAC for CGHS - Operational Guidelines and Transition Plan.

The Central Government Health Scheme (CGHS) has been providing healthcare services to central government employees, pensioners, and other eligible categories since 1954. The existing software system, developed in 2005, has not undergone version upgrades in nearly two decades and was deemed technically obsolete. Consequently, CGHS undertook a comprehensive assessment and decided to adopt the "Health Management Information System (HMIS)" developed by the Centre for Development of Advanced Computing (C-DAC), a government agency under MeitY.

1. Timeline and Impact on Existing Services

The new C-DAC developed software will be made operational from 28th April 2025. CGHS services will be suspended on 26th April 2025 for final transition activities. A parallel run of both existing and C-DAC systems for providing continuity of Pharmacy services. From 28th April 2025, the old CGHS websites www.cghs.gov.in and www.cghs.nic.in will be deactivated. All services and information will henceforth be hosted on the new unified CGHS Digital Platform at www.cghs.mohfw.gov.in

2. Key Operational Changes and Procedures

- (a) Payment Procedure Contribution payments will now be auto-verified through direct integration (Line of Business Application Integration) with Bharat Kosh. There will be no manual choosing of options, entry of details on Bharat Kosh portal which shall eliminate errors and refund issues. (From 28th April 2025, the existing payment purpose on Bharat Kosh portal will be disabled.) All applications for which contribution payment has not been made by 27th April 2025 will lapse. New applications must be submitted exclusively through www.cghs.mohfw.gov.in. The contribution amount will be through the portal www.cghs.mohfw.gov.in after verification.
- (b) Public Dealing Suspension All CGHS Wellness Centers will remain closed to public interaction on 26th April 2025.
- (c) Departmental Identification Department identity for serving employees will be based on PAO (Pay and Accounts Office) and DDO (Drawing and Disbursing Officer) codes. Applicants are advised to refer to their salary slips for correct PAO/DDO codes. Until a department is on boarded, physical submission at CGHS Card Sections will continue.
- (d) User Access and Login All beneficiaries will be required to reset their passwords on their first login. SMS and email alerts will be sent for application progress. ACGHS mobile app is available.

3. New Functionalities and Service Enhancements

PAN-based unique beneficiary identification, eliminating duplication Pre-payment application scrutiny to prevent errors and refund cases Auto-verification of contribution via Bharat Kosh/PFMS Real-time application

- (b) Support and Training: Master Trainers have been deployed across CGHS AD offices and major Wellness Centres. User manuals and helpdesk facilities are available on CGHS Website and myCGHS App for beneficiaries, departments and CGHS staff. (c) Contact and Help Official portal: www.cghs.mohfw.gov.in.

All CGHS and CS (MA) beneficiaries in the department must strictly follow the revised CGHS referral and treatment guidelines issued by the Ministry of health & family welfare (OM No. Z15025/19/2024/DIR/CGHS?EHS dated 28.6.2024)

- No Endorsement Needed for Tests Below Rs. 3000 :
- Referral / endorsement from CGHS welleness centre is not required for tests or investigations costing up to Rs. 3000.

Referral Mandatory for sepcial . Costly Investigations :

Referral is mandatory for the following:

- CT Scan PET Scan MRI Scan Any test/investigation costing more than Rs. 3000
- No Post-Facto Approvals for OPD without Referral :
- CGHS beneficiaries will not be branted post-facto approval for OPD treatment/investigations in empanelled or non empanelled hospitals without valid CGHS referral.
- CS (MA) beneficiaries must obtain prior permission from the department even when referred by an AMA. Reimbursement will not be granted otherwise.

Prior permission needed for CGHS 0 unlisted Tests:

 Departmental permission is mandatory before undergoing any unlisted CGHS procedure/test, except in emergencies. • In emergency cased, post-facto approval must be sought within one month of treatment. Late application will be rejected.

No reimbursement for OPD Medicines:

- OPD medicines will not be reimbursed under any circumstance.
- Medicines must be collected from designated CGHS wellness centres.
- In emergency cased, medicine claims must include an officially stamped endorsement from the attending doctor indicating emergency.

- 1. In continuation of the efforts to enhance digital infrastructure and service delivery under the Central Government Health Scheme (CGHS), the Hospital Management Information System (HMIS) has been migrated from the NIC platform to the C-DAC platform with effect from 28th April 2025. The new platform is presently undergoing functional optimization to manage the outpatient workload across CGHS Wellness Centres.
- 2. It has been observed that certain operational challenges have arisen during the transition period, resulting in difficulties being faced by CGHS beneficiaries in availing "Indent" medicines from the Wellness Centres. 3. With a view to mitigating the inconvenience caused to the beneficiaries, and as a one-time special measure, it has been decided that: 1. CGHS beneficiaries shall be permitted to procure medicines for a period of one month only from the open market based on a valid prescription, irrespective of the issuance of a Non-Availability Certificate (NAC), and for the quantity specified in the prescription. 2. A valid prescription shall be deemed to be one where the treatment duration prescribed by the Government Hospital/CGHS Medical Officer/ Specialist/CGHS Empanelled Hospital has not expired as on the date of procurement of the medicine.
- 4. The reimbursement of such medicines shall be admissible upon submission of claims as per the applicable procedure outlined below:

In case the medicine prescribed by the specialist is available by an alternative brand name having the same composition, it shall be supplied by the brand name available at CGHS wellness centre.

If the medicine prescribed by the specialist is not available at CGHS wellness centre either by generic name or alternate brand name it shall be indented by the same brand name through authorized local chmist.

2. In view of the above the CGHS wellness centres are directed to stictly adhere to these guidelines to ensure uninterrupted and efficient service deluvery to beneficiaries subjet to the admissibility instructions for medicines issued from time to time by the directorate.

I am directed to refer to this office letter of even number dated 28.1.2025 and to say that DOT vide OM no. 38-66 / 2024 - Pen (T) (I) dated 22.1.2025 had allowed grant of notional increment to absorbed employees of BSNL who are retiring/retired from BSNL w.e.f. 1.1.2006 and have rendered the requisite qualifying service as on the date of their superannuation with satisfactory work and good conduct. The said DOT OM dated 22.1.2025 was issued in accordannce with the interim order dated 6.9.2024 in MA Dy. No. 2400/2024 of Hon'ble supreme court in CA No. 3933/2024 in CA No. 2471/2023 and MA dy No. 2400/2024 has been disposed of by the Hon'ble supreme court vide order dated 20.2.2025 wherein the interim order dated 6.9.2024 in MA dy. no. 2400/2024 has been modifies. Based on the order dated 20.2.2025 in MA No 2400/2024, DoP&T vide OM No. 19/116/2024 - Pers. Pol (Pay(pt)) dated 20.5.2025 has issued instructions for grant of notional increment for grant of pension to central government employees.

- 2. In accordance with above mentioned order dated 20.2.2025 of Hon'ble supreme court in MA No. 2400/2024 in CA No. 3933/2023 and DoP/T OM dated 20.5.2025, DoT vide OM No. 38-66/2024 Pen(T)(i) dated 26.5.2025 (copy enclosed) has issued modified instructions to allow notional increment to the absorbed employees of BSNL, who are retiring/retired from BSNL w.e.f. 1.1.2006 and have rendered the requisite qualifying service as on the date of their superannuation with satisfactory work and good conduct, DoT has further decided that the benefit of notional increment as it was due in any month of the year should be drawn in favour of eligible retired employees/third parties, who has retired/are retiring from BSNL service w.e.f.1.1.2006. Actual benefits in respect of different categories of employees will be governed as per the stipulation of para 4, 5 and 6 of OM dated 20.5.2025.
- 3. All circles/units are requested to implement the above mentioned DoT OM dated 26.5.2025 in respect of eligible absorbed employees retiring/retired on superannuation from BSNL w.e.f. 1.1.2006. The conditions and eligibility criteria stipulated in the OM shall be followed meticulously while processing the cases of notional increment only for the purpose of calculating the pension.
- 4. The cases of eligible employees for grant of notional increment for pension in terms of DoT OM dated 26.5.2025 shall be taken up with the concerned CCA. However, priority may be given to the cases where there are any directions from the Hon; ble central administrative tribunals or that of other judicial forums and forward such cases along with the judicial orders to the concerned CCAs for further action.
 - 5. This is issued with the approval of the competent Authority.

Subject: Grant of notional increment to absorbed employees of BSNL/MTNL for the purpose of calculating the pension admissible - reg.

Kindly refer to the instructions issued vide this department OM No 38-45/2024-Pen (T) (Part-1) dated 22.01.2025 (copy enclosed) regarding grant of notional increment to the absorbed employees of BSNL/MTNL who retired/are retiring a day before it became due in any month of the year.

- 2. The said instructions were issued in compliance of the Interim Order dated 06.09.20204 passed by the Hon'ble Supreme Court while hearing MA No 2400/2024 filed by M/o Railways along with several Intervention Applications tagged herewith. It was indicated therein that the action taken shall be subject to the final outcome of the petition (Dy No. 36418/2024) filed by this Department seeking review of the Order dated 11.04.2023 of the Hon'ble Supreme Court in CA No. 2471/2023 on the subject matter.
- 3. Hon'ble Supreme Court , vide order dated 18.12.2024, had dismissed the Review Petition (Dy. No.36418/2024) filed by DoPT with the observation that there is no error apparent on the face of the record, warranting reconsideration of the order impugned.
- 4. The DoPT vide its OM 19/116/2024-Pers.Pol.(Pay(Pt) dated 20-05-2025 has communicated the Hon'ble Supreme Court final Order dated 20.02.2025 as below:
- (a) The judgment dated 11.04.2023 will be given effect to in case of third parties from the date of the judgment, that is, the pension by taking into account one increment will be payable on and after 01.05.2023. Enhanced pension for the period prior to 30.04.2023 (erroneously mention as 31.04.2023 in the Order) will not be paid.
- (b) For persons who have filed writ petitions and succeeded. the directions given in the said judgment will operate as res judicata, and accordingly, an enhanced pension by taking one increment would have to be paid.
- (c) The direction in (b) will not apply, where the judgment has not attained finality, and cases where an appeal has been preferred, or if filed, is entertained by the appellate court.
- (d) In case any retired employee filed an application for intervention/impleadment /writ petition /original application before the Central Administrative Tribunal /High Courts/Supreme Court, the enhanced pension by including one increment will be payable for the period of three years prior to the months in which the application for intervention limpleadment/writ petition/original application was filed.
- 5. The Hon'ble Supreme Court has decided that the direction referred at para 4(d) above will not apply to the retired Government employee who filed a writ petition/original application or an application for intervention before the Central Administrative Tribunal/High Courts/Supreme Court after the judgment in Union of India & Anr. Vs M Siddaraj i.e. 11.04.2023, as in such cases directions referred in para 4(a) will apply.
- 6.In addition. Hon'ble Supreme Court has clarified that in case any excess payment has already been made, including arrears, such amount paid will not be recovered. Court has decided that pending applications including all intervention/impleadment applications shall stand disposed of in terms of this order.
- 7. The DoPT OM No. 19/116/2024-Pers.Pol.(Pay)(Pt) dated 20-05-2025 has been examined in this department in consultation with Account Wing, DoT. After careful consideration it has been decided by the competent authority that the Notional Increment, as it was due in any month of the year in favour of all eligible should be drawn in favour of all the eligible retired employees/third parties, who had retired/are retiring from BSNL/MTNL service w.e.f. 01.01.2006 as decided for DoT employees also. However, actual monetary benefit should be given w.e.f. 01.05.2023.
- 8. This OM shall be made applicable to the employees whohave rendered the requisite qualifying service as on the date of their superannuation with satisfactory work and good conduct for calculating the pension admissible to them. Grant of the notional increment in any month of the year shall be reckoned only for the purpose of calculating the pension admissible and not for the purpose of calculation of other pensionary benefits.
- 9. The applicability of notional increment guidelines w.r.t. the absorbed employees of BSNL/MTNL who retired under VRS Scheme-2019, is being examined. Instructions in this regard will be issued separately.

We wish to bring into your notice the issue of the chaotic situation throught out the CGHS Wellness Centers. CGHS Directorate, vide office memorandum cited under reference, has launched the modernized Health Management Information System which was scheduled to go live from 28th April, 2025.

We welcomed the step of the CGHS Directorate that modernized Health Management Information System would be implemented for hassle-free services for CGHS beneficiaries. But it is observed that the migration of data from website www.cghs.gov.in to www.cghs.Mohfw.gov.in has been not successful in spite of deploying master trainers. The CGHS services are completely derailed. This has put the CGHS beneficiaries especially aged and ailing CGHS beneficiaries to miseries and distress.

We hereby request your good self to arrange to review the discrepancies in the migration and difficulties faced by the CGHS beneficiaries and do the needful as early as possible.

Sub: Continuous malfunctioning of newly migrated HIMS in CGHS and severe harassment to CGHS beneficiaries/pensioners - regarding

Respected Sir,

A joint meeting of the office bearers and representatives of the Pensioners Associations in Pune was held on 26.05.2025, at S M Joshi Bhawan, Khadki, Pune to discuss about difficulties faced by CGHS beneficiaries on implementation of CDAC developed HIMS software for CGHS.

HIMS Software had been implemented for CGHS with effect from 28/04/2025. Even after one month from the implementation, the CGHS Beneficiaries from almost all Wellness Centers reported so many difficulties. We wish to bring into your notice.

- 1. Online registration of appointment in new App: OTP failure. App MyCGHS 2.0 have persistent glitches
- 2. Lengthy Access time: The beneficiaries are required to wait in the queue for hours together for consultation with Doctor
- 3. Doctors are unable to select even seven medicines per prescription due to software limitations.
- 4. Sluggishness in software performance has drastically reduced patients throughput, leading to utter chaos at Wellness Centers.
- 5. Specialists are unable to prescribe medicines to patients as per their parent dispensary or not indent medicines.
- 6. Indenting of medicines, especially life-saving drugs, has become a nightmare, take 13 days from the date of consultation to reach Wellness Center.
- 7. It is very difficult to get the medicines through Local Purchase in prescribed time.
- 8. Referral memos issued are not being honoured and patients are asked to procure separate referral memo for each facilities viz. consultation, investigation etc which the migrated C-DAC version lacks.

- 9. Branded medicines prescribed by specialists are being auto-substituted without informing the patient or consulting the doctor which is dangerous. It compromises the health and safety of elderly patients.
- 10. Option to add any medicine after a second thought or obtain any treatment facility later at any time on the same day from the WC then available is not available now.
- 11. Empanelled hospitals (HCOs) are unable to upload bills resulting denial of credit facilities to beneficiaries and emotionally pressurize families to pay for the treatment.
- 12. In ordinate delay in sanctioning Medical reimbursement claim payments.

AS such Online functioning of the system has virtually collapsed and it has become a nightmare to ailing patients especially very senior, co-morbidity and cancer patients/beneficiaries. Homeopathy and Ayurveda treatment facilities have also been affected.

It is very much necessary to revisit and restore the NIC Platform immediately, restore the confidence of the CGHS Beneficiaries and protect the dignity and health rights of those who have served the nation.

C-DAC developed HIMS, which need further testing and validation may be re-introduced after through checks and balances.

WE hereby request to report the above issues to the competent authorities for its redressal immediately considering the severity prevailing in CGHS delivery system under intimation to the Pensioners Associations.

CGHS Beneficiaries are very much agitated. Pensioners Associations may be compelled to hold 'Mass Demonstrations' / 'Dharnas' in front of the office of the Additional Director CGHS, Pune on any date after 30th June 2025, if the CGHS delivery system is not improved by the said date.

Respected Sir,

AICGPA Hq. Pune is the Oldest Pensioners Association formed by P&T Pensioners in August, 1947. In view of its network and activities It has achieved the status of an Identified Pensioners Association by Govt. of India, Department of Pension & Pensioners Welfare and also Standing group member of SCOVA, reconstituted in September, 2023.

We wish to bring into your notice the requirement of Additional CGHS Wellness Centres in Pune, especially at Kothrud area on urgent basis.

- 1. At present there are only 9 CGHS Wellness Centres in Pune and PImpri Chinchwad area. Last Wellness Centre was sanctioned at Pune in the year 1986, when Pune City was having population of 12.03 Lakh and Pimpri Chinchwd was having population of 82000 in 1984.
- 2. Pune and Pimpri Chinchwad are expanded since 1986 and spread far and wide covering new areas ie. Kothrud, Warje, Nigadi, Lohagaon, Kharadi, Hadapsar, Katraj, and Khadakwasla etc. Due to such huge expansion Government has decided to develop these areas through Pune Metropolitan Region Development Authority(PMRDA) as per notification in 2015. The population of Pune Metropolitan region (covering area of 7256.46 Sq KMs) is 72.76 Lakh and estimated at 73.99 lakh in 2025.

- 3. In spite of such expansion and development, No additional CGHS Wellness centre was sanctioned/opened to meet the demand of CGHS beneficiaries. Additional Director CGHS Pune had sent a proposal for 5 additional Wellness Centres at Kothrud, Pimpri, Hadapasar, Lohgaon, Katraj. The proposal is pending at CGHS Directorate. CGHS Wellness Centre is opened at CWPRS, Residential Colony recently in April, 2025.
- 4. CGHS facilities at Bajirao Raod, Pune are shifted to Wellness Centre at CWPRS Residential Colony, Khadakwasla, Pune. The CGHS Beneficiaries residing at Karve road, Kothrud, Warje, Bhusari Colony are required to visit Wellness Centre at Mukundnagar. Most of the CGHS beneficiaries are required to travel 10 to 15 Kms.
- 5. CGHS Wellness Centre is having all the facilities and therefore is overcrowded from the beginning. Due to the close of facilities at Wellness Center at Bajirao Road, beneficiaries are visiting Wellness Center Mukundnagar resulting lengthy queue of beneficiaries and also a pressure on Doctors.
- 6. Moreover the problems at the initial stage of implementation of CDAC developed HIMS software added the fuel.
- 7. In such situation, CGHS beneficiaries especially ailing and aged pensioners at Pune are dissatisfied with the CGHS facilities.

It is very much necessary to open additional Wellness Centres at Pune & Pimpri as early as possible. The issue was also raised in the latest 34th SCOVA meeting held on 11th March, 2025.

Sir, We request you to sanction additional centers at Pune, especially at Kothrud on priority and resolve the issue of CGHS Beneficiaries, most of them are senior citizens.

Respected Sir,

I wish to bring to your kind attention the additional information received from the All India Central Government Pensioners Association (Headquarters: Pune) regarding the growing demand for new CGHS Wellness Centres in Pune—particularly in the Kothrud area. 1. Current Situation: At present, there are only 9 CGHS Wellness Centres catering to Pune and Pimpri-Chinchwad regions. The last CGHS Wellness Centre in Pune was sanctioned back in 1986, when the population was 12.03 lakh in Pune and 82,000 in Pimpri-Chinchwad (as per 1984 data). 2. Expansion and Demographic Growth: Since then, Pune and Pimpri-Chinchwad have witnessed rapid urbanization and geographic expansion. New residential hubs such as Kothrud, Warje, Nigdi, Lohagaon, Kharadi, Hadapsar, Katraj, and Khadakwasla have emerged. The Government has also notified the Pune Metropolitan Region Development Authority (PMRDA) in 2015 to manage this expansion. The population of the Pune Metropolitan Region now stands at 72.76 lakh and is projected to reach 73.99 lakh by 2025. spread over 7256.46 sq. km. 3. Need for Additional Centres: Despite the significant growth in population and area, no new CGHS Wellness Centre has been sanctioned post-1986. The Additional Director, CGHS Pune, has submitted a proposal for five new centres in Kothrud, Pimpri, Hadapsar, Lohgaon, and Katraj. The proposal is currently pending with the CGHS Directorate. While a CGHS Wellness Centre has recently been opened at CWPRS Residential Colony in April 2025, this alone does not suffice. 4. Accessibility Challenges for Senior Citizens: The CGHS Wellness Centre earlier located on Bajirao Road has now been shifted to CWPRS, Khadakwasla. Approximately 5,500 CGHS beneficiaries—many of them senior citizens—residing in Karve

Road, Kothrud, Warje, and Bhusari Colony are now forced to travel 7 to 15 km to access the Mukundnagar Centre. This is causing considerable inconvenience.

In view of the above, I earnestly request you to consider the urgent establishment of additional CGHS Wellness Centres in Pune, especially at Kothrud, to address the long-standing demands and healthcare needs of beneficiaries in these rapidly growing localities.

a.We submit the following items for the Agenda.

(soft copy in editable form in word is attached).

A. COMMON ISSUES IN SPARSH:

- 1. Main hurdle is while opening new account in SPARSH, a declaration is required to be e-signed regarding excess payment. The software does not proceed to the new page. This problem need to be solved.
 - 2. If a pensioner wants to shift his pension to other bank, procedure is to be explained.
- 3. Pensioner is required to Change the password frequently. It is difficult to remember password for aged pensioners.
 - 4. Form 16 is not made available till mid June.
 - **B. INDIVIDUAL CASES:**
- 1. Shri M Venugopalan, age 75, Old PPO No. C/32/2006 was retired on 10th August, 1994, while working as Sanitary Supervisor with Station Headquarters Kirkee. His service was transferred to compulsory retirement with pensionary benefits during Aug 1994. Copy of his Old PPO is attached for reference.

After the issue of DoP&PW order dated 14 /6/2022, he approached station HQ, Kirkee and PCDA(P) Prayagraj for revision of his pension.

Station HQ , Kirkee uploaded the wrong information, about his Rank(Store Keeper in place of Sanitary Supervisor) , Date of Birth and other details to SPARSH Portal. Corrigendum PPO Details (Number 3)of eppo No. C0000322006 is attached herewith for reference.

On his representation, only date of birth was corrected and his Rank, scale of pay and other details were not corrected. Due to this he is not getting the pension for the post of Sanitary Supervisor.

2. Miss Shobhana Neelkanth Gokhale, unmarried daughter of late N. D. Gokhale submitted the application for grant of Family pension to COD, Dehu Road, Pune on 6th January-2025. The case is still pending.

As per the letter received from Sr. Accounts Officer(AN), O/o Principal Controller Defence Accounts Office(Army), Pune the documents are submitted vide her letter dated 10/06/2025.

Copy of Form 10 and the Copy of letter dated 10/06/2025 are attached herewith for reference.

3. Grievance of MES-Defence retired employees regarding Fixation of pay as on 1.1.2006 on Merger of 5th CPC Pre-revised Scales of Rs.5000-8000, Rs.5500-9000 with Pay Scale of Rs.6500-10500 as per

संसदेत वित्त विधेयक मांडताना २५ मार्च २०२५ रोजी CCS पेन्शन नियम व त्यांची तत्वे यांच्या वैधतेसाठी एक प्रकरण समाविष्ट केले आहे. पेन्शन नियमांना बाधा न आणता सरकारला सामान्य तत्व म्हणून पेन्शन धारकांमध्ये भेद स्थापित करण्याचा अधिकार आहे. आणि केंद्रीय वेतन आयोगाच्या स्वीकृत शिफारसी लागू करताना विशेषतः निवृत्तीच्या तारखेच्या आधारावर पेन्शन धारकांमध्ये भेद केला जाऊ शकतो व ही वैधता १ जून १९७२ पासूनच लागू करण्यात येईल.

या वैधते बाबतीत लोकसभेत खासदार तसेच पेन्शन धारकांकडून नाराजी व्यक्त करण्यात आली. अशारितीने सरकारने अधिकार आपल्याकडे घेतल्यानंतर पुढील वेतन आयोगाचे लाभ देताना सध्याच्या पेन्शनरांबाबत सरकार भेदभाव करू शकेल, अशी भीती निर्माण झाली.

२७ मार्च २०२५ रोजी राज्यसभेत मा. अर्थमंत्री श्रीमती निर्मला सीतारामन यांनी स्पष्टीकरण दिले की ६ व्या वेतन आयोगाने ०१.०१.२००६ पूर्वीच्या आणि ०१.०१.२००६ नंतरच्या पेन्शन धारकांमध्ये फरक केला होता. त्यानुसारच त्यांच्या पेन्शन मधे सुधारणा सुद्धा झाली होती. तसेच ७ व्या वेतन आयोगाने ०१.०१.२०१६ पूर्वीच्या आणि ०१.०१.२०१६ नंतरच्या निवृत्ती वेतन धारकांच्या पेन्शन मधे समानता आणली आहे. त्यांनी स्पष्ट केले की संसदेत मंजूर झालेली वैधता ही केवळ विद्यमान नियमांचे प्रमाणीकरण आहे. कोणत्याही पेन्शन नियमांमध्ये किंवा सूचनांमध्ये सुधारणा करण्यात आलेली नाही. तर १ जून १९७२ पासून म्हणजेच CCS पेन्शन नियम जारी झाल्याच्या तारखेपासून असलेल्या नियमांची केवळ पृष्टी आहे.

पेन्शनर सभासदांच्या मनात निर्माण झालेला हा संभ्रम नाहीसा करण्या साठी व स्पष्टीकरणा साठी, पेन्शनर असोसिएशन च्या मागणी नुसार पेन्शन मंत्रालयातर्फे श्री व्ही श्रीनिवास सचिव यांचे अध्यक्षतेखाली दिनांक २९ मार्च २०२५ रोजी आभासी बैठक घेण्यात आली. त्या बैठकीत आपल्या असोसिएशन तर्फे श्री एच एफ चौधरी जनरल सेक्रेटरी सहभागी झाले होते. त्यावेळेस माननीय सचिवांनी स्पष्ट केले की, ५ व्या वेतन आयोगाने ०१.०१.१९९६ पूर्वी आणि त्या नंतर निवृत्त झालेल्या पेन्शन धारकांमध्ये भेद केला होता. तसेच ६ व्या वेतन आयोगाने ०१.०१.२००६ पूर्वी आणि नंतर निवृत्त झालेल्या पेन्शन धारकांमधील तफावत कायम ठेवली आहे. तथापि, सर्वोच्च न्यायालयाच्या आदेशानुसार सध्याच्या पेन्शन नियमांमध्ये असा फरक करण्याचा सरकारला अधिकार नव्हता म्हणून सरकारने CCS पेन्शन नियमांमध्ये ही तरतूद केली आहे.

वरील सर्व वस्तुस्थिती लक्षात न घेता काही पेन्शनर संघटना, यापुढे वेतन आयोगाच्या शिफारशीनुसार वाढ पेन्शनराना सरकार लागू करणार नाही किंवा कदाचित यापुढे पेन्शन सुद्धा बंद केली जाईल असे सांगून पेन्शनरांच्या मनात गोंधळ व भीती निर्माण करीत आहेत.

आपल्या असोसिएशन ने त्वरित केंद्रीय कार्यकारिणी ची आभाशी बैठक बोलावून त्यावर साधक बाधक चर्चा केली. नवीन कायद्याचा बारकाईने अभ्यास केल्यास असे आढळून येईल की सरकारला पूर्वी पासूनच निवृत्तीच्या तारखेच्या आधारावर पेन्शनधारकांमध्ये फरक करण्याचे अधिकार होते. पाचव्या व सहाव्या वेतन आयोगाने सुद्धा शिफारस करतांनाच पुर्वीच्या पेन्शनर्सबाबत फरक कायम ठेवला आहे.

त्यानंतर सातव्या वेतन आयोगाने १.१ २०१६ पूर्वी आणि १.१.२०१६ नंतर निवृत्त झालेल्या निवृतीवेतन धारकांमध्ये अशतः समानतेची शिफारस केली. संसदेत विधेयक मंजूर झाल्यानंतर सरकारने स्पष्ट केले की पेन्शन नियमामध्ये कुठलाही बदल करण्यात आला नाही. आणि ८ व्या वेतन आयोगाचे शिफारशीनुसार १. १.२०२६ पूर्वी निवृत्त झालेल्या पेन्शनधारकांना सुद्धा पेन्शन रिव्हीजनचा फायदा देण्यात येईल.

यावर विश्वास ठेवून असा निर्णय घेण्यात आला की सध्यातरी आठव्या केन्द्रीय वेतन आयोगासमोर आपल्या मागण्या मांडल्या आहेतच. तसेच आठव्या केंद्रीय वेतन आयोगाचे गठण व आयोगाच्या कार्य क्षेत्राच्या अटी (Terms of Reference) मांडण्यात सरकारतर्फे होणाऱ्या विलंबाबाबत दिनांक जून २०२५ रोजी कॅबिनेट सचिवाना पत्र पाठविण्यात आले आहे.

आठव्या वेतन आयोगाचे गठन, कार्यक्षेत्राच्या अटी, आयोगाचे शिफारशीवर तसेच सरकारच्या निर्णयावर बारीक लक्ष ठेवू या. आपली असोसिएशन केन्द्र सरकारच्या तसेच बीएसएनएल एमटीएनएल पेन्शनरांच्या न्याय्य हक्का साठी कायम खंबीर पणे कार्यरत आहे. आपल्या सहकार्याबद्दल धन्यवाद!

- 9. ज्या पेन्शनर्सनी कोर्टात केस दाखल केली नाही, त्यांना निवृत झाल्याच्या पुढील तारखेपासून म्हणजेच १जुलै/१जानेवारी पासून नोशनल इन्क्रिमेन्ट देण्यात येईल. एक वेतनवाढ धरून वाढीव पेन्शनचा फायदा मात्र १.५.२०२३ पासून मिळणार आहे.
