Points Discussed in BWC & PC Branch Monthly Meeting on 15 June 2011:



- 1. CWC Meeting held on 08 June 2011 CHQ Pune: Points discussed were
 - a. Constitution amendment
 - b. Proceedings of Committee for constitution amendment
 - c. Department wise office bearers
 - d. Website: Website should either be used by all branches and members or it should be discontinued. CWC Members agreed to use website.
 - e. Information about Branches: All secretaries gave information about respective branch which included following information.
 - f. Year branch established.
 - g. Present strength of members
 - h. PP Bulletin subscribers
 - i. Difficulties faced by branches: Non issue of PPO, Contacting local officers of offices, banks and post offices, Contacting higher offices, recovery for overtime and salary paid for 2 members of Akola branch, Birth date proof, delayed payment of revised DR and arrears specially by post offices.
 - j. Organising AGM by branches: Information should be given at least 1 month in advance
 - k. Information about pension: Family Pensioners i.e. spouse, parents, brothers and sisters, children, divorced daughters and wife.
- 2. Souvenir "Health Care" Nearly 75 hospitals in Pimprichinchwad, Talegaon and Pune were contacted by letter, sms and telephone. Nearly 20 hospitals in Pimprichinchwad and Talegaon (Dabhade) were contacted personally by the President and Secretary during last 3 weeks. Except 2 hospitals all have agreed to contribute towards souvenir (both information and donation). Approximately 10 hospitals have issued cheques for donation and these have been collected and deposited. So far collection is only Rs. 30000.00 approximately. This would not even meet printing expenditure. All members should shoulder this task and collect as much information and donations as possible in next 15 days. Delay in collection would increase delegation fee for the AGM of our branch.

- 3. Mobile numbers of Pensioners: This branch has approximately 200 mobile numbers of pensioners against registered strength of 514 active members. It is understood that almost every pensioner is having personal mobile or can get one from BSNL under scheme "Pyari Jodi" or can ask their children to receive sms from the branch. All should make arrangement to get connected through mobile so that the branch can contact pensioners easily and quickly to give information.
- 4. Bulletin subscription and delivery: The website has enabled the branch to control bulletin subscription. Every pensioner receiving bulletin is reminded of the expiry of subscription on the address label. The last line specifies this. Bulletin subscribers should pay this subscription well in advance. Computer remembers the date and prints address labels of subscribers those whose subscription is valid. This means if subscription is invalid bulletin shall not be posted.
- 5. CGHS: Letter from Ministry of Health & Family Welfare Lr.No.S.11011/7/99-CGHS(P) dated 27.4.2011 regarding medical facilities for impatient treatment and post operative follow-up treatment to CGHS beneficiaries in Non-CGHS Areas received under Additional Director CGHS Pune vide letter no. CGHS/PNE/Estt.4-1/2010/3270 dated 03 June 2011. Shri Ramakant Pitale, informed that OM dated 16-3-2011 and OM dated 30-12-2009 are not on website of the ministry. Brief information contained in the circular was given during the meeting.
- 6. AGM: It is proposed to hold AGM on 20 July 2011. Agenda place etc. shall be finalised in BWC and notice would be issued to all members. Members whose mobile is registered shall be informed in addition through sms.
- 7. AIC: CHQ asked our branch to hold AIC on behalf of CHQ during December 2011. We have suggested that AIC if held during May 2012 there is a possibility of cheaper accommodation made available by some college/school.
