## **Issue of Revised PPO**

Dear Sir,

All India Central Government Pensioners Association was established by pensioners from then P&T Department during 1947. The association has over 75 branches all over India. Pimprichinchwad branch is one of the said branches. Members of the association not only from this branch but all branches are disappointed as the revised PPO is not yet issued. You will agree that PPO to pensioner is like Service Book to serving employee. PDAs disburse pension as per the details given in the PPO. In addition to this information, PPO is useful for working out revision of Pension as and when revision is authorised by the government.

Specific requirement is inclusion of information on Pay Scale, Grade Pay, birth date, retirement date, qualifying service, revised pension, date on which recovery towards commutation stops, Family pensioner(s) with birth date etc. Draft application is made available to pensioners at <a href="http://aicgpa.org">http://aicgpa.org</a>. Association need not bring out importance of this information.

Some of the members have taken initiative in requesting for issue of revised PPO to Accounts Officer (Pension) / TA, who have initially issued PPO. However, the said account office has informed that his office has received thousands of similar requests and his office doesn't hold enough staff for revising PPOs. Therefore, no time can be specified for issue of revised PPO.

Association hopes that your good self do not uphold the thinking of your accounts officer and would find a solution so that revised PPOs are issued within a time frame fixed by you. Association hopes that you would inform us about action taken and time frame by which members of association should expect respective revised PPOs.
