## CGHS DISPENSARY IN PIMPRICHINCHWAD CITY

Pimprichinchwad city is situated near Pune city. Dividing line is river 'Mula'. This gives an impression to outsiders that whatever services available in Pune are easily reachable by Pimprichinchwad citizens also. However, that is not true. Maps of Pune district, Pune city and Pimprichinchwad city are attached for your perusal. From these maps it is illustrated that Pimprichinchwad covers a vast area and is comparable with Pune. Dehuroad and Talegaon (Dabhade) are towns located on northern side of Pimprichinchwad. These towns can be considered as part of Pimprichinchwad for provision of facilities.

After flood disaster in Pune on 12 July 1962 land prices in Pune started touching the sky. Pimprichinchwad New Town Development Authority (PCNTDA) was established in 1972 with a purpose to develop residential area in horse shoe shape around industrial area of Pimprichinchwad. PCNTDA started development in Akurdi area first and plots were sold at affordable prices. Most of the employees took advantage of this and purchased plots. Thes employees are now pensioners. Thus a large number of pensioners are concentrated in this area. Akurdi railway station was established on account of this concentration during 1980s. Similar concentration is found near Dehu Road and Talegaon railway stations.

There are many central government offices like, Excise Commissioner, Income Tax Commissioner, College of Military Engineering (CME), Central Quality Assurance (CQA), Central Ordnance Depot (COD), National Sample Survey, Central Intelligence Bureau (CBI), Military Farm (MF) etc. are located in this area. Residential accommodation for central government employees has also been provided near Akurdi Railway Station.

Akurdi railway station is more or less at centre of Talegaon (Dabhade) on north side and last railway station in Pimprichinchwad city i. e. Dapodi on south side. During morning hours local and passanger trains run with a frequency of approximately 30 min. PMPML, local public bus service connects Akurdi railway station from all parts of Pimprichinchwad and areas beyond Talegaon (Dabhade) with frequency ranging between 15 and 30 minutes. Thus the place is highly convenient for citizens of Pimprichinchwad and adjoining towns i. e. Dehu Road and Talegaon (Dabhade). Alandi village has religious importance and is well connected.

CGHS dispensiory No. 1 was located at Deccan Gymkhana, Pune. The premises had to be vacated and was shifted to DAD Complex, Lullanagar, wanowrie Range, Pune 411040. However, it had been underutilised since its shifting. (refer CGHS Pune letter No. CGHS/PNE/Estt.4-42/07/3511 dated 16 July 2007 addressed to your office). Also, there is another dispensary No. 3 situated near Pune College within 3 km of existing location of dispensary No. 1, DAD Complex. Additional Director CGHS Pune has been convinced that there is a need to open at least 2 dispensaries in Pimprichinchwad area (refer his letter No. CGHS/PNE/ESTT 4-42/08/3392 dated 18 July 2008). On receipt of your approval for shifting dispensary No. 1, office of the Additional Director, CGHS Pune, requested Executive Engineer, CPWD, PCD-III, CRPF Campus, Talegaon, Pune, 410507 for accommodation (Letter No. CGHS/PNE/ESST.4-28/06/1994 dated 12 July 2006). Now it is understood that 2 Nos. type IV quarters have been allotted near Akurdi railway station for the said dispensary. The accommodation has been approved by your local office of AD, CGHS, Mukundnagar Pune, 411037. However, the dispensary has not yet started functioning from its new location near Akurdi railway station.

Your office is further requested to plan a CGHS hospital in the area. PCNTDA has reserved locations for hospitals and land would be available for dispensary at government approved price. You may direct Additional Director CGHS Pune for preparing a proposal for hospital. That shall give a good boost to morale of employees and pensioners.

Pimprichinchwad is an independent city, spread in vast area and populated by over 5000 employees / pensioners (and their families) who need CGHS facilities. There are small towns and villages like Dehu Road, Telegaon (Dabhade), Alandi, Ghorawadi and many more who could be provided health services by CGHS Dispensary located near Akurdi Railway Station in Government Accommodation. The case is under correspondance since year 2006 or earlier. Approvals needed have been received by Additional Director CGHS Pune. However, shifting is not yet completed. You are requested to kindly issue suitable orders so that the dispensary No. 1 starts functioning at the earliest from its new location (i. e. Govenment quaters near Akurdi railway station). A hospital also be planned in Pimprichinchwad area. Your action shall prove to be a morale booster for employees and pensioners in this area.
